The meeting was called to order at 6:00 P.M. and the following business was conducted:

- 2. Council Member Mr. David Richardson Led the Invocation
- 3. Pledge of Allegiance/Pledge to the Texas Flag

Non-Action Items

4. Citizens Comments

- Mr. Lloyd Smith-
 - Last meeting was a heated exchange about when the next meeting was going to be and in the end the Mayor apologized to Mr. Richardson. Stated the next regular meeting would be on the 25th.
 - Understands that the Mayor can call a special meeting but looked at the agenda and did not see anything time sensitive that could not wait until the next regular meeting.
 - o Meetings should be consistent for the citizens and council members to attend
 - Official Facebook page for the city could be a positive thing but found a couple of concerns.
 - Not approved by council
 - Citizens are not happy about the deletion of the comments.
 - Good things have been posted: frost warning and Kempner VFD.
 - More clarification on the posts on the Facebook page.
 - Disturbed that the petition was posted with personal information
 - Texas Law requires certain individuals are to be exempt from information being shared.
 - Information about the candidates running for council was not posted due to not wanting the information to be exposed.
- Mr. Wayland Allen
 - o Be careful on 3300 since due to the weather, the road can be slippery.
 - o Thanks to Mr. Maupin and his wife for what they will be doing in Kempner.

5. Reports

Any Additional City Hall Repairs and Costs

Mayor Harvey:

- Transformer blew, originally missed by adjuster from TML. Has been identified and will taken care of.
- Official Communication Page is for the official communication page of the Mayor to put out factual information to the city.

- The former page was taken down due to threats to the Mayor of some expressing to come to City Hall and harm the Mayor, racial disparaging remarks, cyber bullying and language being posted.
- Everything the Mayor does is ran through the attorneys.
- To be considered exempt from personal information being shared, it is the individual's responsibility to ensure they are exempt.
- Picture of Mr. Harris Kempner has been restored and has been hung.

All in favor Mr. Richardson, Mrs. Parker, Mr. Wilkerson, and Mrs. Vandeveer.

All opposed Mr. Ruszkiewicz.

Mr. Wilkerson made a motion to approve consent item c but with the correction on section 5 the spelling be changed from counsel to council.

Mrs. Parker second.

All in favor, motion carried.

7. Staff Comments

Mr. Wilkerson:

- His job takes him out of town. He had advised his work that on the 2nd and 4th of each month he cannot have meetings.
- Spoke with the developer of the property and the property does not close until April.
- Asked for consideration to be given, if he (Mayor) asked Mr. Allen to compose himself and not make facial expressions to also ask Judge Mahoney the same thing.

Mayor Harvey

• There are things that must be taken care of due to letters needing to be sent.

- Mr. Wilkerson has been in the city all week between the hours of 8:00 and 12:00 noon.
 Why is it impossible for Mr. Wilkerson to come to City Hall and retrieve his council packet?
- Does not believe that Mr. Wilkerson is too busy to pick up council packet or make meetings due to his ability to take pictures of Hickory Street, meet with residents and hang around the Brick Oven Restaurant.
- Will take into consideration the 2nd and 4th Tuesday of each month for the meetings but will call for a special meeting as needed.
- Addressed Mr. Lowe about the calls he has made to the City Hall regarding the election.
 We wanted to get it right the first time. Was in constant communication with Mr. Bishop to ensure the city did just that.

Mr. Richardson

- Regarding the council meetings, to be held at 7 PM to allow citizens time to eat dinner and attend.
- Mr. Richardson made a request for the meetings to be held at 7 PM. Mrs. Vandeveer agreed.

Mrs. Parker

• Would like the minutes to be proofread.

Mayor Harvey

- Attorney advised council members are not allowed to advocate for or against the election on adopting a city manager.
- Council members are only allowed to put out facts and let the citizens decide.

Mr. Wilkerson

- Asked for written documentation from the attorney that council members cannot advocate for or against. He spoke to TML, advised him they cannot expand or utilize the city resources, but a council member can obtain the right to either speak out for or against.
- Mayor Harvey addressed Mr. Wilkerson, if he does not believe him to call the city attorney.
- Mr. Richardson asked if the information could be provided in an email from the city attorney to avoid fee's from calling.

Mayor Harvey

- Emails have been communicated to council members in the past yet council members called the City Attorney's to verify.
- Stated it is the right of every councilmember, and they allowed to contact the City Attorney's.

Mr. Ruszkiewicz

- He did not see a time frame on the Burn Ordinance.
- Judge Mahoney stated it is listed on the Ordinance and it indicates 1 hour after sunrise and one hour prior to sunset.
- Mrs. Parker stated she did not see anything about a burn barrel.

The meeting was called to order at 7:00 P.M. and the following business was conducted:

- 1. Roll Call
- 2. Council Member Mr. Ruszkiewicz Led the Invocation
- 3. Pledge of Allegiance/Pledge to the Texas Flag

Non-Action Items

4. Citizens Comments

- · Mr. Lloyd Smith-
 - O Last week's discussion on whether council members could openly endorse one way or another in the coming City Manager election. The mayor had his guidance from his attorney and Mr. Wilkerson from TML and wanted to know if there was any cohesion from both opinions.
 - Last meeting notes there was a discussion about proofreading. Mr. Smith recommended Grammarly to be used.
 - Mr. Smith made a research about getting better internet due to not having good options. Spoke with Rollcall Communications from Lampasas and they have run fiber lines run through Kempner and can put fiber internet out to the citizens.
 - Tearing up of CR 3300 to repave and tracked through different media postings, citizens have reached out to county and apparently, there was an arrangement between the Mayor and the county to get it done. CR 3300 was not one of the roads originally considered or approved by the council.
- Mrs. Anelicia Cheney-Campbell-
 - Addressed the council regarding the Mayor refusing the right for the council members or the citizens the right to speak during the Staff Comment section. According to House Bill Section 2840 the governing body must allow the public the right to speak on agenda items either at the beginning of the meeting or during the meeting.

- O Citizens have the right to speak at any time during the meeting. If the Mayor refuses the citizens to speak from items that are listed on the agenda, then that item should be removed from the agenda.
- o If a public official does not want to hear the citizens' comments, then that person should not be a public official.

Mr. Wayland Allen-

- He does not understand how three of the council members were not aware of the situation going on with CR 3300.
- The last meeting brought up that CR 3300 was slippery and was not addressed.
- Reached out to the county commissioner.
- o On the Official Facebook, he would like to see the detour route that citizens must take to avoid CR 3300 when it is being worked on.
- He stated he has still not seen the total cost of repairs from the previous streets.
 Two residents that live on Hickory stated that there is grass in the middle of the streets.

Mr. Frank Potter-

- O Thanked the council members and the Mayor for the donation that was given to the fire department for the lockers.
- Once the lockers are put up, they will invite the council members and the mayor to look at the lockers.

5. Reports

- Any Additional City Hall Repairs and Costs- Mayor
 - Currently waiting on the gutters to come in. Once they come in, they will be installed. All the transformers were blown and will be replaced. The bulbs are being installed and each bulb costs \$52.
 - On CR 3300, Mr. Allen in previous council meetings stressed issues concerning the road that needed to be repaired. The mayor informed the city there is an interlocal agreement with the county. The commissioner and the mayor talked and agreed it is a troubled road. People are driving in a 30mph zone at 60-70mph. This matter concerning CR 3300 was discussed with the previous mayors and cost of repair was the sole reason of nothing being done.
 - The petition about Rollcall Communication, if people want a fiber line, they can
 get it. Start the petition, get the required signatures for the company and let the
 process begin.
 - Judge Mahoney- If Century Link tells you they are the only ones that can go through Kempner, it is partially true. There is no current Franchise agreement

- with anyone besides Time Warner. Century Link Franchise agreement expired in 2009.
- Mayor spoke with Lone Star and they are fixing the issue on Hickory. Lone Star stated it is not uncommon when you do overlay for grass to go up. All council members received estimates about what the streets cost, and it is not accurate. One of the streets that were repaired ended up costing less.
- Mayor spoke with Jeff Ulmann and stated he was contacted by Mr. Wilkerson requesting information in writing regarding being able to advocate for or against the petition for the City Manager (Political Advertising and Use of City Resources). The city attorney will send a letter in writing to the City Secretary and will be emailed to the council members and the Mayor.
- Mayor asked Mrs. Cheney-Campbell to control her deportment/comments or will be asked to leave the council chambers.
- o Mrs. Cheney-Campbell asked the Mayor, rather than hearing his opinion can he read the letter from the city attorney. Mayor responded when the city receives the email from the city attorney, the letter will be emailed to the council members.
- Mayor stated based on what he was told from two attorney's, they cannot advocate for or against the petition for the City Manager.
- Mrs. Cheney-Campbell stated the last meeting the Mayor advised Alderman Wilkerson that he contact the city attorney and she would like to know if Alderman Wilkerson received a response from Jeff Ulmann.
- Mr. Wilkerson stated he sent an email to the city attorney asking if a council member or Alderman can advocate for or against the City Manager petition without using the city resources. Stated he did receive an email from the city attorney, stating yes Alderman can go out in public and advocate for or against as long as no city resources are used and there are a lot of considerations to give on what city resources are.

6. Consent Items.

- a. Consider approval of the minutes from the Council meeting held on February 18, 2020.

- o Mayor stated all items are to be considered as one unless one is pulled out by a council member with the motion being made.
- o Mr. Wilkerson made a motion for 6c to be pulled out.

- o Mr. Richardson asked if they are voting for what Mr. Wilkerson just asked.
- Mayor stated they are not voting due to Mr. Wilkerson making a motion.
- o Mr. Richardson made a motion for 6b to be pulled out.
- Mayor stated the motion from Mr. Wilkerson dies due to no second. Asked if there is a second for 6b.
- Mrs. Parker made a motion for approval of 6a and for 6b and 6c to hold out. Mr.
 Wilkerson second. All in favor: Mr. Richardson, Mrs. Parker, Mrs. Vandeveer. All opposed: Mr. Ruszkiewicz. Motion carries.
- o 6a all in favor, motion carries.
- o Mayor asked if 6b and 6c will be postponed to the next council meeting since Mrs. Parker made a motion to hold out.
- Mrs. Parker wants to make a motion to hold 6b and 6c for discussion tonight. Mr.
 Wilkerson second. All in favor: Mr. Richardson, Mrs. Parker, Mrs. Vandeveer. All opposed: Mr. Ruszkiewicz. Motion carries.
- 6b is open for discussion.
- o Mr. Richardson asked for clarification from 6b on Hampton Inn and Discount Tire charges. Mayor stated Hampton Inn (CT) was for Chief training/lodging in Huntsville, Texas. The Discount Tire charge was for eight tires that needed to be replaced from both service vehicles. Mr. Richardson would like more clarification when it comes to abbreviations. Mayor stated he will spell out the words and avoid abbreviations or if they have any questions, they can call the City Hall and get answers pertaining to any question they might have concerning agenda verbiage for clarification. Mr. Ruszkiewicz made a motion to approve 6b, Mrs. Vandeveer second. All in favor Mr. Richardson, Mrs. Parker, Mr. Ruszkiewicz, Mrs. Vandeveer. All opposed, Mr. Wilkerson. Motion carries.
- o 6c is open for discussion.
- o Mr. Wilkerson stated he is all for spending money to repair the roads. His only concern right now is that he knows what we had on the streets and repairs account when the budget was talked about and he knows there was not enough to complete all the roads. Mr. Wilkerson knows the money needed to be pulled out from somewhere and would like to know from where that money was pulled from. Mayor stated that part of the money for the roads was never moved for the roads from the Savings Account to the Street Account. If people want to know what the salaries for the City Hall employees are, they can go online. The only salary that is not online is the Municipal Court Judge. The city accountant had stated the budget needed to be amended because the Judge was voted in during the month of October, after the budget approval. Mayor stated we are in the middle of an ongoing audit and Mr. Wilkerson has called the auditor.
- Mayor stated he was informed the council members were not getting the council packets.
 The council packets are first emailed, and hard copies are made for pick up from city hall.

- o Mayor stated a petition was turned in to the city. The petition was sent to attorneys and was advised by the Secretary of State Election Department the only information that needed to be redacted was the date of birth.
- Mayor stated people come to his office and tell him that they are getting attacked by members of the COK, they do not like the Mayor, and everything is the Mayors' fault.
- Mrs. Cheney-Campbell insisted on talking without being recognized, the Mayor asked Mrs. Cheney-Campbell to exit the council chambers. Mrs. Cheney-Campbell replied "NO" and requested for the council to vote for her removal. Mr. Allen was also asked to be removed from the council chambers for standing to his feet shouting an outburst towards the Mayor after Mrs. Cheney-Campbell was asked to leave the council chambers. Mrs. Vickie Whitis stood to her feet and stated to the Mayor "you have been a disgrace since you moved to our town" and she was asked to be removed as well. The Mayor stood and stated to Mr. Allen "you like to attack volunteers and people on social media, attack me" and to Mrs. Whitis, "why don't you say what you really want to say, you say it behind closed doors, it's the color of my skin".
- o The Mayor called a recess of 10 minutes.
- Mrs. Vandeveer walked out of the city council meeting.
- o The Mayor stated CR 3300 was not on the initial estimate and different streets have been brought up for repair.
- Mr. Ruszkiewicz made a comment stating if the county had not helped with the repair of CR 3300, the repair would have cost more to the city. Mr. Ruszkiewicz made a motion to approve 6c.
- O Mrs. Parker asked if any of the residents of CR 3300 have complained that they do not want the road fixed. Mayor stated the county commissioner spoke with the residents who live on CR 3300 and no one expressed or opposed road repaired. Mrs. Parker second the motion to approve 6c. Mr. Richardson asked if Mrs. Vandeveer will come back to the forum. The Mayor stated no. Mrs. Mahoney was asked to leave the forum for making an outburst.
- All in favor to approve 6c Mr. Richardson, Mrs. Parker, Mr. Ruszkiewicz. Abstained Mr. Wilkerson.
- o Mr. Wilkerson wanted to explain the reason he abstained for 6c. Stated Mr. Ruszkiewicz is correct that it is a good thing the county commissioner is helping. He also stated he is all for CR 3300 to be repaired but first wants to know what the balance of the account for the road repair is before voting. The Mayor stated to Mr. Wilkerson "you received the financials from the City Accountant in a meeting you requested, why don't you know what the City have available."
