



The meeting was called to order at 7:00 P.M. and the following business was conducted:

- 1. Roll Call
- 2. Council Member Mr. Ruszkiewicz Led the Invocation
- 3. Pledge of Allegiance/Pledge to the Texas Flag

Non-Action Items

- 4. Citizens Comments None
- 5. Reports
 - Any Additional City Hall Repairs and Costs- Mayor
 - All roof repairs are completed at this time. At this present time, there are no major repairs that are needed to be done as of right now.

ACTION ITEMS

6. Consent Items.

All items listed under the Consent Agenda are routine and will be enacted by one motion. There will be no separate discussion of these items unless requested by a Council member in which event, the item will be removed from the consent agenda and considered separately.

- a. Consider approval of the minutes from the Council meeting held on March 10, 2020.
- b. Consider approval of the Accounts Payable for payment dated March 5, 2020.
- c. Consider approval to postpone the general and special election to the November 3, 2020 uniform election date per the authorization of Governor Greg Abbott.
 - Mr. Wilkerson made a motion to approve 6a and 6b and pull out 6c for discussion. Mr. Richardson second.
 - Mr. Ruszkiewicz made a secondary motion to comment on section 6b. Mr. Wilkerson stated he is
 willing to amend his motion and second Mr. Ruszkiewicz motion. Mayor stated the first motion
 has been amended.

- Mr. Ruszkiewicz stated he appreciates Jack Clark the way he laid out all the financials last meeting.
- Mr. Wilkerson made a motion to approve 6a and 6b and pull out 6c for discussion. Mr. Richardson second. All in favor of approval of 6a and 6b, motion carries.
- Mr. Wilkerson addressed the council and stated he spoke with Mark Bishop in regarding TML putting out the guidelines saying that the Governor authorized for the elections to be postponed. He stated he spoke with Mr. Bishop asked for the election to be postponed due to not wanting his staff to be subjected to unnecessary exposures. Mr. Wilkerson stated he agrees for the May 2, 2020 election to be postponed at least until November and if TML stated the election can be sooner then that will be addressed.
- The Mayor stated Mr. Bishop has been in contact with the City Hall and has expressed his
 concern about postponing the election until November. Mr. Bishop contacted the City Hall today
 and advised the City of Lampasas postponed the election for November 3, 2020.
- Mr. Wilkerson stated based on the literature today by TML stated there is a great possibility for the City of Lampasas County to have issued a shelter in place and could cost for someone to contest the election and that should be taken into consideration.
- Mr. Ruszkiewicz stated it all adds-up on why we should postpone the election.
- The Mayor stated if we do not postpone the election it will be the city's expense.
- Mr. Ruszkiewicz made a motion if no one has a comment to approve 6c, Mr. Richardson second.
 All in favor, motion carries.
- a. Convene into executive session according to Section 551.074, Texas Government Code, to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of TCOLE Certified Reserve Peace Officer.
- b. Reconvene into open session to act as determined appropriate in the City Council's discretion regarding the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of TCOLE Certified Reserve Peace Officer.
 - Mr. Wilkerson made a motion to approve the two candidates that were presented to them to become Reserve Unpaid Peace Officers for the City of Kempner, Mrs. Parker second. All in favor, motion carries.

8. Staff Comments

• Mr. Wilkerson stated the last council meeting or the meeting before where the council was asked to help dispel inaccuracy throughout the community and stand up for what the truth is. He stated he would like to go over information without sounding abrasive and make solutions for the information he has been filled in with. The Mayor stated all the information he has been presented with to please provide the information to the City Secretary. Mr. Wilkerson stated he has sent emails to the City Secretary and has not received responses. The Mayor asked Mr. Wilkerson if he has not received any emails from the City Secretary and Mr. Wilkerson responded stating he has received some but had not received any emails asking for workshops and information to be placed on the agenda. The Mayor stated that email sent by Mr. Wilkerson had information regarding the executive session and he cannot discuss any of that information.

Mr. Wilkerson stated he was not wanting to discuss information from the executive session. The Mayor stated if he does not have a court order to discuss information from the executive session, no information will be discussed.

Lampasas County Public Health Emergency Declaration Stay Home Stay Safe

WHEREAS, on March 16, 2020, President Trump acknowledged the gravity of the COVID-19 pandemic, releasing strict new guidelines to limit people's interactions, including that Americans should avoid groups of more than 10 people;

WHEREAS, on March 20, 2020, Governor Abbott issued the following executive order relating to the COVID-19 pandemic:

Order No 1: In accordance with the Guidelines from the President and the CDC, every person in Texas shall avoid social gatherings in groups of more than 10 people.

Order No 2: In accordance with the Guidelines from the President and the CDC, people shall avoid eating or drinking at bars, restaurant, and food courts, or visiting gyms or massage parlors; provided, however, that the use drive-thru, pickup, or delivery options is allowed and highly encouraged throughout the limited duration of this executive order.

Order No 3: In accordance with the Guidelines from the President and the CDC, people shall not visit nursing homes or retirement or long-term care facilities unless to provide critical assistance.

Order No 4: In accordance with the Guidelines from the President and the CDC, schools shall temporarily close.

WHEREAS, pursuant to Texas Government Code Section 418.108, Lampasas County Judge Randall J Hoyer issued a Declaration of Local Disaster for Public Health Emergency on March 23, 2020, due to a novel coronavirus now designated SARS-CoV2 which causes the disease COVID-19; and,

WHEREAS, on March 23, 2020, the Lampasas County Commissioners Court approved Judge Hoyer's Disaster Declaration for Lampasas County issued an Order of Continuance of Declaration of Local Disaster for Public Health Emergency that affirmed the activation of the Lampasas County Emergency Management Plan and extends until such time as the County Judge and/or the Commissioners Court determines such is no longer required.

WHEREAS, on March 26, 2020, Lampasas County Judge Randall J Hoyer issued an order for Lampasas County residents to:

- Requires social distancing of at least six feet from any person when they are outside their residence
- Restricts gatherings in groups of more than 10
- Prohibits dining in at restaurants and food establishments
- Prohibits service-oriented business from performing services that require physical contact
- Strongly encourages County residents to remain at home and limit travel to essential needs only.

WHEREAS, current information from the CDC, the President, Governor, CDC and local emergency planning committee indicates an increased seriousness for Lampasas County;

THEREFORE, BE IT PROCLAIMED and ORDERED by County Judge Randall J Hoyer that Lampasas County residents are directed to Shelter in Place.

SUMMARY OF ORDER

Summary: The virus that causes Coronavirus Disease (COVID-19) is easily transmitted through person to person contact, especially in group settings, and it is essential that the spread of the virus be slowed to protect the ability of public and private health care providers to handle the influx of new patients and safeguard public health and safety. Because of the risk of the rapid spread of the virus, and the need to protect the most vulnerable members of the community, this Order requires all individuals anywhere in Lampasas County to shelter in place — that is, stay at home — except for certain essentials activities and work to provide essential business and government services or perform essential public infrastructure construction, including housing. This Order takes effect at 11:59 p.m. on April 1, 2020 and will continue through 11:59 p.m. on April 7, 2020, subject to the limited exceptions and under the terms and conditions more particularly set forth below. This Directive may be extended if circumstances warrant such.

UNDER THE AUTHORITY OF TEXAS GOVERNMENT CODE SECTION 418.108, LAMPASAS COUNTY JUDGE RANDALL J HOYER ORDERS:

- 1. Effective as of 11:59 p.m. on April 1, 2020, and continuing until 11:59 p.m. on April 7, 2020:
 - (a) All individuals currently living within Lampasas County are hereby ordered to shelter at their place of residence. For the purposes of this Order, residences include hotels, motels, shared rentals, and similar facilities. To the extend individuals are using shared or outdoor spaces, they must at all times as reasonably as possible maintain social distancing of at least six feet from any other person when they are outside their residence. All person may leave their residences only for Essential Activities, or to provide or perform Essential Governmental Functions, or to operate Essential Businesses, all as further defined in this Directive.
 - (b) All businesses operating within Lampasas County, except Essential Businesses as defined in below in Section 2, are required to cease all activities at facilities located within the County except for minimum basic operation. For clarity, businesses may continue operations consisting exclusively of employees or contractors performing activities at their own residences (i.e. working from home). To the greatest extent possible, all Essential Businesses shall comply with the Social Distancing Guidelines, including maintaining six-foot social distancing for both employees and the general public, including, but not limited to, when customers are standing in line.
 - (c) All public or private gatherings of 10 or more people occurring outside a single household or living unit are prohibited, except as otherwise provided herein. Nothing in this Order prohibits the gathering of members of a household or living unit.
 - (d) Restaurants with or without drive-in or drive-through services and microbreweries, micro-distilleries, or wineries may only provide take out, delivery, or drive-through services as allowed by law.
 - (e) Religious and worship services may only be provided by video and teleconference. Religious institutions must limit in-person staff to ten (10) people or less when preparing for or conducting video or teleconference services, and all individuals must follow the Social Distancing Guidelines including the six-foot social distancing.
 - (f) All elective medical, surgical, and dental procedures are prohibited anywhere in Lampasas County. Hospitals, ambulatory surgery centers, dental offices and other medical facilities are directed to identify procedures that are deemed "elective" by assessing which procedures can be postponed or cancelled based on patient risk considering the emergency need for redirection of resources to COVID-19 response.

2. Definitions:

- (a) For purposes of this Order, individuals may leave their residence only to perform any of the following "Essential Activities":
 - To engage in activities or perform tasks essential to their health and safety, or to the health and safety of their family or household members (for example, obtaining medical supplies or medication, visiting a health care professional, or obtaining supplies need to work from home).
 - Ii. To obtain necessary services or supplies for themselves and their family or household members, or to deliver those services or supplies to others (for example, food, pet supply, and any other household

consumer products, and products necessary to maintain the safety, sanitation, and essential operation of residences.)

- iii. To engage in outdoor activity, provided the individuals comply with social distancing requirements of six feet (for example, walking, biking, hiking or running).
- iv. To perform work providing essential products and services at an Essential Business or to otherwise carry out activities specifically permitted in this Order.
- v. To care for a family member or pet in another household.
- (b) For purposes of this Order, "Essential Businesses" means:
 - Essential Healthcare Operations. Healthcare operations, including hospitals, clinics, dentist, pharmacies, pharmaceutical and biotechnology companies, other healthcare facilities, healthcare suppliers, mental health providers, substance abuse service providers, blood banks, medical research, laboratory services, or any related and/or ancillary healthcare services. Home-based and residential-based care for seniors, adults, or children are also considered healthcare operations. Healthcare operations also includes veterinary care and all health and welfare services provided to animals. This exemption shall be viewed broadly to avoid any impacts to the delivery of healthcare. Healthcare operations do not include fitness and exercise gyms and similar facilities. Healthcare operations do not include elective medical, surgical, and dental procedures as established in accordance with Subsection 1(f) of this Order.
 - ii. Essential Government Functions. All services provided by political subdivisions of the State needed to ensure the continuing operation of those agencies to provide for the health, safety, education, and welfare of the public. Further, nothing in this order shall prohibit any individual from performing or accessing "Essential Government Functions." All Essential Government Functions shall be performed in compliance with social distancing requirements of six feet, to the extent possible.
 - iii. Essential Critical Infrastructure & Activities. Work that is necessary to the operations and maintenance of the critical infrastructure sectors as identified by the National Cybersecurity and Infrastructure Agency (CISA), including public works construction, residential and commercial construction, airport operations, water, sewer, gas, electrical, oil refining, roads and highways, public transportation, solid waste collection and removal, internet, and telecommunications systems (including the provision of essential global, national, and local infrastructure for computing services, business infrastructure, communications, and web-based services), financial institutions, defense and national security-related operations, essential manufacturing operations provided that they carry out those services or that work in compliance with social distancing requirements of six feet, to the extent possible. Essential Businesses providing essential infrastructure should implement screening precautions to protect employees and all activity shall be performed in compliance with social distancing guidelines attached.
- iv. Essential Retail. Food service providers, including grocery stores, warehouse stores, big-box stores, bodegas, liquor stores, gas stations and convenience stores, farmers' markets that sell food products and household staples. Food cultivation, including farming, fishing, and livestock. Businesses that ship or deliver groceries, food, goods or services directly to residences. Restaurants and other facilities that prepare and serve food, but only for delivery or carry out. Schools and other entities that typically provide free services to students or members of the public on a pick-up and take-away basis only. The restriction of delivery or carry out does not apply to cafes and restaurants located within hospital and medical facilities. Laundromats, dry cleaners, and laundry service providers. Gas stations, automobile sales, auto-supply, auto and bicycle repair, hardware stores, construction supply stores, and related facilities. Businesses that supply products needed for people to work from home.

 V. Providers of Basic Necessities to Economically Directional Populations.
- v. Providers of Basic Necessities to Economically Disadvantaged Populations. Businesses that provide food, shelter, and social services, and other necessities of life for economically disadvantaged or otherwise needy individuals.
- vi. Essential Services Necessary to Maintain Essential Operations of Residences or Other Essential Businesses. Trash and recycling collections, processing and disposal, mail and shipping services,

building cleaning and maintenance, warehouse/distribution and fulfillment, storage for essential businesses, funeral homes, crematoriums and cemeteries. Plumbers, electricians, exterminators, and other services providers who provide services that are necessary to maintaining the safety, sanitation, and essential operations of residences and Essential Businesses. Professional services, such as legal or accounting services, when necessary to assist in compliance with legally mandated activities. Businesses that supply other essential businesses with the support of supplies needed to operate.

- vii. News Media. Newspapers, television, radio, and other media services.
- vili. Childcare Services. Childcare facilities may continue to operate; however, to the extent possible, it is recommended that groups consist of no more than 10 and be kept separate.
- 3. Any manufacturer who retools so that a substantial part of their business is for the purpose of manufacturing and producing ventilators may apply for an "essential business" exemption under this Order.
- 4. Grocery stores, supermarkets, warehouse stores, hospitals, and medical facilities are experiencing high levels of demand for a large number of products, requiring more deliveries from manufacturers and distribution centers to serve their customers. A number of Texas cities and local associations have implemented restrictions on delivery hours to stores to mitigate truck noise and traffic. Due to the need to deliver products as quickly and efficiently as possible during this critical timeframe, this Order hereby suspends all delivery hour restrictions for transport to or from any entity involved in the selling or distribution of food products, medicine, or medical supplies in Lampasas County for the next 60 days.
- 5. If someone in a household has tested positive for coronavirus, the household is ordered to isolate at home and follow the directives from their health care provider. Members of the household cannot go to work, school, or any other community function, provided that workers included in Essential Healthcare Operations may continue to work in accordance with CDC guidance. All persons are encouraged to take advantage of telehealth services offered by healthcare providers, including expanded telehealth services now available to Medicare patients.
- 6. Nursing homes, retirement, and long-term care facilities are instructed by this order to prohibit non-essential visitors from accessing their facilities unless to provide critical assistance or for end-of-life visitation. These facilities are also required to institute temperature checking of all staff entering the facility at least twice per day and limit physical contact between residents in the facility wherever possible.
- 7. For individuals who are 65 and older and individuals with compromised immune systems or underlying health conditions, the following recommendations are made:
 - a. Remain Indoors
 - b. Outdoor exercise activities should be solitary
 - c. Prescreen all essential visitors
 - d. Do not visit homes or places with more than one person
 - e. Ask all visitors to wear masks
 - f. Follow social distancing guidelines
 - g. Do not use public transit except in an emergency
- 8. Daycare facilities may continue to operate but it is recommended that groups in the facility consist of 10 or fewer in those settings and kept separate to the extent possible.
- 9. This Order shall be effective until 11:59 p.m. on April 7, 2020, or until it is either rescinded, superseded, or amended pursuant to applicable law.
- 10. The Lampasas County shall provide copies of this Order by posting on the Lampasas County website and by filing with the Lampasas County Clerk. In addition, the owner, manager, or operator of any facility that is likely to be impacted by this Order is strongly encouraged to post a copy of this Order onsite and to provide a copy to any member of the public asking for a copy. If any subsection, sentence, clause, phrase, or word of this Order or any application of it to any person, structure, gathering, or circumstance is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, then such decision will not affect the validity of the remaining portions or applications of this Order.

Hello again. This is Georgia Hay, MD, your Lampasas County Local Health Authority. I am writing to you to update that we do officially have our first case in Lampasas County. This is not a shock or a surprise, but it does provide even more evidence we need to continue to push to stay at home and physically distance from others to reduce the spread. We are also asking those with COVID-19 in their homes to quarantine the entire household per the health department. I am trying to reach out to those affected to make sure they have what they need and to see about other potential exposures in our community. I want to assure those affected by the virus that none of their personal information will be released. I know emotions and anxiety are running high right now, but I can honestly say it could easily be spread without knowing you are sick and no one should be angry with those affected. I understand the importance of these gatherings, and I understand how important our spiritual health is to our emotional, mental, and physical health. I implore those who attend keep with our physical distancing to stay safe. I also want to remind those that if they are not feeling well I wouldn't recommend going even if you are staying in the car. - 4. Citizens Comments -
 - Lloyd Smith (Non-Agenda Item)
 - O Mr. Smith asked who the park supervisor and events coordinator for the park are. He stated these individuals are not widely known and getting ahold of them is not something that is quickly done. Resources are being wasted on an investigation of theft based on what many are perceiving as a personal issue. The flag was given to a council member who relayed it to the Mayor Pro-Tem. The veteran who replaced the flag from the park is not identified to the public but would like to thank him for his action.
 - O The City of Kempner signs are placed in a way that they are virtually impossible to read until you are right upon them. He stated he recognized the council approved the replacement of the previous Boy Scout built sign. Citizens have asked the question of why the Boy Scouts were not allowed to restore the sign. The local scouts stated they offered to do so and were denied. The result of the signs is that they look good but placed in a way on the side of the highway that almost no one can read them and is something that has to be corrected and will cost more money. He also stated that the current signs are in a current situation as bad if not worse than the previous signs.
 - o Mr. Smith stated it is understood that there are restrictions on gatherings, and will continue to be so. Mr. Smith recommended to the city to put an order stating what was posted yesterday about how to attend the meeting, who is allowed in person, etc. or putting that information in the agenda. He stated it ensures everyone is

informed and well in advance and minimizes any perception of not adhering to the Open Meetings.
