		Discussion: Mayor advised council that a couple of organizations want to get a permit for firearms displays at the 2022 Kempnerfest, however the park ordinance prohibits this absent council approval. Mayor also indicated the current language may not be in line law changes made by the Texas Legislature regarding firearms and a city's ability to regulate them. Additionally, there are some minor grammatical changes that need to be made. Mayor recommends council consider adopting the resolution, and the City review the ordinance for legal compliance. Place 3 expressed his agreeance with this plan, however wanted the title changed from "specified event" to "Kempnerfest 2022".
