PLEASE ACCEPT THIS LETTER OF FORMAL NOTICE OF MY RESIGNATION AS A POLICE OFFICER AT KEMPNER POLICE DEPARTMENT, EFFECTIVE IMMEDIATELY.

I APPRECIATE THE OPPORTUNITY TO HAVE SERVED THIS COMMUNITY. IT WAS NOT EASY TO MAKE THE DECISION OF LEAVING THIS AGENCY. AS YOU ALL KNOW I BEEN WITH THIS AGENCY AND LOMETA POLICE DEPARTMENT FOR ONE YEAR ALREADY. THE MAIN REASON FOR WORKING FOR BOTH AGENCIES HAS BEEN TO GAIN AS MUCH EXPERIENCE AS I CAN IN ORDER TO PERFORM MY JOB EFFECTIVELY. HOWEVER, I DON'T WANT TO BE PART OF A POLICE DEPARTMENT THAT DOES NOT HAVE A CHIEF OF POLICE OR HAS AN ADMINISTRATOR THAT IS LITTLE TO NOT ANY KNOWLEDGEABLE IN THE POLICE DEPARTMENT AREA. I AM NOT READY TO STEP UP TO A CHIEF OF POLICE POSITION WITH ONLY ONE YEAR AND FIVE MONTHS ON THE POSITION OF PATROL POLICE OFFICER. I AM NOT WILLING TO BE ASSOCIATED WITH A MAYOR THAT KEEPS LYING TO COVER HIS ILLEGAL ACTIONS AND TRIES TO BLAME IT ON HIS CITY SECRETARY WHO IS A MOTHER OF TWO BEAUTIFUL GIRLS. I WILL NOT STAND BY AN ELECTED OFFICIAL THAT HAS DONE WRONG. I CAN HONESTLY SAY THE MAYOR WAS DOING GREAT THINGS TRYING TO DO GOOD FOR THE CITY, BUT HE HAS CROSSED THE LINE AND HE IS DIGGING HIMSELF IN A DEEPER HOLE TRYING TO FIX WHAT IS UNFIXABLE. Please accept this letter of formal notice of resignation as the City Secretary at Kempner City Hall effective immediately.

I appreciate the opportunity that was given to me to serve this community. As we all know I started as the Court Clerk in September and then was moved up to City Secretary in late October. I thank the Mayor and the city council for trusting and believing in me.

As much as it saddens me to be leaving the city of Kempner, I believe it is in my best interest to protect myself. I do not want to be involved in the current situation going on with the City of Kempner. I do not feel comfortable working in a place that I am being accused of something I clearly did not do, and the video will show this. The Municipal Court Judge Keith Mahoney told me that I will not be in any trouble since Mayor Harvey gave me instructions to open the door and retrieve the flags from inside of the Chief's office. All I did was open the door as Mayor Harvey instructed me to do. As I clarified to Judge Kenneth Mahoney that I only opened the door and did not touch or retrieve any flags, Judge Mahoney then asked me "then who was it?" I laughed because I knew exactly what they were trying to get me to say and agree to and because I knew that they both knew the answer to that question. The judge then asked me not to answer. Municipal Court Clerk Tracie Martin asked Judge Mahoney where the DVR was at. Judge Mahoney responded that the DVR was inside the Mayor's office and turned towards Tracie Martin and said and I quote, "tampering."

Mayor Harvey keeps asking me questions about this "flag" incident all the time. He keeps trying to question me to see if I say something that will incriminate me or the former officers when I haven't done anything wrong. I cannot take this stress anymore.

I only wanted to explain this situation to the council and the reasons why I cannot continue to work for the City of Kempner.

4. Citizens Comments:

Angie Carswell: I am deeply embarrassed, once again, by your choice to treat the veteran who replaced the tattered American flag as a criminal rather than a valued, contributing member of our community. Your lack of cooperation and repeatedly refusing to work alongside members of the Kempner community continue to cause division rather than unity. Your new city sign is an embarrassment to our community. It cannot even be easily read by those passing through town. You wasted \$5,000 of city money rather than working with the Boy Scouts to refurbish the proud existing sign.

As for the flag, you should have apologized for the torn flag left to fly at the park. Then thanked those who took initiative to replace it. That would have been the right thing to do. That would have created good public relations. It would have shown a genuine desire to serve Kempner citizens. Instead you have chosen to escalate this event into some sort of personal vendetta against Alderman Wilkerson. Again, creating even more division and embarrassment for the City of Kempner. Please, save the city further embarrassment and money, resign immediately.

Vance Rodgers: Citizens and Council Members,

Sec. 22.005., Local Government Code states: "A person who is elected or appointed to a municipal office under this code must take and sign the official oath of office before beginning to perform the duties of the office. Furthermore, The Texas Constitution requires that all appointed and elected officers in the state must take an oath of office. TEX. CONST. Art. XVI, §1. This includes elected officials, such as city council members and mayors. This oath contains the requirement that the officer ".... will to the best of my ability preserve, protect, and defend the Constitution and laws of the United States and of this

State, so help me God." I do not think some of you realize the responsibilities that come with this oath.

Texas Penal Code (Sec. 39.02.) states a criminal violation has occurred involving ABUSE OF OFFICIAL CAPACITY when "A public servant commits an offense if, with intent to obtain a benefit or with intent to harm or defraud another, he intentionally or knowingly:(1)violates a law relating to the public servant's office or employment.

The key phrase I want you all to pay attention to is to "harm of defraud another." I want you all to realize that it is in fact a criminal offense and I will do whatever is possible to hold these types of officials accountable. This includes interference from a group of officials working together to formulate a plan on how to "harm or defraud another."

- Paul Miceli: I am sending this email do to not being able to attend meetings in person and would appreciate my comments being read during the citizen comments section of the meeting. As you can see it has been sent to the Secretary, the Mayor and the News.
- Although I am not a voter within the city limits of Kempner, I still feel the need to voice opinion. I am tired of watching this saga unfold and instead of getting realistic answers from the Mayor in meetings we are subjected to hearing you, Mayor Harvey get on a soap box and preach your defensive logic from your self-proclaimed platform.
