BE IT REMEMBERED that on July 12, 2016, the City Council met in a regular session with the following members present: Mayor Carolyn Crane; Council members Bob Crane, Robert Stafford, Robert McKinnon, Clifton Morse and Melba Vandeveer.

The meeting was called to order at 7:00 p.m. and the following business was transacted:

Council member Clifton Morse made a motion to approve the minutes from the Regular Meeting held June 28<sup>th</sup>, 2016. Council member Robert Stafford seconded the motion. Motion carried.

Council member Bob Crane made a motion to approve the accounts payable as presented. Council member Robert McKinnon seconded the motion. Motion carried.

Council member Robert McKinnon made a motion to approve the appointment of Forrest Spence as Police Officer for the City of Kempner. Council member Bob Crane seconded the motion. Mayor Crane stated that Officer Spence has more than 16 years of experience in law enforcement. He served in law enforcement in Corpus Christi and Del Rio. He is currently Constable for Precinct 4 of Lampasas County. As a result of Mike Lock's recommendation, the Mayor states that Officer Spence was hired to begin immediately. Motion carried.
