BE IT REMEMBERED that on February 28, 2017, the City Council met in a regular session with the following members present: Mayor Carolyn Crane; Council Members Steven Martin, Robert McKinnon, Bob Crane, and Clifton Morse. Council Member Melba Vandeveer was absent.

The meeting was called to order at 7:00 p.m. and the following business was transacted:

Council Member Crane made a motion to approve the minutes from the Regular Meeting held February 14, 2017. Council Member McKinnon seconded the motion. Motion carried.

Council Member Martin made a motion to approve the accounts payable as presented. Council Member Crane seconded the motion. Motion carried.

Council Member McKinnon made a motion to accept the financial statements for the period ending January 31, 2017. Council Member Martin seconded the motion. Motion carried.

Mayor Crane stated a Kempner City resident requested "Children at Play" and "Stop" signs be placed on Cherokee Trail. The Mayor stated the City has both signs in their inventory, and that TxDOT confirmed the City is allowed to place the "Stop" sign on the corner of Cherokee Trail and FM 2808.

Council Member McKinnon stated he did not have a problem with the "Stop" sign, but did not see the need for a "Children at Play" sign in the middle of a street. He thought it would start a precedence that those signs would need to be everywhere.

Council Member McKinnon mentioned having the residents who want a "Children at Play" sign to purchase it themselves. Mayor Crane asked if he would have the residents purchase the sign even if the City has them in inventory. Council Member McKinnon answered yes.

Council Member Morse asked how many children are out in that area. Mayor Crane stated that was not something she could answer. Mayor Crane stated she sent an invitation to the council meeting to the resident who requested the signs. However, no one was in attendance from that area. She stated that if it was something the City needed to look into, the council could table the item for the next council meeting.

Council Member McKinnon made a motion to table action on the "Children at Play" and "Stop" sign for Cherokee Trail to research the need and cost for the signs. Council Member Crane seconded the motion. Motion carried.

There were no citizens signed in to address the council.

Mayor Crane stated the next council meeting will be March 14th, 2017.

Mayor Crane reminded the council of the upcoming Kempner Volunteer Fire Department annual Auction and BBQ. She stated the Auction and BBQ will be held on March 4, 2017, and encouraged the council to support them.

Mayor Crane stated the Kempner Municipal Court received a Certificate of Recognition from Texas Municipal Courts Education Center for participating in National Night Out 2016. She also mentioned that Kempner's Police Department, Police Chief Forrest Spence, and Volunteer Fire Department played integral parts in the City's National Night Out celebration.
