BE IT REMEMBERED that on March 26, 2019, the City Council met in a regular session with the following members present: Mayor Carolyn Crane, Council Members Don Casper, Bob Crane, David Richardson, and Melba Vandeveer. Council Member Clifton Morse was absent.

The meeting was called to order at 7:00 P.M. and the following business was conducted:

Council Member Crane made a motion to approve the minutes from the regular meeting held March 12, 2019. Council Member Casper seconded the motion. Motion carried.

Council Member Vandeveer made a motion to approve the accounts payable dated March 26, 2019. Council Member Richardson seconded the motion. Motion carried.

During the citizen speaking time, Kenneth Shirley spoke about opening up the Log Cabin Café again. He presented the Council a list of taxes that have been paid in the past.
