Dear Mayor Harvey and City Council Members:

Dan Hause, Richard A. Rowland, and Patrick Moore ("Petitioners") have filed the attached petition for creation of Lampasas County Emergency Services District No. 1 (the "District") with the Lampasas County Commissioners Court ("Court"). The District is proposed for the purpose of funding emergency medical services in the area by a constitutionally capped property tax not to exceed \$0.10 per \$100 of assessed valuation. The Court has accepted the petition and will hold a public hearing on July 16, 2019 to consider whether to grant the petition and call an election to allow the voters to decide whether to create the District. Because a portion of the proposed District is within the City of Kempner's city limits and extraterritorial jurisdiction ("Kempner Jurisdiction"), the City must consent to the inclusion of this area within the District before the Kempner Jurisdiction may be included within the District (Texas Health & Safety Code §775.014). This letter serves as a formal request that the City consent to creation of the proposed District and allow the District to include the Kempner Jurisdiction.

The Petitioners respectfully request to be placed on the City's agenda as soon as possible, and before July 12, 2019, at the latest, under an item titled, "Discuss and consider consenting to creation of the proposed Lampasas County Emergency Services District No. 1."

A map of the District and the metes and bounds description are included in the attached petition.

The Petitioners respectfully request that you consent to including the Kempner city limits and extraterritorial jurisdiction in Lampasas County Emergency Services District No. 1 by adopting a resolution similar to the attached and approving the request in writing.

#### TO THE HONORABLE COUNTY JUDGE AND COMMISSIONERS OF THE COURT:

NOW COME 100 or more qualified voters who own taxable real property in Lampasas County, Texas, pursuant to Texas Health & Safety Code, Section 775.011, requesting the creation of an Emergency Services District and would respectfully show the following:

#### I. CREATION AND OPERATION

The proposed new Lampasas County Emergency Services District ("District") will be created and operated under the provisions of Article III, Section 48-e of the Constitution of Texas and Chapter 775 of the Health & Safety Code ("Code") of the State of Texas.

#### II. NAME AND NUMBER

The name of the proposed District is "LAMPASAS COUNTY EMERGENCY SERVICES DISTRICT NO. 1."

#### III. AREA OF DISTRICT

That the area of the District does not overlap with any existing emergency services district and will generally include all or portions of the city limits of the City of Kempner and portions of the extraterritorial jurisdiction of the City of Copperas Cove that is within the boundaries of Lampasas County. Incorporated cities in the District include the City of Copperas Cove and the City of Kempner. The boundaries of the District are more particularly described by the description

attached as <u>Exhibit "A"</u>, which is attached hereto and incorporated herein for all purposes and generally shown on the attached sketch in <u>Exhibit "B"</u>.

#### SERVICES TO BE PROVIDED

The District will provide emergency fire services in response to any emergency situation in accordance with the authority granted to emergency services districts under Chapter 775 of the Texas Health & Safety Code.

#### IV. COMPLIANCE WITH CODE

The creation of the District complies with Sections 775.025 of the Texas Health & Safety Code.

#### V. PETITIONERS

That Dan Hause, who resides at 162 County Road 4693 Kempner, Texas 76539, Richard A. Rowland, who resides at 1295 County Road 3300 Kempner, Texas 76539, and Patrick Moore, who resides at 615 County Road 3300 Kempner, Texas 76539, (collectively, "Petitioners"), agree and obligate themselves to pay the cost incident to the formation of the District, including the costs of publishing notices, election costs, and other necessary and incidental expenses, such cost not to exceed one hundred fifty (\$150.00) dollars for Lampasas County.

#### VI. CITIES AFFECTED

The Cities of Copperas Cove and Kempner are the only municipalities whose consent must be obtained under Section 775.014 of the Code.

#### VII. SIGNATURES REQUIRED

The signatures required by Section 775.011(a) of the Code for the creation of the District are attached hereto as **Exhibit "C"** and are incorporated herein by reference.

WHEREFORE, PREMISES CONSIDERED, Petitioners pray that such notices be issued by the County Clerk of Lampasas County as required by law; that a public hearing be held on this petition in the county; that a copy of this petition be sent to Lampasas County Emergency Services District No. 1 together with a request for a statement of services; and, that after the hearing, the Commissioners Court of Lampasas County grant this petition and call a special election regarding the creation of the new District.



# STATE OF TEXAS COUNTY OF LAMPASAS CITY OF KEMPNER

BE IT REMEMBERED that on May 28, 2019, the City Council met in a regular session with the following members present: Mayor Carolyn Crane, Council Members David Richardson, Don Casper, John Wilkerson, Mack Ruszkiewicz and Melba Vandeveer.

The meeting was called to order at 7:00 P.M. and the following business was conducted:

Judge Isenhour presented Clifton Morse, Bob Crane and Mayor Crane with plaques, thanking them for their service to the City of Kempner.

City Secretary Stacy Roberts presented Dr. Keith L. Harvey with his Certificate of Election.

Dr. Keith L. Harvey signed his Statement of Officer.

Judge Isenhour administered the Oath of Office for Mayor of the City of Kempner to Dr. Keith L. Harvey.

Mayor Harvey stated that the Citizens comments has been moved to the front of the meeting. He wants to hear from the Citizens first.

No Citizens signed in to speak.

The first item on the Agenda is the minutes from May 14, 2019. City Secretary stated that there was one change. On the last page, the Mayor's name was changed to Dr. Keith L. Harvey. Council Member Wilkerson made a motion to approve the minutes from the regular meeting held May 14, 2019, with one request. He would like to have page numbers, 1 of 1 on the bottom of the page. Council Member Richardson seconded the motion. Motion carried.

Council Member Casper made a motion to approve the accounts payable dated May 24, 2019. Council Member Vandeveer seconded the motion. Council Member Wilkerson had a question as to why the training on Officer Pena's card was not itemized and what training did Officer Pena attend? City Secretary said that it was bailiff training and all training would be itemized from now on. Motion carried.

Dan Hause from the Kempner Volunteer Fire Department spoke about the creation of the Lampasas County Emergency Services District # 1. He would like to ask the City Council for the City's consent to form an ESD. The creation of the ESD will allow the City to grow and continue to receive fire protection. The ESD will provide much-needed equipment and training. Chief Hause said that KVFD averages 300 calls a year. The response time can be up to 25 minutes. The KVFD will present this to the Lampasas County Commissioners Court then it will be decided by the voters.

Council Member Wilkerson made a motion to approve to Resolution R-2019-05-28-001, with the modification of adding the #1 by the following the words Lampasas Emergency Service District #. The number one was left off. Council Member Casper seconded the motion. Motion carried.

Council Member Wilkerson made a motion that the Council adopts guidelines for the formal education of new and existing Council Members. Council Member Richardson seconded the motion. Council Member Casper asked where the funds this for training coming from. Mayor Harvey stated funds for the training would come from the current budget under the training section. At this time there are not funds available to send the Council and the Mayor. Mr. Richardson has been through the training (he paid for it himself) and

there could be a possibility that he help educate the other Council Members. Council Member Wilkerson asked it if Council Member Richardson was a certified trainer for the Texas Municipal League? Mr. Richardson is not a certified trainer. Council Member Ruszkiewicz state that with the current budget, he will not be attending the training at this time. The vote was as follows: Place I - against, Place II - against, Place IV - against, Place V - against. The vote is 1 to 4. Motion failed.

Council Member Casper made a motion to remove Mayor Carolyn Crane from all City bank accounts. Council Member Ruszkiewicz seconded the motion. Motion carried.

Council Member Wilkerson made a motion to add Mayor Keith Harvey to all City bank accounts excluding the Police Forfeiture Account. Council Member Vandeveer seconded the motion. Motion carried.

Council Member Richardson made a motion to accept the resignation of Bob Crane as the Sylvia Tucker Memorial Park Coordinator. Council Member Casper seconded the motion. Motion carried.

Council Member Wilkerson made a motion to amend possible action concerning the addition of Council Agendas and Minutes for the past two years being added to the City's website. The motion is amended to maintain two years of Agenda's and approved minutes, starting in May on the website. Council Member Vandeveer seconded the motion. Council Member Ruszkiewicz asked how it would affect the budget? Mayor Harvey replied that if we were to put the past two years on the website, it would cost \$500.00. If we started now the cost would be \$50.00 at the end of the year. Council Member Casper asked why this was necessary? Council Member Wilkerson stated that this is to keep the Council accountable. This is so the Citizens of Kempner can go back and view the minutes and see how the Council voted. Council Member Casper asked the City Secretary how long the items are kept. The City Secretary replied that the information is kept for years and is available thru an open request.
