## **ORDINANCE NO.** 2000-05-16-002

AN ORDINANCE OF THE CITY OF KEMPNER, TEXAS EXTENDING EXTRATERRITORIAL JURISDICTION TO ADJACENT AND CONTIGUOUS TERRITORY TO THE CITY; MAKING FINDINGS OF FACT; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Kempner, Texas (herein the "City") is a general law municipality authorized by State law to extend extraterritorial jurisdiction beyond one-half mile to areas adjacent to the City's extraterritorial jurisdiction at the request of owners of the property pursuant to § 42.022 of the Tex. Loc. Gov't. Code;

WHEREAS, the property being added to the City's extraterritorial jurisdiction is adjacent and contiguous to the present city extraterritorial limits;

**WHEREAS**, the property being hereby affected is not within the extraterritorial jurisdiction of any other City; and,

WHEREAS, City Council has held a public hearing to consider the voice and views of the citizens regarding the extension of the extraterritorial jurisdiction upon the property owners' requests:

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KEMPNER, TEXAS:

**SECTION 1.** That all of the above premises and findings of fact are found to be true and correct and are incorporated into the body of this ordinance as if copied herein their entirety.

<u>SECTION 2.</u> That the following described property, as more particularly shown in attached Exhibit "A", (hereinafter referred to as the "Property") is hereby joined and incorporated into the extraterritorial jurisdiction of the City of Kempner:

- (a) Tract 1: Being all of tracts number 2, 3, 4, 5, 6, 7, and 8 Pecan Valley Ranch Estates, Phase I, a subdivision in Lampasas County, Texas according to the plat thereof of record in Plat Cabinet 1, Slides 293-294 Lampasas County Plat Records.
- (b) Tract 2: Being all of tracts number 10, 11, 12, 13, 14, 15, 17, 18, 20, 21, and 22 Pecan Valley Ranch Estates, Phase II, a subdivision in Lampasas County, Texas according to the plat thereof of record in Plat Cabinet 1, Slides 295-296 Lampasas County Plat Records.
- (c) Tract 3: Being all of tracts number 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 55, and 58 Pecan Valley Ranch Estates, Phase III, a subdivision in Lampasas County, Texas according to the plat thereof of record in Plat Cabinet 1, Slides 300-301 Lampasas County Plat

#### Records.

- (d) Tract 4: Being all that certain tract or parcel of land being 8.91 Acres, comprised of 0.01 Acres, of the C. H. Casper Survey, Abst. No. 156, and 8.90 Acres, of the James F. Keller Survey, Abst. No. 1163, and being part of a 9.04 Acre tract described in a deed from Paul C. Hudson, Trustee to Dorothy M. Boehnlein as recorded in Volume 304, Page 967 of the Deed Records of Lampasas County, Texas.
- (e) Tract 5: Being all that certain tract or parcel of land being 246 acres, more or less, of land out of the Wm. Gray Survey in Lampasas County, Texas, in a deed to W.W. Cox, of record in Volume 81, Page 294 of the official records of Lampasas County, Texas.
- (f) Tract 6: Being all that certain tract or parcel of land being 5.41 acres, more or less, comprised of 2.55 acres, more or less, of the E.J. Nesbit Survey, Abst. No. 1384, and 2.87 acres, more or less, of the James F. Keller Survey, Abst. No. 1163, and being a part of a 5.00 acre tract described in Volume 310, Page 910, of the Deed of Records of Lampasas County, Texas, and all of the 0.556 acre tract described in Volume 304, Page 738, of Lampasas County, Texas.
- (g) Tract 7: Being all that certain tract or parcel of land being 1.00 acre, more or less, of the E.J. Nesbit Survey, Abst. No. 1384, described in Volume 308, Page 948, of the Deed of Records of Lampasas County, Texas.
- SECTION 3. That the official map and boundaries of the City's extraterritorial boundaries, heretofore adopted and amended be and hereby are amended so as to include the Property as part of the extraterritorial jurisdiction of the City of Kempner.
- SECTION 4. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable and, if any phrase, sentence, paragraph or section of this Ordinance should be declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of this ordinance of any such invalid phrase, clause, sentence, paragraph or section. If any provision of this Ordinance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision, and to this end the provisions of this Ordinance are declared to be severable.
  - **SECTION 5.** That this ordinance shall take effect immediately from and after its passage.
- **SECTION 6.** That it is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, *Chapt. 551*, *Tex. Gov't. Code*.


