## A RESOLUTION OF THE CITY OF KEMPNER, TEXAS, NAMING THE CITY OF KEMPNER CITY HALL BUILDING AS THE "ISENHOUR-CLARK MUNICIPAL BUILDING"

WHEREAS, the Kempner City Council and Mayor recognize the extraordinary contributions Grady Eugene "Gene" Isenhour Jr and Jackie Neil "Jack" Clark have made to the City of Kempner over the past 25 years; and

WHEREAS, Gene Isenhour has donated his time, services and personal resources to ensure the success of the city for over 17 years, as a Council Member, Mayor Pro-Tem, Mayor and Municipal Court Judge; and

WHEREAS, Jack Clark has donated his time, services and personal resources to the City of Kempner by donating countless hours of invaluable financial guidance and expertise since the formation of this City; and

WHEREAS, the financial and structural planning of the Kempner City Hall Building is attributed to the tireless efforts of these two men; and

WHEREAS, both of these men continue to provide services to the Citizens of this City at no cost to the citizenry of this city.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KEMPNER THAT THE CITY HALL BUILDING LOCATED AT 12288 US HIGHWAY 190 IN KEMPNER TEXAS BE HEREAFTER NAMED THE "ISENHOUR-CLARK MUNICIPAL BUILDING" IN HONOR OF GENE ISENHOUR AND JACK CLARK AND AUTHORIZE THE MAYOR TO PERMANANTLY AFFIX A SIGN TO THE BUILDING REFLECTING SUCH.

**SECTION 1. FINDINGS.** The City Council of the City of Kempner has found the aforementioned gentlemen have made contributions to the citizens of the City of Kempner which far exceed that which is expected from any elected official, officer of the City, or volunteer.

**SECTION 2. AUTHORITY TO MODIFY.** The Mayor, on behalf of the City, is hereby authorized to select, purchase and affix a sign to the exterior walls of the City of Kempner Municipal Building, located at 12288 US HWY 190 in Kempner Texas, reflecting the intent of this resolution.

**SECTION 3. SEVERABILITY.** If any provision of this resolution or the application of any provision to any person or circumstance is held invalid by a court of competent jurisdiction, the invalidity of such provision shall not affect the other provisions contained herein and to that end the remaining provisions remain and are declared severable.

**SECTION 4. OPEN MEETINGS.** It is hereby officially determined that the meeting in which this resolution is passed was open to the public and furthermore, notice of the meeting was lawfully posted in accordance with the Texas Open Meetings Act.
