# 7. Boonslick Regional Planning Commission:

### a. Ashley: Truesdale Active Transportation Plan

- i. Ashley provided the survey results from the public. After going over the results of the survey, we discussed prioritizing needs as to where any sidewalks, trails, bike lanes, etc would need to be placed within the City of Truesdale. As a Board we decided that the High priority places for needs would be from Laura Street to Conrad Cir on the East side of the road. The second highest priority would be working on Highway M from Green Gardens to Spoede Road. We had discussed running a sidewalk along the South Side of Highway M to Mark's Automotive. Then running a crosswalk over Highway M to the North side of the road, continuing the sidewalk to Spoede Road. If we can put in a walking trail from Heritage Hills to Spoede Road, then we would want to continue the sidewalk from Highway M/Spoede Road to that walking trail. It was discussed that we could keep track of how much foot or bike traffic runs on South Water Street and South Street before and after school, as both of those streets could potentially be a medium priority for a sidewalk. The lowest priority streets would be Smith Street, Depot Street, Conrad Cir (along the entire circle in Dieckman Farms), and streets within Heritage Hills.
- ii. There is the potential that we could apply for a TAP Grant from the State of Missouri to possibly be able to use for a bike lane along Highway M. If there was the potential to put a bike lane on Spoede Road as well, we would have to get approval from Warren County as that is a County Road not a City Street.
- iii. There needs to be a public hearing to approve a final draft of the Active Transportation plan. That meeting has been scheduled for September 20, 2023, at 5:30 p.m. immediately before the Planning and Zoning Meeting.
