Highway Superintendent's Report: HWS Tony Domenicone said that since being back they have cleaned the equipment and shop. They sanitize daily and have been using all safety equipment for COVID. The new employee did not show up to work, failing to meet his probationary period, so he was let go. Consensus was to hold off on replacing the lost employee. Tony had the 284 agreement for the Highway Expenditures. One is that we just spend the CHIPS money and roll the rest of the money into next year, or two we spend our CHIPS and spend 1/3 of the summer budget and purchase patch and make small repairs to the roads that will not survive next winter season. Consensus of the Board was to not replace the employee right now and to hold off on major repairs.

Dog Officer's Report: Turned in and available to view in office.

Correspondence: Supervisor Nirelli went over the status of NYS as when we will be opening. We are missing one aspect of being able to reopen. Madison County region is hoping to open by Friday May 15 but will probably be pushed back even further. She also has had a significant amount of calls and letters with complaints regarding Springwater Farms manure Pit between Bruce Road and Harp Road. Supervisor Nirelli has received phone calls from Senator Mays office and Assemblyman John Salka and from Brindisi's office. They asked if there is anything that the Town can to pause, stop or move this to someplace else. However, the Town has no recourse on this as this is governed by the DEC and Ag and Markets. The DEC has put a hold on this until the 20th of May. After this they will start back up with the construction. It can not be prohibited.

New Business:

Supervisor Nirelli says we are trying to move forward with an appraisal for the old schoolhouse/town hall. She received an email from Chris Kantak through inquire reality. He came out and evaluated the property to other commercial properties in the area. It has an assessed value at \$63,900.00 with a market values of \$64,900. Councilmember Melissa During asked to see the CMA of the property when we get it. Supervisor Nirelli will email it to all when she receives it.

COVID virus differently. As a township we cannot move forward separately from the county. The Town Clerk has still been meeting everyone by appointment and keeping regular hours. There is a draft reopening phase through Madison County based on May 8th on their website. As for our Town Meetings, we will continue with Zoom Meetings for the public and possible meeting as a Board in person with Social Distancing. Councilmember Russell Blanchard said he is ready to come back. Supervisor Nirelli stated that if we can, as a town, enable the Planning Board to resume via Zoom Meetings but continue to not allow the public into the Town Hall and to follow Madison Counties guidelines for when the Towns and Counties can open. Mat Spendley will check in with the Planning Board to see if they want to start meeting at the Town with Zoom meetings for public. If they do have a Public Hearing via zoom, then they can leave the hearing open until the next meeting so the public can email or letter in their comments and concerns. Supervisor Nirelli said there is a whole protocol for meeting in person that we will have to follow.

RESOLUTION #56-2020: Councilmember Russel Blanchard made a motion to allow the Planning Board to resume their monthly meetings with the protocol of the COVID-19 Social Distance criteria that we have in place.
