HW Supervisor Anthony Domenicone said he had some complaints regarding the lack of Topsoil for the new Water district. Supervisor Nirelli said that they will be going back afterwards to fix the topsoil after the project is complete, they are just temporally doing a rough grade to make it look nice for now and to keep the dust down. HWS stated that he got a letter for the CHIPS for 21-22. The 20% they withheld in 2020, we are getting back 90% of that back which will pay for all of the paving for this year.

Doug Holdridge stated that There is still a surplus of \$22,364 that needs to go into the HWS. Supervisor Nirelli stated that it is in unexpended funds balance until the end of this year and then be moved over.

HWS Tony stated that we received one bid for paving from Ulster Paving at a bid of \$58,280.00.

Jayne asked about the Church parking lot, Tony said probably September.

Supervisor Nirelli asked Highway Supervisor Tony Domenicone about a culvert on Nelson Road and he stated that it is part of the work planned for this year.

Supervisor Nirelli was asked about Bruce Road, several residents wanted Bruce Road to become a seasonal road. Tony said it cannot because people live on the road. Another resident stated that a culvert that was put in is too small for any runoff and is going over the culvert. Mason's retention pond was turned back into a hay field, the Town ditch was not designed to handle that run off. The residents need to put the retention pond back in and discuss with Soil and Water. Bruce Road tree trimming is part of the road work this year.

RESOLUTION #93-2021: Councilmember Russell Blanchard made a motion reopen as the State allows if you are vaccinated to have no mask and no social distance, if not vaccinated you must wear mask and be 6 feet social distance.

Supervisor Nirelli spoke with the Schultheis family that we would plant a new tree and have the monument moved to our new Town Hall.
