Supervisor Nirelli asked Attorney Jim Stokes about the legals of putting this on the market. His response was to sell as close to fair market value as possible. When we have an offer to make a resolution for a Permissive Referendum. Supervisor Nirelli stated that they will go to executive session to discuss at the end of the meeting. She also stated that the old Town hall needs to be cleaned out and the remaining items moved to the New Town hall. The Judicial Records will be handled by the Judges only to move.
