### **Correspondence:**

- A. Received the annual Onondaga Water Report.
- B. Letter from Jeffrey Baxtor, energy advisor regarding renewable energy and how he can help us with future endeavors.
- C. Codes received a letter from a resident that wants to replace a trailer on a pad that is too big for a single wide. The code that dictates this is a NYS Code not Town of Lincoln code. The Pad cannot be any wider than the unit because of water that can run under it and end up with Mold and unsafe

conditions. Codes Enforcer Larry Cesario said that he should get an engineer to help him modify the pad to make it approved.

NYSAC inflation data information was in for 2022.

### **Old Business:**

- A. Supervisor Nirelli stated that the water survey resulted in 217 postcards returned out of an approximate 712 surveys that were sent out. 16 returned for no address, 62 yes 139 no. Supervisor Nirelli asked if the Board wanted to look at the yesses by location. We will look at them next month.
- B. Supervisor Nirelli discussed the proposed Solar Local Law. Planning Board Member Mat Spendley discussed the law as presented. Attorney Richard Andino spoke via speaker phone to the Board about the proposed law.

RESOLUTION #102-2021: Councilor Doug Holdridge introduced proposed Local Law B-2021, "A Local Law to Amend the Town of Lincoln Land Management Law to Add a New Article Regulating Solar Power and Energy Systems in the Town", which Local Law will permit and regulate the construction of solar energy systems in the Town of Lincoln in a manner that preserves the health, safety and welfare of the Town, while also facilitating the production of renewable energy, and made the following motion which was seconded by Councilor Melissa During

**WHEREAS**, proposed Local Law B-2021 has been introduced and will be considered for enactment pursuant to the provisions of the Municipal Home Rule Law; and

**WHEREAS**, Volume 6 N.Y.C.R.R., Sections 617.3 and 617 of the Regulations relating to Article 8 of the New York Environmental Conservation Law of New York (SEQRA), requires that as early as possible after submission of a completed application, an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

**WHEREAS**, the adoption of said Local Law is a Type I action for purposes of environmental review under SEQR; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Lincoln, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said proposed Local Law, with the result that the Town Board shall act as lead agency in this matter; and

**WHEREAS**, the Town Board has determined that a Full Environmental Assessment Form (EAF) shall be required in connection with this matter; and

**NOW, THEREFORE**, it is

**RESOLVED AND DETERMINED** that the enactment of proposed Local Law B-2021 is a Type I action, there are no other involved agencies and this Board shall act as lead agency in this matter for purposes of SEQRA review; and it is further

**RESOLVED AND DETERMINED** that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law B-2017 at the Lincoln Town Offices located at 6886 Tuttle Road, Canastota, NY 13032 in the Town of Lincoln on August 11, 2021 at 7:30 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard.

- C. Attorney stated that the Moratorium expires in October for wind, and perhaps extending the moratorium for wind due to the restrictions from Covid during our current Moratorium. Would need a local law introdued at the August meeting to vote on in September.
- D. Supervisor Nirelli spoke of the sale of the Old Town Hall. Our attorney has been getting the documents together. Tony has been trying to get the well back on. Kincaid came to look at the issue stating there may be an issue with a leak in the pipe. A plumber then came out an attempted to purge the system and found the well is infested with water snakes. The Water construction company are testing the lines on Timmerman currently and hopefully get the Town Hall hooked up to City Water. So, we can either fix the well or hook up to city water. Our Attorney suggests that we do a permissive referendum for 30 days.

**WHEREAS**, the Town of Lincoln (the "Town") has received a number of offers to purchase the former "Town of Lincoln Town Hall" tax parcel no. 52.10-1-37, being a 1.46 +/- acre parcel of property, including a building, on 3849 Timmerman Road in the Town of Canastota, and

**WHEREAS**, the Town Board has considered all offers and finds the purchase proposal of \$65,000.00, advanced by Ms. Thelma Musacchio of 4032 Seeber Road, Canastota, New York 13032 to be reasonable; and

**WHEREAS**, the Town has no public use for this excess property and is willing to sell the same to Ms. Musacchio for the proposed amount of \$65,000.00; and

NOW, THEREFORE, BE IT

**RESOLVED AND DETERMINED**, that the Town Board hereby approves the sale of the aforementioned property to Ms. Musacchio for the purchase price of \$65,000.00; and it is further

**RESOLVED AND DETERMINED**, that the proposed purchase price of \$65,000.00 is a reasonable market value for the subject parcel; and it is further

**RESOLVED AND DETERMINED**, that the Town will provide an up-to-date survey and abstract of title for the property to the buyer; and it is further

**RESOLVED AND DETERMINED**, that the sale of said property to Ms. Musacchio will be subject to the terms and conditions and provisions of the "Contract to Purchase" between Ms. Musacchio and the Town; and it is further

**RESOLVED AND DETERMINED**, that the Town will provide a warranty deed to the buyer; and it is further

**RESOLVED AND DETERMINED**, that this sale of publicly owned Town property is subject to permissive referendum.

- E. Supervisor Nirelli gave an update on the Water District. They have gotten their copper in and now hooking up those spots that can be tested and approved by OCWA. OCWA said they may allow hook ups in phases. No written decision from OCWA regarding this yet though. They have gone down Nelson and Knolls East. Rt 5 is not hooked up yet.
- F. The Mandatory Referendum for the Justice position the paperwork is being done and will be sent out to the BOE to make sure it is what NYS requires.
- G. EV Charging Station 1st Deposit is due. We will get it back from NYSERDA at the end of the project's completion.

They are on an hourly rate if we would like to retain them. The Board members chose to wait until next month to decide.

She will check in with Tyler Farwell about filling the position. Councilor During would like to come up with an updated code of ethics and try to get an ethics committee together.
