

**CITY OF CORYDON, KENTUCKY
ORDINANCE 2022-1**

AN ORDINANCE CHANGING PENTECOST STREET FROM A TWO-WAY STREET TO A ONE-WAY STREET

WHEREAS, Pentecost Street is presently a two-way street between Center Street and U.S. 60; and

WHEREAS, the City Council of the City of Corydon has determined that changing Pentecost Street to a one-way street running from Center Street to U.S. 60 is in the best interest of the City of Corydon.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CORYDON, KENTUCKY, THAT TITLE VII OF THE CORYDON CODE OF ORDINANCE (TRAFFIC CODE) IS HEREBY AMENDED AS FOLLOWS:

SECTION I

Pentecost Street is hereby declared to be a one-way street running from Center Street to U.S. 60, and the City of Corydon Traffic Code.

SECTION II

The Mayor is hereby authorized and directed to place and maintain appropriate one-way traffic signs in accordance with applicable state laws, regulations and specifications providing notice to the public of the one-way street designation approved by this Ordinance. After placement of such signs vehicular traffic on Pentecost Street shall move only in the direction indicated by the one-way traffic signs.

SECTION III

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law and upon placement of signage as specified herein.
