AN AMENDED ORDINANCE SETTING THE DAY AND TIME FOR
THE REGULAR MEETING OF THE CITY COUNCIL OF
CORYDON, KENTUCKY
92.1

WHEREAS, KRS 61.820 states, in part, that all public meetings shall be held at specified times and places which are convenient to the public, and that a schedule of said times and places shall be made available to the public;

NOW, THEREFORE, BE IT ORDAINED by the city of Corydon that:

1. Henceforth, the Corydon City Council shall conduct its business at ~~two regular monthly meetings~~ **one regular monthly meetings**. The meetings shall be held on the ~~1st and 3rd~~ Thursday of each month beginning at 7:00 PM at City Hall.
2. When a quorum is not present at the ~~1st Thursday or the 3rd Thursday~~ meeting. **Special Meeting (KRS 61.823), Any meeting that deviates from the regular meeting schedule is a special meeting. Can be called by presiding office (Mayor) or upon written request of a majority of the legislative body. Discussion and action limited to items listed on special meeting agenda**
The Council shall conduct business on the following Tuesday 7:00 PM. The meeting place shall be Corydon City Hall.
