Plaintiffs Talia Jackson, Nathan Alfano, and Kristen Moore (together, the "Plaintiffs") and defendants Melissa Bacelar, Wagmor Pets, Wylder's Holistic Pet Center, Inc. d/b/a The Wagmor (together, the "Defendants") (collectively, with the Plaintiffs, the "Parties") through their respective counsel submit this Joint Status Report.

A. PLAINTIFFS' POSITION:

On January 24, 2024, the Parties attended a full-day, in-person mediation session before the Hon. Suzanne Segal (Ret.) of Signature Resolution. Following several postmediation communications through the assistance of Judge Segal, Plaintiffs and Defendants' insurance carrier, The Hartford, reached a proposed class action settlement in principle on or about February 26, 2024.
