## Memorial Day

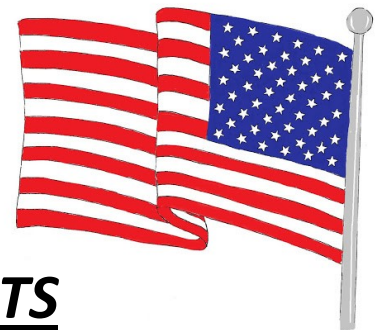

Did you know? Each year on Memorial Day a **National Moment of Remembrance** takes place at 3:00 p.m. local time. The National Moment of Remembrance, established by Congress in 2000, asks Americans, wherever they are at 3 p.m. local time on Memorial Day, to pause in an act of national unity and remembrance for a duration of one minute.



## FLAG FACTS

A flag expert is called a "vexillologist".

The U.S. Flag, adopted on June 14, 1777, is the fourth oldest national flag in the world. Denmark's flag, adopted in 1219, is the oldest.

The blue field on the U.S. Flag is called the "union".

On Memorial Day, to honor all those who died in battle, the flag should be displayed at half-staff until noon only, then raised to the top of the staff for the remainder of the day.

June 14 was proclaimed Flag Day by President Woodrow Wilson in 1916. While Flag Day was a popular celebration in scores of communities for many years after Wilson's proclamation, it didn't receive its official Congressional designation until 1949.

## **Topic of Interest for our Community**

With the beautiful weather and the desire to get outdoors, many of us have been out walking and cycling in the neighborhood. We all want to stay safe as we do so. Please remember that in the state of Florida, bicycles are considered vehicles. They should be ridden with traffic on the right-hand side of the street just like cars and obey traffic laws. Cyclists should wear bright colors and use a white light in front and a red light in the rear if riding after sunset. Also, those that are walking in areas that do not have sidewalks, should walk against traffic on the left-hand side of the street. This allows for oncoming traffic to see you more easily and you won't be surprised by someone coming upon you from behind. You'll be more visible to motorists especially after sunset if wearing light colors. Pedestrians and cyclists please travel single file in areas where you'll encounter motor vehicles. Thankfully, since the sidewalk was installed on Ohio in 1991 there have been no pedestrian fatalities, but there have been pedestrian and bicycle accidents resulting in injuries on several roads throughout our neighborhood through the years.

## **USE CAUTION WHEN CHARGING A GOLF CART**

Many of our residents enjoy the use of golf carts for travel around the neighborhood. Some are gas powered, but most are battery operated and require periodic charging. A little-known risk is charging a golf cart within a closed garage, especially if the batteries are low on water. The process of battery charging produces hydrogen, an explosive gas, which can be ignited by the operation of the electric motor on the garage door opener. There was a recent article in the Palm Beach Post about this risk. If you are going to charge your golf cart in the garage, make certain there is adequate ventilation and that the batteries are properly filled with water before you charge. Interestingly, hydrogen build-up can trigger a carbon monoxide detector. I actually know someone who this happened to. When their CO detector alerted them to a dangerous condition, they properly evacuated the house and called the fire department. The responders carefully vented the house without incident, but instructed the residents on the potential negative effects of charging their golf cart in their unvented garage.

## **MORE FLORIDA GARDENS HISTORY**

Another in a series of articles on the interesting history of our community.

Ever wonder why the streets on the southern half of the neighborhood all start with 'West...' (West Mango, West Palmetto, West Cypress, etc.)? To understand it, you have to go back to the original vision of Karl Beachler. In 1951, Mr. Beachler bought all the property from the Turnpike east to what is now the beginning of the Fountains community, with the grand plan of creating a small municipality called Florida Gardens Village. If you look at the original plat plan, the area to the east of our present community (the area we now know as Lucerne Lakes) was to be much like our present Florida Gardens layout. In fact, the area south of the L13 canal was to be a mirror image of our community today. Thus, while the streets on the west side of Ohio Road were West Mango, West Cypress, etc., the matching streets on the east side of Ohio were to be East Mango, East Cypress, etc. Sales of lots started in the west 'half', so all the 'West...' streets were built. However, the grand vision was not to be. Mr. Beachler recognized that what was trending in the Florida real estate market were golf course communities, so he abandoned the original plot plan and instead the Lucerne Lakes golf community we know today was created.

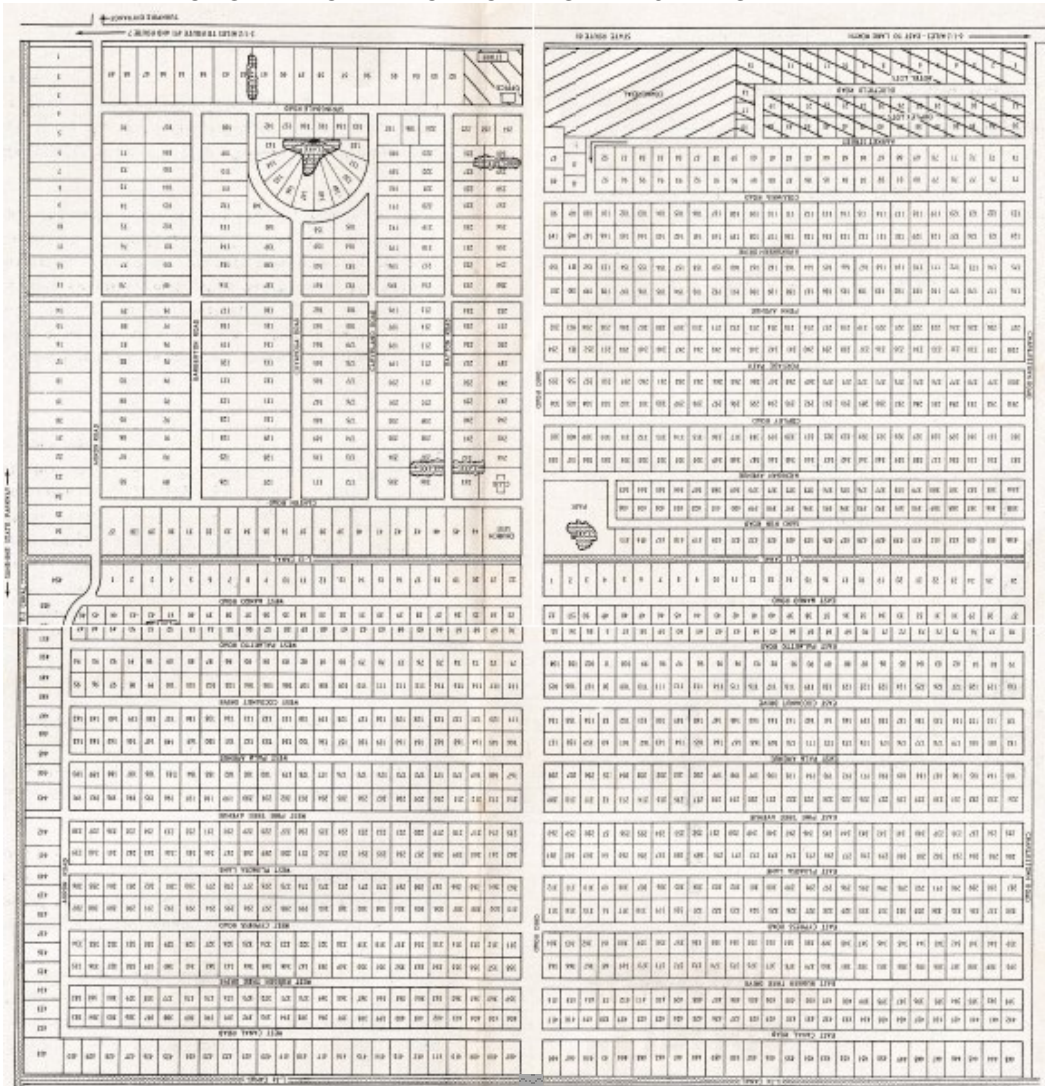
By the way, the street we know today as West Arch Drive wasn't originally that at all. It was to be West Canal Road (and its East Canal Road counterpart). Because canal property was desirable, a few of the lots along what is today East Arch Drive were sold. For a reason I have yet to uncover, the East Canal Road name was dropped and it was changed to (simply) Arch Drive. At some point after that, another change was made to designate the East and West Arch Drive roads we have today. Since some properties there had already been sold, that small section of Florida Gardens along East Arch Drive was not converted into the Lucerne Lakes golf community.

It was because of Mr. Beachler's original grand vision for the area that he successfully lobbied the Governor and the Florida Turnpike Authority to build the access ramps to the Florida Turnpike (then called the Sunshine State Parkway) from Lake Worth Road. When it opened in the spring of 1959, it was designated Interchange #32. Archives contain a picture of Mr. Beachler, Governor Leroy Collins and other dignitaries at the ribbon cutting when the Turnpike access was opened.

Speaking of our archives, I would like to take this opportunity to thank Libby Eagen, one of Florida Gardens first residents, for saving and donating almost all the historic memorabilia on the early days of Florida Gardens.

I hope you enjoyed this brief look at some more of the history behind our community.

## Share a Recipe

## **SPANISH RICE AND FISH**

The recipe for this dish calls for talapia, but feel free to swap in your favorite. Cod or catfish are good options.

### Ingredients :

14-oz can of no-salt-added  
petite diced tomatoes  
7-oz box of Spanish rice mix  
1/2 lb tilapia fillets  
1/4 tsp pepper  
4 lemon wedges

### Directions :

Preheat oven to 375 degrees F. Bring water, tomatoes and rice mix to a boil in a saucepan. Remove from heat and pour into a 2-qt or 8" x 8" baking dish. Cover tightly with foil and bake for 10 minutes.

Remove from the oven and remove the foil. Place the tilapia fillets on top of the rice mixture. Sprinkle the fish with pepper. Top the fish with the lemon wedges. Replace the foil and return to the oven. Bake 20 minutes. Remove from the oven and let stand for 5 minutes before serving.

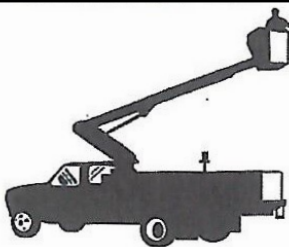
