

## Field Trip Permission

I have read and agree to the conditions of this permission form, and I give permission for staff from Beck 'n Call Pet Care to transport my dog to the city's public dog park.

I understand Beck 'n Call staff will take every precaution to ensure the safety and happiness of my pup while on the field trip. But I understand that unleashed dog(s) in a public dog park involve risks of injury to people, my dog(s), and other dogs, and I agree those risks are entirely my responsibility.

I understand that dogs, irrespective of their training and usual past behavior of characteristics, may act or react unpredictably at times based upon instinct of circumstances, and I agree to assume that this risk may result from aggressive, vicious, and dangerous dogs, which may be present.

I further understand that not all dogs present in the public dog park have received the Rabies vaccine as required by law, and that not all dogs using the public dog park have been vaccinated for Distemper, Bordetella, or Parvo - all of which could result in illness or injury to my dog(s).

Additional risks include, but are not limited to dog fights, dog bites and injuries to humans and other dogs; dog escape; vegetation may have burrs or seeds that could become tangled in a dog's coat or lodge in a dog's feet, ears, nose, or eyes; mosquitoes, ticks, chiggers, fleas or other insects may be present; wild animals such as skunks, raccoons, opossums, or stray dogs could be present, all of which might injure or infect my dog(s).

### Liability Release and Indemnity Agreement

I hereby release and forever discharge and agree to save and hold harmless Beck 'n Call Pet Care and its staff of any and all injuries, including but not limited to my dog(s) personal injury disability, dismemberment and death, illness, losses, damages, claims, liabilities, or expenses of any kind of nature (and whether accruing to me, my heirs, or my personal representatives) that are caused or alleged to be caused in whole or in part by the action, negligence, failure to act or condition of the public dog park, any accident during transport, and that arise in connection with the field trip.

I hereby agree to hold harmless and indemnify Beck 'n Call Pet Care and its staff for any and all injuries related to, caused by, or arising from, either directly or indirectly, any act or omission of my dog, including but not limited to any damage, personal injury, death, loss, claims, liabilities, and expenses of any kind or nature.

I further understand:

Beck 'Call will take every precaution to ensure my pet has a happy and safe stay, but Beck 'n Call will not accept responsibility for Canine Influenza, Canine Cough, flea or tick, loss/escapes, illness or any kind of injury.

1. In the event that it is necessary for the Beck 'n Call Pet Care to seek veterinary assistance without the consent of the client who may be unavailable to provide such consent, then I agree that the cost of any procedure undertaken as a result will be my full and financial responsibility.
