May 2 - Voluntary Recall of Certain Golden Flake, Good Health, UTZ and Weis Brand Tortilla Chips Because of Possible Milk Allergen - Utz Quality Foods, LLC, is voluntarily recalling select expiration dates of some Golden Flake, Good Health, Utz and Weis Brand Tortilla Chip items due to potential contamination of undeclared milk allergen. People who have an allergy or severe sensitivity to milk run the risk of serious or life-threatening allergic reaction if they consume these products.

May 3 - More than 35,000 pounds of raw ground beef products recalled

A Lenoir, NC establishment announced that they will be recalling 35,464 pounds of raw ground beef products that may be contaminated with extraneous materials, specifically hard plastic. The products were shipped to distribution centers in Indiana and Virginia for further distribution to retail locations, including Kroger. According to the FSIS, the products subject to recall have establishment number "EST.34176" inside of the USDA mark of inspection. The steering wheel on the go-kart can detach, break or crack while in use, posing a laceration and/or collision hazard to young children.

May 9 - Women's Scarves Recalled by Wrapables Due to Violation of Federal Flammability Standard (Recall Alert) - The U.S. Consumer Product Safety Commission in cooperation with Wrapables, of Fremont, Calif., today announced a voluntary recall of Women's scarves. The women's scarves fail to meet the federal flammability standard for clothing textiles, posing a risk of burn injuries to consumers.
