PET TRANSPORTATION AGREEMENT

This is an agreement between Casper's Canine Cab, LLC and the pet owner whose signature appears below. (hereinafter called "Owner")

The following are terms of service for the transportation of the Owner's pet (hereinafter called "pet") as a guest with Casper's Canine Cab, LLC.

- 1. Casper's Canine Cab, LLC reserves the right in its discretion to deny transportation to any pet for any reason at any time.
- 2. Owner represents that he/she is the sole owner of the pet, free and clear of all liens and encumbrances.
- 3. Owner certifies the accuracy of all information provided to Casper's Canine Cab, LLC verbally, electronically or in writing about the pet.
- 4. Owner agrees to pay for the transportation provided and any additional services requested, at the rates in effect on the date the pet is transported by Casper's Canine Cab, LLC. Owner understands payment in full is due at check-out.
- 5. Owner agrees if payment in full is not received at check-out, Casper's Canine Cab, LLC will bill the remaining charges to the Owner's credit card on file. If payment is not received within 14 days, the Owner agrees to be responsible for any collection costs and/or attorney's fees incurred by Casper's Canine Cab, LLC in collecting payment.
- 6. Owner represents that, to the best of Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in. Owner represents that each time the pet is transported by Casper's Canine Cab, LLC, Owner is re-certifying that the pet is in good health and has not had any communicable illnesses of any kind for thirty days prior to transportation. During the period of this contract, Owner also agrees to notify Casper's Canine Cab, LLC of any known exposure of the pet to a communicable disease.
- 7. Owner certifies that the pet is up to date on all vaccinations required or recommended by Owner's veterinarian. It is expected to include immunizations for DHLPP (Distemper, Hepatitis, Leptospira, Parvovirus, and Parainfluenza) Rabies, and Bordetella.
- 8. Owner understands that Casper's Canine Cab, LLC tries to ensure that all pets it transports are fully vaccinated. However, it is still possible for Owner's pet to become ill, even if vaccinated. Owner understands that this is not due to any circumstances or conditions at Casper's Canine Cab, LLC, and agrees not to make any claim against or hold Casper's Canine Cab, LLC liable in the event their pet becomes ill during or after it's transport. Casper's Canine Cab, LLC agrees to use its best efforts to maintain a clean and sanitary environment.
- 9. Owner agrees to be solely responsible for any and all acts or behavior of the pet while in the care of Casper's Canine Cab, LLC, to include payment of costs for injury to staff or other animals or damage to the vehicle caused by the pet. Owner further agrees to indemnify, defend and hold harmless Casper's Canine Cab, LLC from and against any claims made against Casper's Canine Cab, LLC or its employees or members or other agents for losses or damages of any kind suffered by Casper's Canine Cab, LLC or any other party as a result of Owner's failure to inform Casper's Canine Cab, LLC of any pre-existing condition the pet may have (such as illness or aggression problems) or which were otherwise caused by or related to the pet.
- 10. In extreme cases, and in Casper's Canine Cab, LLC's discretion, dogs may be muzzled for their protection or the protection of other dogs or staff.
- 11. Owner agrees that Casper's Canine Cab, LLC shall have no liability or responsibility for any

loss, injury, disease, death, running away, or injury to other persons, other pets, or property arising out of or related to the transportation of any pet.

- 12. Owner agrees the pet is on flea and tick prevention, and to be financially responsible for any required treatment for fleas and ticks, for the pet or for the vehicle, staff or facilities of Casper's Canine Cab, LLC, if determined necessary by Casper's Canine Cab, LLC.
- 13. This agreement contains the entire agreement between both parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, personal representatives, successors and assigns of the Owner and Casper's Canine Cab, LLC.
- 14. Any controversy or claim arising out of or related to this contract, or breach thereof, or as the result of any claim, or controversy involving the alleged negligence by any party to this agreement, shall be settled, if possible, in mediation or in Small Claims Court. The prevailing party in any such matter shall be entitled to recover from the other party court costs and reasonable attorney fees.
- 15. Casper's Canine Cab, LLC agrees to use its best efforts to transport and take care of the pet while the pet is in its custody. Casper's Canine Cab, LLC makes no representations or warranties of any kind with respect to the service rendered under this Agreement other than those expressly set forth herein, and expressly disclaims any and all other warranties expressed or implied including any implied warranties of merchantability of fitness for a particular purpose.

I certify that I have read and understand the policies of Casper's Canine Cab, LLC as set forth in this Pet Transportation Agreement and that I acknowledge and agree to all of the terms and conditions of this Agreement.
