MEMORANDUM TO: Chief of Staff
(Thru Chief Administrative Officer)

SUBJECT : Advance Instructions to United Nations Prisoners of War
in Germany.

I - DISCUSSION:

1. It is estimated that, at the conclusion of hostilities, there will be in confinement at Prisoner of War Camps in Germany, some two million prisoners of war. Should these prisoners attempt to make their way back, either individually or in groups, it would greatly hinder and impede our movement into Germany and the early assumption of the control of the German Administrative Government. To prevent this, and to facilitate their repatriation, and protection pending evacuation, the respective governments concerned have agreed that the prisoners of war should remain in their camps.

2. It is proposed that, at the conclusion of hostilities, advance instructions to prisoners of war in Germany, signed by General EISENHOWER, be distributed by two means:


- a. Thru German authorities.
- b. By dropping from planes over the camps.

3. These instructions provide that every prisoner of war is to remain in his respective camp until the arrival of the Prisoner of War Contact Officer, and that the camp leader will assume command of the camp for all purposes, including discipline.

4. It is proposed to print this paper in English, French and German, and in Russian, if the last named agree to this plan. It would then apply to all United Nations prisoners of war in German camps.


II - RECOMMENDATIONS:

3. The instructions contained herein are intended to facilitate the repatriation of Prisoners of War, and to ensure their protection and well-being, pending evacuation. Failure to do so will not only affect the individual, but will react on all concerned, by causing further delay in repatriation.

4. On receipt of these orders, the Camp Leader will assume command of his camp for all purposes, including discipline. 5. An officer, (either British or U.S.) of the Allied Expeditionary Forces, designated "Prisoner of War Contact Officer", will arrive at each Prisoner of War Camp within seven (7) to ten (10) days of the cessation of hostilities.

EVERY PRISONER OF WAR WILL REMAIN IN HIS RESPECTIVE CAMP UNTIL THE ARRIVAL OF THIS PRISONER OF WAR CONTACT OFFICER.

6. The Camp Leader, having assumed command of the camp, will be responsible:
