# all-risk disaster **EVACUATION SIMULATIONS**

This is 80% of all vehicles within the selected evacuation region , departing over 15 minutes.



The worst-case scenario for a single vehicle evacuating under these conditions is **13H** 4M.

A typical vehicle may take 9H 3M. This estimate could vary by as much as 1H 21M. Long travel times are projected.

# **Texas Commission on Environmental Quality (TCEQ)**

1. **TexasEnviroHelp.** Small Business and Local Government Assistance Resources specifically tailored to help small businesses and local governments comply with environmental regulations. - 2. TCEQ is accepting applications under the Governmental Alternative Fuel Fleet (GAFF) Program. The GAFF Program will be providing an estimated \$3.9 million in grant funding to help government entities with 15 motor vehicles or more purchase or lease new vehicles that operate primarily on compressed natural gas, liquified natural gas, liquified petroleum gas (propane), hydrogen fuel cells, or electricity. - 3. Concrete Batch Plant Standard Permit Distance Limitations and Public Notice. TCEQ is seeking to withdraw a proposed amendment to *Chapter 116, Control of Air Pollution by Permits for New Construction or Modification.* The proposed amendment to §116.615(2) would have added language to require for any requested on-site movement of a concrete batch plant authorized by the Air Quality Standard Permit for Concrete Batch Plants, the owner or operator shall submit a new or amended registration and fee and comply with the public notice requirements, including the opportunity to request a contested case hearing, unless the new location is greater than 440 yards from any property line. The executive director has elected to cancel this rulemaking project to ensure any proposed rule language remains consistent with existing statute under Texas Health and Safety Code (THSC) §382.058(c) and further evaluate options for addressing this potential issue that were not included for consideration in the proposed rule.

4. Rule §330.647 Regional Solid Waste Management Plans Approval. This rulemaking will adopt in rule the 24 regional solid waste management plans developed by the COGs. Each regional solid waste management plan has been reviewed by TCEQ technical staff and attorneys. After technical review, the regional solid waste management plans were approved by Waste Permits Division management. Copies of the adopted regional solid waste management plans are available for public review on the commission's website at www.tceq.texas.gov/goto/wastegrant.

5. Municipal Solid Waste Landfills §111(d) State Plan and Rule Updates. On August 29, 2016, the EPA issued new emission guidelines (EG) for existing municipal solid waste landfills (MSWLF). On May 21, 2021, the EPA published a federal plan rule for MSWLF under 40 CFR Part 62, The current Texas state plan for existing MSWLF is implemented through regulations in 30 Texas Administrative Code (TAC) Chapter 113, Subchapter D, Division 1, and was approved by the EPA in 1999. 2016 EG. Rulemaking is needed to revise the Texas state plan and corresponding Chapter 113 MSWLF rules to conform to the EPA's 2016 EG. If adopted, this rulemaking will also allow MSWLF that are currently subject to EPA's Subpart OOO federal plan to instead comply with substantially equivalent state rules under the authority of the TCEQ, rather than the federal plan being administered by the EPA, after EPA approval of the revised state plan. The rules also include transitional language to establish when landfills would be required to begin complying with the new Division 6 rules. A separate §111(d) state plan document with supporting documentation has also been prepared for concurrent adoption with the rule changes to Chapter 113.

6. Amend Requirements Related to Advisory Committees and Advisory Groups. The rulemaking adoption will amend 30 TAC §5.3, Creation and Duration of Advisory Committees Created by the Commission, to provide that advisory committees created by the commission are to be abolished according to the requirements of TGC §2110.008 unless the advisory committee is required to remain in effect without abolishment under a state or federal law or a different date for abolishment is established under new 30 TAC §5.15. The rulemaking would create new §5.15, Duration of Advisory Committees, to establish the duration of advisory committees. New subsection (b) establishes an abolishment date of December 31, 2032, for the following advisory committees: the Water Utility Operator Licensing Advisory Committee, the Municipal Solid Waste Management and Resource Recovery Advisory Council, the Irrigator Advisory Council, the Concho River Watermaster Advisory Committee, the Rio Grande Watermaster Advisory Committee, the South Texas Watermaster Advisory Committee, and the Brazos Watermaster Advisory Committee.



# FEDERAL

1. Investments from EPA Under the Bipartisan Infrastructure Law

- a. Clean School Bus Investments *Houston Independent School District -* Total Awarded **\$6,225,000**. Over the next five years (FY 2022-2026) to replace existing school buses with zero-emission and low-emission models.
- **b.** Jones Road Ground Water Plume Total Provided \$722,700 in environmental remediation at Superfund National Priorities List sites and reinstates the Superfund chemical taxes, to address legacy pollution that harms the public health of communities and neighborhoods.
- c. Brownfields Multipurpose, Assessment, Revolving Loan Fund, and Cleanup Cooperative Agreements - Total Awarded \$500,000. The City of Houston's Brownfields Redevelopment Program works with qualified owners, developers, or potential developers by offering environmental site assessments to incentivize brownfields redevelopment. Program staff may help in determining the future path of properties once site assessments have been completed and provide technical assistance in applying for brownfields funding from other agencies. # 2. Per- and Polyfluoroalkyl Substances (PFAS).

Proposed PFAS National Primary Drinking Water Regulation. EPA announced the proposed National Primary Drinking Water Regulation (NPDWR) for six PFAS including perfluorooctanoic acid (PFOA), perfluorooctane sulfonic acid (PFOS), perfluorononanoic acid (PFNA), hexafluoropropylene oxide dimer acid (HFPO-DA, commonly known as *GenX Chemicals*), perfluorohexane sulfonic acid (PFHxS), and perfluorobutane sulfonic acid (PFBS). TEPA anticipates finalizing the regulation by the end of 2023. EPA expects that if fully implemented, the rule will prevent thousands of deaths and reduce tens of thousands of serious PFAS-attributable illnesses.

1. NEW: Amtrak Passenger Train Emergency Response (PTER) Program. In the event of an Amtrak train incident the program provides the liaison and coordination between passenger rail operations (Amtrak and Host Railroads), local First Responders (Fire, Law Enforcement, Medical, etc.), and provide an Amtrak resource for Local/State Emergency Management Agencies. The Amtrak PTER Program consists of providing pertinent information and training on railroad environment, emergency response operations, and Amtrak passenger railroad incident management procedures. The program outlines lessons learned from prior passenger train emergencies and identified the type of resources and incident management system required to efficiently manage, train, and exercise for passenger train incidents or emergencies. A PTER Handbook (PTER-H), Incident Field Guide, and our free no cost PTER Training provides a framework for local and state emergency management agencies, emergency response organizations, and public safety departments to be able to plan, prepare for, and respond to Amtrak train emergencies and rail incidents.
