BYLAW NO. 2023-05

LAGOON AND HAULER FEE BYLAW

A BYLAW OF THE RESORT VILLAGE OF TOBIN LAKE IN THE PROVINCE OF SASKATCHEWAN TO FIX THE RATE TO BE CHARGED FOR WASTEWATER SERVICE

The Council of The Resort Village of Tobin Lake in the Province of Saskatchewan enacts as follows:

1. TITLE

This bylaw may be cited as the Lagoon and Hauler Fee Bylaw.

2. FEES AND PENALTIES

- 1. The lagoon charges to be paid by every property owner within the Resort Village of Tobin Lake shall be those set forth in Schedule A attached to and forming part of this Bylaw.
- 2. The lagoon charges to be paid by every haul received from outside of the Resort Village of Tobin Lakes boundaries shall be those set forth in Schedule A attached to and forming part of this bylaw
- 3. The fee structure implemented is intended to address the costs of the debenture loan for the construction of the wastewater treatment system.
- 4. The lagoon charges shall be applied to each residential, commercial and agriculture titled parcel within the Resort Village of Tobin Lake, whether or not a building, structure or holding tank is situated on the property.
- 5. Lagoon billing shall occur once annually by the 30th of June to cover the costs of repayment in the given year.
- 6. The haulers shall supply the Village office with the RVTL- Lagoon Hauler Fee Quarterly Report, Schedule B attached to and forming part of this Bylaw, which will be made available to them by the administrator, on a quarterly basis along with full payment as set forth in Schedule C, RVTL Lagoon Hauler Procedures attached to and forming part of this bylaw.
- 7. The hauler charges are due and payable ten (10) days following the quarterly cut-off. Any unpaid amounts remaining outstanding after thirty (30) days from that date shall have a 2% penalty added, which shall compound monthly until paid in full.
- 8. As provided in The Municipalities Act, unpaid charges and any subsequent penalties that are owing with respect to a parcel may be added to the tax roll for that parcel.

3. COMING INTO FORCE

The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.

Bylaw 03-2020 is hereby repealed.

Schedule "B"

RVTL - LAGOON HAULER PROCEDURES

- 1. The Resort Village of Tobin Lake Council will determine which haulers will have the privilege of using the lagoon. The Council will inform the administrator, or village clerk, of the authorized haulers.
- Once a hauler has been authorized, the administrator will issue a key fob to open the gate to the
 village lagoon. The gate is to be opened when the hauler arrives with a load and is to be closed
 when the hauler leaves after that load. This is to prevent liability, damage, reporting, and
 wildlife issues.
- 3. Each load to the lagoon is based on truck tank capacity and on a per gallon rate of approximately .01 per gallon inside the resort boundaries or approximately .026 per gallon outside these boundaries. For example, a truck with a 1500 gallon tank capacity would have a fee of \$15.00 per load from inside the resort and a fee of \$40.00 outside the resort boundaries. Haulers who have trucks of different truck tank capacity report each truck on separate forms.
- 4. A high usage hauler from outside the resort boundaries, when the annual fee of \$150.00 is paid, would pay the \$15.00 per load rate instead of the \$40.00 rate for a 1500 gallon truck tank. To qualify for the high hauler rate, that client should average approximately SO loads to the lagoon per year. The high usage hauler should pay the annual fee by December 31 each year to receive this rate for the next calendar year. The administrator would inform the haulers who the high usage haulers were for that year, so that they would be charged that rate.
- 5. Haulers will have four quarterly reporting periods. Reports will be submitted for January to the end of March, April to the end of June, July to the end of September, and October to the end of December.
- 6. Haulers must have their Lagoon Hauler Quarterly Fee Report and Fee Reimbursement submitted to the Village Office on or before the 10th day of April, July, and October. January 10 will be for the last reporting quarter of the previous year. When the report is submitted, a receipt of billing is given, and payment made. Any adjustments will be billed separately. Penalties will be applied for any unpaid amounts for previous years.
- 7. The lagoon entrance may be monitored by camera for irregularities to lagoon policy or procedures. Council may cancel the authorization of a hauler to use the lagoon. When the hauler decides to no longer use the lagoon, or loses Council authorization, the entrance fob must be returned. Unauthorized usage will be considered trespassing.
- 8. These procedures are to provide some clarity and to help with the efficient use of the lagoon. Procedures may be altered, and haulers would be notified.
