- 1. EMS/Ambulance Committee: Chief Watkins/Chief Dolson no Report
- 2. OAC: Chief Walder / OES Chief Zander
 - Chief Walder Strike Team Leader refresher training will be scheduled May. Also, on the regional level, reported that this year's deliverables were being finalized for distribution.
 - OES Chief Zander reminded everyone that the information on CFIRS needs to be updated. In the process of purchasing 3 Type 3 engines. Informed the group that www.Healingourown.org is a good resource for firefighters.
- 3. Operation/Training: Chief Nelson
 - Training chiefs have not met since last meeting.
 - Next regional exercise RT130 is being scheduled in May.
 - Chief Lauchner reported that the Hazmat IC and Hazmat Specialist F & G are being hosted by Roseville FD April and May.
 - CALFIRE will host the next Officer Training in June.
 - Arson Investigation: Chief Flower No report
- 4. Fire Prevention: Chief Higgins
 - Sac Regional announced Fire Investigator 2A is scheduled April 4th 6th; 2B is scheduled May 14th 18th. Roseville FD will be hosting.
 - Chief Walder reported that the investigator classes offered in April and May will be the last two offerings of the two classes before the new requirements take effect.

5. Sierra College Advisory: Chief Palmer

- Thanked Chief Morris for the Chief's Address at the Fire Academy graduation.
- Next Advisory meeting was scheduled on Tuesday, March 13th, 0900 at Sierra College, 316 Vernon.
- Chief Ruffcorn plans to retire December 31, 2018.
- Current Fire academy has 33 students, and the Nevada County Fire Academy has started with 10 students.
- Steering Committee met in January and last week.
- Facility Master Plan update Bond initiative Measure E is on the ballot, which will help fund needed repair/changes to the Sierra College campus.

6. IMT: Chief Estes, Chief Mathias

- Chief Estes reported that a draft of the team operational manual was sent it to Chief Bartee and Chief James for review. Met with the ICs from Sac Regional IMT regarding operations, will follow-up in the next couple of weeks, and will come back with more information.
- Chief Mathias reported that the IMT Trailer is moving along slowly, hope to have it here next month. Reminded the group that the 305 Class still a good class for agencies to take. OES has \$15,000 available to assist with the costs, which will need to be spent by February, 2019. Dates for the class are still be finalized. Would like to confirm the Rocklin Community Center for the class. Will work towards sometime in June.

7. Communications/CAD:

- Chief Pierson reported CALFIRE side has turned in their radio loads. Will have more information at the next Chief's meeting
- Chief Walder reported that Placer Co CAD will be switch over to the new CAD June 8th.

8. Grants: Rod Rodriguez

- Grant year 2017 was approved, 2018 is in process and won't have final word on that grant until early fall.
- Grant year 2019 is moving forward, start submitting white paper through Chief Bartee.
- John McEldowney reminded everyone that if the Feds move to the 25% match, agencies should include on their white paper, that they are able to meet the 25% matching requirement. Distributed Total Resources by Agency spreadsheet for the group to review. The County is looking for as listing the resources for each agency. Open for suggestions, if agency has information in another format send that to John. EOC tabletop exercise scheduled beginning of May.

9. Tree Mortality Task Force Update – John McEldowney
