DIVISION REPORTS (brief reports)

1. EMS/Ambulance/SSV: John Poland and Gabe Cruz

APOT – John Poland

- a. Shared update from County including adding paramedics with a nasal cannula for transporting patients.
- b. 911 response time policy is being updated (no changes to Placer County).
- c. Brittany recently emailed a QIP to EMS providers, due end of March.
- d. 2023 Regional training is a month out and will be replacing 2022 list from website.
- e. EMS update for ALS agencies, staff will be completing 3.5 nemesis version (3.4 is not accepted with PCR vendor).
- f. BLS update includes regular changes to complete the patient care report then submitted to nemesis. State is monitoring the BLS requests to complete the care form.
- g. Advanced airway update includes purchase request for review of success rate of date from RSV. Currently RSV in trial 100%.
- h. ImageTrend trouble shooting meeting scheduled March 22nd to discuss patient care information on tablet.

AMR – Gabe Cruz

- a. Shared staffing is at full-staff.
- b. 4-5 new ambulances with AWD distributed soon.
- c. South Placer new airway class at Rocklin facility (MEDs program). ImageTrend is integrating PCR platform.

2. OAC: Chief Spencer

- a. XPL STEN Refresher class scheduled for end of April and will include information on Single Resource orders.

- b. Placer dispatch IROC training was provided for 5 dispatchers. A refresher will be provided as the season gets closer.
3. Operation/Training: Chief Lauchner
 - Training challenges discussed. Three sub-committee's have been established for EMS, Training, and Interoperability.
 - The Fire Rescue Mutual Aid document draft will be discussed during closed session.
4. Fire Prevention/Fire Investigations: Chief Rizzi (RSV) and Chief Brayton (ROK)

Chief Rizzi –

 - Shared that the State Fire Marshal's office has requested jurisdictions requesting State Fire Marshal inspections, be submit by January 1st.
 - Kaiser is breaking ground for a 6-story addition in the next couple of months as well as a 5-story parking garage.

Chief Brayton –

 - Fire training available at the Cocker building (located in Rocklin at Pacific and Grove) that includes a 5,000 ft building with arch roof and breakout rooms. ROK BC Molinaro will be reaching out to allied agencies to schedule. Goal is 2-day burn with full extinguishment
 - Training opportunity to schedule with regional partners for truck time. Sign ups will be available to cut on the building. Date projected for training is after March 16th. Currently, the owner of the property is working on a few requirements to be completed by March 16th.
 - Training for Fire Inspector II series and the possibility of ROK hosting investigation training for 1A, 1B, and 1C.
 - Currently looking for executive team members for Investigations.
5. Sierra College Advisory: Jason Hemler – Not present, no report.
6. Communications/CAD: Chief Harrigan
 - Dispatch study is up and running and currently getting interoperability for further discussion on the 5 dispatch centers that include closest resource and the mutual aid agreement that is in review.
 - The first meeting is scheduled on February 27th and meeting every odd month.
 - Chief Bartee requested to respond to email requests for dispatch center.
 - Chief Williams shared AP Triton interview occurred this week with ROK dispatch regarding dispatch center.
 - Chief Alves shared that relationship with BK radios has ceased and moving to Motorola system (APX 10000).
 - Chief Feeley added South Placer took the lead for a grant for request for portable radios for multi-agencies. Grant was submitted in mid-February.
7. Placer Co. OEM/HSGP: Chief Estes
 - Shared the OES report is currently a Level 3 with PCSO and OES County Fire.
 - World Cup at Palisades Tahoe this weekend is expecting 22k in attendance.
 - A new model is requested for permanent staffing. Currently, a unified command has been in place as of March 2020.
 - Joint meeting suggested with Lake Tahoe Regional Fire Chiefs Association 1-2 times a year. Next meeting projected for April 18th possibly hosted at Alta Station or Tahoe area. At the same meeting, possibility for further discussion regarding Assistance by Hire and LAFCO to be discussed. Currently, the Association has a local agreement outside of the OES standard order.

- Additionally, the grand opening of the Venue in Lincoln went well overall and there will be a truck committed to the upcoming shows.
- Chief Bartee added an email came from Chief Atkinson regarding the Mosquito rebuild and cleanup. The Placer OES new POC for EOP updates is Dominic Cooper.

GOOD OF THE ORDER

- Chief Bartee Roseville station 8 is expected to break ground in April. Engine 8 will hopefully be in service next January. An engine and truck are ordered with Pierce. Station 8 will also include a task force for cancer prevention with cancer reducing clean rooms. Roseville Fire and Police will be adding a Type I command van staffed by PD. Once available, Roseville will do some testing and demonstration.
- Chief Williams Rocklin roundabout project is complete at the intersection of Pacific Street and Rocklin Road. Request for RSV truck company and T77 to drive through roundabout and advise of any issues. AMR has been able to navigate without any concerns. Additionally, ROK will be recruiting three new firefighters and 2-3 additional. Testing to begin in March/April for FF and Lateral FF/P. Two command vehicles are going in to service soon and are currently at Lehr. ROK's Foam tender is currently out of service.
- Chief Alves Lincoln reported that Firefighter positions have been filled and currently running 3-0 staffing (at minimum staffing) Recently, promotions occurred for BC and Captain that created Engineer vacancies. Chief interviews are scheduled for next week.
- Chief Matcham Captain promotion testing will be coming available in Foresthill with internal and external testing in mid-April. Currently, Foresthill has a new part-time Assistant Chief who will oversee training and prevention. Foresthill will be going to Board of Directors to request to purchase a Type 3. Additionally, a new command vehicle that will need radio programming was donated by Placer County.
- Chief Spencer Preparation for the National Wildfire Awareness and Prevention weekend at the Auburn fairgrounds is in process and advertising will be coming soon.
- Chief Harrigan Special ops Type 1 teams for lab grade regarding fentanyl to start this summer working with Placer County jail.
- Chief Lauchner Roseville recruitment is open with a goal of 20 new hires with the opening of Station 8. BC testing will be in March, Engineer testing in April and Captain testing in May.
- Chief Fionan Sac Metro academy started smaller than expected with 15 that started and 13 are currently completing the academy.
- Chief Mackwood Placer County FD is upstaffing units with additional engines in Nevada County. Chief crew levels are available. Standards of Cover with AP Triton to begin. Grants in process for new contract and master plan addition.
- Nicole Paskey Placer Hills has a conditional offer for Captain. All 3 Districts staffed. INFERS training will be hosted in Placer Hills/Penn Valley/Penryn in March (3/23 – 24) that will be provided for free for coding accurately.

Gabe Cruz AMR joined team in Sacramento to reflect on counties improving together. Additionally, AMR is attending monthly meetings with Kaiser regarding interim options for overcrowded ER and long-term solutions.

Brent Strangeland Added PG&E is proactive with current storms and their EOC has been moved to Vacaville that is currently staffed as of Sunday and tied in with OES. Additionally, the OEC-Office Emergency Center is currently staffed with crews.
