COMMITTEE REPORTS (brief reports)

- 1. <u>EMS/Ambulance Committee: Chief Watkins/Chief Dolson</u> Chief Dolson – No report.
- 2. OAC: Chief Higgins
 - Deployments to Red Bank. After two days demobed and reassigned to Lime Fire. 4125 transferred to Lime lodging was an issue. Reimbursements for hotels have been authorized with "S" numbers.
 - Rainbow Strike Team with Brush 9 and trainee to Swedes Incident. After 24 hours demobed.
 - Region IV, Chief Walder-16 type 3 strike teams with 20 overhead out of region IV. In the
 process of demobilization at all fires.
- 3. Operation/Training: Chief James; Arson Investigation: Chief Fowler
 - Ops Training Group met discussed PIA. Discussion regarding heat and fatigue well ness for training. Material coming out regarding proper hydration.
 - SOG's for commercial structure fires has created working Committee with help from Auburn Fire. Google doc created and will give access to everyone.
 - Training Cadres for 3rd quarter hosted by Roseville late October. 4th quarter at South Placer. 1st quarter of 2020 at Auburn for Active shooter.
 - Discussion regarding CRA moving forward to a working committee to discuss central fire command center and creating a heat map of Placer County based on call volume. Goal is to have better move up and cover plan – still in beginning stage and will bring issue back later.
 - Chief James to step down after this year-rotate lead each year.
 - SCBA grant purchase received and in-service training group working on regional training.
 - Chief Bartee Rescue Task Force SOG's will be emailed to group, signed and placed on the website.
 - Arson Investigation; Chief Pote- Arson Task Force looking for instructors for fire investigations

- Many issues with transient fires and will be working with LE regarding issues with breakins at structure fires.
- End of year: new chairperson- start of January.
- 4. Fire Prevention: Chief Higgins
 - 2019 fire code adoptions out agencies should order books now and start working to adopt and get new fire code ratified. Need to be into the County by February.
 - Chief Estes- Fire prevention event held at the demonstration building at the Gold County Fair at the Auburn Fairgrounds recently.
- 5. Sierra College Advisory: Chief Palmer
 - Looking for a guest speaker for the Academy Graduation on Dec. 15th.
 - Fire Advisory Board meeting Oct. 2 from 9 to 12.
 - Firefighter I and II changes presented at NV County Chiefs are moving forward for approval; Fire Directors meet on the 18th to discuss college curriculum.
 - Starting 1/1/2020 Firefighter I hours reduces to 308 hours
 - CID process changes include CO officer degree and certificate of achievement available.
- 6. IMT: Chief James, Chief Webb
 - Chief Walder- need to change role to IST and reevaluate the value. Need to schedule training hours to move forward.
 - Chief Estes concern that same people on team committed to incident. Need for ancillary support. Trailer needs to be repurposed into incident support for logistics and planning- will bring back plan for additional information to upgrade the trailer.
 - Need to complete the roster and get interested employee's education and experience.
- 7. <u>Communications/CAD: Chief Diemer</u> CAD to CAD
 - Four Meetings held. Next meeting in October to discuss moving forward to active phase then back with recommendations to discuss.
 - CAD to CAD can reduce the workflow on dispatchers when used properly.
- 8. <u>Grants: Rod Rodriguez</u>
 - Holly Powers Homeland Security grant performance period up in May 2020. Need to expend \$25,000 remaining funds soon prioritizing training or equipment. Funds may be spent on Emergency Management or Company Officer training as long as it's done as multi-agency.
 - FY 18 on track, FY 19 in applications with approval pending. FY 20 white papers due last month but flex period pre-application extends to January 2020.
 - Homeland Sec. Grants put into excel spreadsheet with each year allocated a tab for a quick glance to see grants and status.
 - Rod sent FEMA & FMA & Flood Mitigation Assistance Grant out now with NOI due Sept. 18th. Must have mitigation plan to apply.
 - Five-year update for Placer County Mitigation Plan in progress.
- 9. Emergency Management Working Group- Holly Powers
 - Program Manager now in 2nd interviews with two candidates.
 - PSPS portal for PG&E avail- email portal to get access,
 - NDA for medical baseline done with PG&E directly Placer County has no access
 - Non-Account Holder Alert by zip code available for non-owners
 - Possible grant funding for Multi-agency IMT/IST to leverage available funding.
 - 1st meeting for EM Group upcoming- primary function is EOP progress.
 - Rolled out "Ready Placer" a week ago with handout materials/flyers in progress.
