Mosting was called to order at 9:45 A.M. by Chairman McCartney and visitors welcomed.

Minutes of Dec. 3rd meeting were read and approved. Correspondence relating power line extensions on State highways was reviewed and filed. Notice relative to the establishment of two Gooperative Electric associations serving Counties of Alachua, Bradford, Glay, Putnam, Union, Sumter, Leke, Marion and Hermando with allotment of \$435,000 of R.E.A. funds was for the building of 322 miles of line together with power plants, was read and discussed. Some of the Communication Companies were concerned as to the character of the lines that will be built. It was thought that the R.E.A. would require rigid construction standards, however, there was still doubt as to their being maintained and regarding right-of-ways, especially where one side of the highway was already occupied by private Power Companies. The Secretary was instructed to write each of these organizations requesting them to keep this Committee advised as to route construction and extensions so proper coordinating methods may be worked out to the mutual advantage of all.

The State Road Dept. representatives stated they could not be arbitrary in refusing right-of-way permits solely upon objections of other wire using companies. It was brought out that as the Florida Railroad Gomadssion has control over quality of service rendered by Communication Companies, they may be able to discourage such type of construction that would impair communication service.

The interference mar Bonita Springs between Florida Power & Light Company's circuits and Inter County Tel. & Tel. Co. Ft. Myers-Mismi circuits was reported improved, however, Mr. Williams stated more corrective measures were planned.

Beautification of highways and the effect of trees under Power & Light and telephone lines was discussed with Messrs. Dowling and Stewart of the State Hoad Department. The Committe was informed the Read Dept. has jurisdiction over the planting of trees and shrubs on highways and in order that the public in general may understand this Mr. Dowling is to give the Associated Press that information so that more complete control may be obtained.

The matter of tall Washingtonians or other palms which cannot be satisfactorily trimmed, interferring with wire lines was discussed. This condition on state roads according to Mr. Dowling can be corrected if the Road Department is consulted and arrangements made for replanting a substitute tree or plant. The State Highway Planning Engineer is available for consultation when necessary.

Mr. Stewart stated that Mr. Harry Lee Baker, State Forester, could very likely be of help to the wire companies in arranging for clearences.

Mr. Dowling made the request that all right-of-way matters be routed thru their Division Engineers in order to save time in the approval of construction requests. He is to prepare a map showing the boundaries of Divisions within the State and send copies to all members. Division Engineers are located at Lakeland, Jacksonville, Miami, Lake City and Chipley.

It was world to bold the next meeting at Goala on Friday, May 13th, it being thought the second Friday in the month more suitable than first Friday.
