### NEW BUSINESS

State Road Department of Florida - "Short Form"

An agenda is being added to the short form by rubber stamp at the present as follows:

"Applicant declares that prior to the filing of this Application

he has ascertained the location of all existing utilities, both aerial and underground and states that due notice of the work under application was furnished each other utility involved, and attaches copies of letters addressed to said users."

Kindly send the Secretary copies of these letters and replies.

- Mr. Stanley Warth, Southern Bell Tel & Tel Company, advises that in the case of Joint use contracts, with other utilities, the State Road Department is requiring that a notice be given to them for the stringing of wire on Joint use poles, and the utility or the Cooperative is to give this notice to the State Road Department.
- Mr. Warth advised that the matter had been handled with the State Road Department, and a letter is being requested from the utilities advising the State Road Department that they have Joint Use Agreements; by this method it is hoped that an individual notice of each installation can be eliminated. Also Mr. Warth stated a case of where Joint Use Agreement was in effect, and where the utility installations were on private property, the utility is refusing to give notice to the State Road Department, and

Mr. Warth wanted to know if others had encountered this condition, and what did they do about it.

Mr. R. S. Davis entered the meeting about this time and every one was glad to see "Red" make his appearance.

It has come to the attention of the Southern Bell Tel and Tel Company, that the Mars TV Company, Daytona, has received a franchise from the city to construct a community Antenna Service, and it proposed to use the utility and telephone poles for this service. The Southern Bell have been approached for a joint agreement of this nature, and the committee was advised that they have not, at this time, entered into any agreements of this kind.

Mr. W. R. Irey and Mr. W. D. Hogan of the Dupont Company, showed film and stills of the progress being made on Brush Control, over a one, two and three year period. The talk by Mr. Hogan was very interesting and enlightening, and was enjoyed by all. Mr. Hogan advised that he would be glad to answer any questions either by personal contact or by mail, his address is 1027 Nottingham Avenue, Orlando, Florida. The committee thanked both Mr. Ivey and Mr. Hogan for the information given.
