Opening Invocation & Tribute to Flag

Chairman Kris Hayes called the FUCC Business Meeting to order shortly after 9:00 am. The chairman introduced himself and the other FUCC officers. Next, Kris welcomed everyone, recognized the importance of our sponsors and gave some opening remarks. The chairman then proceeded with the invocation given by Robb Brown and the tribute to the US flag.

Reading of the Minutes – Robb Brown

The chairman then requested the Secretary to read the previous meeting minutes. Vice Chair Jodi Rano spared the group from the agency of hearing the minutes being read

and made a motion to approve the minutes as posted on the web-site. And seconded by Sandra Panos that the reading of the complete minutes be waived. Motion Passed.

Since 1932, records in the FUCC archives have been kept in the format of 4 meetings per year — even generally on the same weeks of the year! Even during World War 2!! To set a new precedent, and to bore you young folks out there who don't enjoy history as much as we "old souls" do, I will compile the forthcoming April meeting Historian reports from combining the February and May minutes of coordinating past.

Yes, that's right – take a huge slash of coffee as you are about to get SIX reports instead of THREE for this meeting. You can thank me later for the early Christmas present.

75 years ago (Part 1):

February 14, 1941, Tampa, Florida (site location unknown).

Chairman Stanley Warth of Southern Bell Telephone & Telegraph Company presiding, H.V. Street of Florida Power & Light was Secretary.

- 22 people in attendance
- 10 Telephone
- 4 REA (Rural Electrification Administration Electric Co-ops)
- 3 Power
- 2 Telegraph
- 1 each from Railroad, Florida Railroad Commission, and State Road Department

Topics discussed:

- Mr. Linhard of the Florida Railroad Commission read a letter from the Bureau of Standards relative to the
 revision of the Safety Code for covering crossing specifications. The revision will be delayed and the
 FUCC voted to give their full support to the commission on this endeavor.
- Mr. Williams of Inter County Telephone and Telegraph complained the Lee County Cooperative had
 constructed a line from Ft. Myers to Pine Island that would materially affect his operations. A
 subcommittee was appointed to view the case and will report their findings at the next meeting.

75 years ago (Part 2):

May 16, 1941, San Juan Hotel, Orlando, Florida (site location unknown).

Chairman Stanley Warth of Southern Bell Telephone & Telegraph Company presiding, S.O. Newsome of Riverside Telephone was Vice Chairman, and H.V. Street of Florida Power & Light was Secretary.

- 13 Power

- 3 Telegraph

- 1 each from Florida Railroad Commission, a consultant, and State Road Department

Topics discussed:

R.W. Shriner of the Peninsular Telephone Company had been appointed chair of the subcommittee
reviewing the case of inductive interference between REAs and telephone companies but had been called
in to Naval Service. R.S. Davis reported on the Pine Island case, where Lee County Co-op ran power lines
from Ft. Myers to Pine Island crossing the road seven times in fifteen miles. K.H. Williams of Inter-County
Telephone & Telegraph Company was still not happy and requested that the appointed subcommittee

inspect the project. Chairman Warth appointed W.F. Girtman of Florida Telephone Company to replace Mr. Shriner on the subcommittee and requested them to report back at the next meeting on the conflict.

• W.T. Smith, Technical Standards Division, REA, Washington DC spoke on the REA and the inductive influence of power lines on telephone and telegraph lines.

50 years ago (Part 1):

February 11, 1966, Tampa-Sheraton Motor Inn, Tampa, Florida

Chairman W. V. Bottorff of Gulf Telephone Company presiding, J.M. Tinsley of Southern Bell Telephone & Telegraph was Vice-Chairman, and H.D. Broome of Tampa Electric was Secretary. Hotel rates were \$10 single and \$12 double – members were advised to "Beware of Pirates!" as the meeting coincided with the Gasparilla Festival.

- Mr. Broome and E.M. Salley reported on the proposed revisions to the Policy and Procedure Memorandum 30-4.
- Due to the complexity of the Accommodations Guide, the subcommittee has been increased in order to represent all utilities.
- Interesting notes: "Words of Wisdom' Stanley Warth (the Chairman from 25 years prior) was in fine form and made several encouraging remarks to the Committee." "The One and Only' Red Davis was getting along fine". "It was reported that Mr. Gray Davis was 'too busy' to attend."

- E.M. Salley of the State Road Department reported on the revisions of the PPM 30-4 (utility relocations and adjustments). The points of interest made were that the Bureau of Public Roads has a backlog to review, the Civil Rights Clause must be included in all Federal Aid Project Agreements, the depreciation problem is being considered, the revisions should be complete by June and reported at the Denver meeting.
- Verne Brown of General Telephone Company was selected as chairman of the Accommodation Guide Subcommittee.
- Mr. "Words of Wisdom" Stanley Warth told a story of the golfer and the ants that left the message of get on the ball. The story was well taken and enjoyed. After some Googling, the story goes essentially like this:

"Once there was a golfer whose drive landed on an anthill. Rather than move the ball, he decided to hit it where it lay. He gave a mighty swing.

He was acknowledged as someone who believed in, and practiced the 4 C's; Coordination, Cooperation, Communication and the all important Commitment.")

- Treasurer's Report \$397.57, registration \$5. November meeting room and audio equipment rental wiped out \$978 and the meeting only brought in \$405!
- FDOT Update by Paul Kaczorowski (still can't pronounce it), who distributed a list of 4 training courses: Training, UAG, Changes in Forms and Procedures, Utility Poles Safety Program.
- Mr. Jim Taylor of Maglev Transit, Inc. presented the soon to be (never) constructed magnetic levitation rail system scheduled to be built between Orlando International Airport and International Drive. The route was proposed to be 13.2 miles, cost \$600 million (all private funding), and begin construction in January 1992. The fare was projected to be \$15 per person. The project was eventually scrapped in 1997 after the early-90s recession in Japan eliminated a major source of investment.
- Mr. Scott Sidney of Lee County Electric Co-op presented a video on the Transfer of Joint Use Attachments, prepared by LCEC, United Telephone, and Cablevision Industries. It took 50 years but apparently LCEC and the telephone company differences from 1941's report!

- The Steering Subcommittee listed the meeting locations through the end of 1992 to be in Pensacola, Daytona, Ft. Lauderdale, Tallahassee, Tampa, St. Augustine, and Miami.
