Please note there are two different types of Lump Sum. – tell us what they are and how to invoice them.

#### FDOT's Concern:

Old Poles: When new poles are placed, please do what you need to do with your joint pole user to have the old poles removed.

Please ensure the cable company has transferred to your new pole, per your contract with them.

Whether you are there by permit or by rule, the Power Co is responsible to remove the pole and schedule your joint pole users to move so you can meet the schedule. You can show this in your Utility Work Schedule as well.

You cannot transfer ownership of a pole within the DOT right of way. So even if they fail to transfer, you are still the owner.

#### Street Lighting:

Many of the local municipalities are informing the power companies that they will no longer maintain lighting along State roads. Hillsborough County in D-7 states that as of 6-1-2017 they will no longer maintain state lighting. How is the Department handling this issue?

<u>Attendees</u>: Scott Baird (FUCC Vice-Chair), Brian Dean (FUCC Co-Treasurer?), Chris McLaughlin (FUCC Historian), & Mike Hamlin (Steering Subcommittee Sewer Rep – via phone)

<u>Minutes</u>: Referring to the last approved version of the By-Laws from 2/5/2015 and the compiled comments in the time since, plus Mike & Brian's comments the following items were discussed:

- 1. Section 6, Item 3 (Vacancies and Nominations): clarify and revise the confusion regarding nominating incoming Secretary. Refer nomination and election tasks to a central Section.
- 2. Section 3, Item 1 (Purpose): Should UAO be expanded to include consultants to catch up with modern contracting of staff? How do FUCC members feel about utilities having influence diluted.
- 3. Section 3, Item 3 (local UG/Liaison partnership): Should FUCC increase its partnering and can it given that many UGs are hosted by FDOT?
- 4. Section 4 (Membership), Section 11 (Meetings), & Section 12 (Action by the Committee): should these be combined into a section called "Organization"?
- 5. Section 5 (Fees & Sponsorships): Consider revising this and converting to Corporate Membership since FDOT can't take part in sponsored activities.
- 6. Section 6 (Officers) and Section 7 (Duties of Officers): Combine these sections and refer arbitrary duties to the Officer Duties ByLaws Appendix for a single reference document of responsibilities.
- 7. Section 8, Item 2 (Steering Subcommittee):
  - Should Interest Group Chairs fill Steering Spots for their industry? If so, this will necessitate revisions for both throughout.
  - Define or remove "term" in Item 2 since it is further defined in Item 2a.
  - Should we combine Telephone & Cable TV into "Telecom" now that the industries have overlapping services?
  - Should we delete Governmental Non-Utility (FDOT) & Public Service Commission?
  - Create a table of Steering Subcommittee members, add Interest Group chairs and Committee officers.
- 8. Section 8, Item 3 (Awards/Nominations Subcommittee):
  - Include a 4-year employment commitment requirement.
  - Clarify where the list of potential candidates for officer positions goes to.
- 9. Section 8, Item 4 (Programs Subcommittee):
  - Include Interest Group presentations.
  - Include all FUCC officers in helping to arrange programs and speakers.
- 10. Section 8, Item 5&6 (Conference Planning & Membership/Promotions Subcommittees):
  - Who collects money?
- 11. Section 8 & 10 (Subcommittees): Combine these sections.
- 12. Section 12, Item 2 (Contested votes): This item should be revised for clarity.

<u>Key Takeaways</u>: FUCC needs to address the changing industry dynamics by involving consultants who work on behalf of utilities, but how are they classified? We need to review in detail membership & voting privileges, reform nominations & actions, and the purpose of FUCC. Section 12 contains some confusing voting specifics, removing the separation between Associate Members and Members would fix this.

# November 7-9, 2017 FUCC Historian's Report Jacksonville (fall) Meeting, DoubleTree Jacksonville Riverfront 1201 Riverplace Blvd., Jacksonville, Florida Chris McLaughlin, Historian

#### 75 years ago:

November 13, 1942, Floridian Hotel, Tallahassee, Florida.

B.A. Galloway of Winter Park Telephone Co. was Chair, Wilkins Linhart of Florida Railroad Commission was Vice-Chair, and R.S. Davis of Florida Power & Light was Secretary.

14 people in attendance, no breakdown of attendees by utility was given.

#### Topics discussed:

- Under the order of old business, the Subcommittee appointed to meet with the members and Staff of the Florida Railroad Commission to unify the crossing specifications, reported through Subcommitteemen Terrel and Warth that the meetings of September 23rd and November 12th were entirely successful, due substantially to the fine cooperation of Messrs. Green and Girtman. It was reported that the Railroad Commission had accepted the revisions of part 1, governing the construction and maintenance of telegraph, telephone and other communication lines, crossing the tracks of steam railroads and that the revised specifications will be issued in due time. The part 2, governing the construction and maintenance of electric light and power lines crossing tracks of steam railroads, is to be revised at a time more convenient to the Commission. In the interim, it has been suggested that the National Electric Safety Code, U.S. Bureau of Standards, specifications be followed, since the revision of part 2 will conform to the NESC Standards.
- Mr. Galloway directed that the Secretary remove members from the roster that are serving in the Armed Forces and their successors placed on the list.
- Mr. Warth suggested that the names of District and Maintenance Engineers of the State Road
  Department and others of similar capacity with Rail, Power, Communication and Public Services
  be sent into the Secretary, in order that they be especially invited to attend our meetings when
  and as held in their district.
- Mr. J.H. Dowling, State Highway Engineer explained at length the very high standing of Florida among the states having a comprehensive program of highway beautification. He stated several regrettable instances had been recently called to his attention, where trees had been butchered or at least improperly trimmed by workmen.
- Mr. Stanley Warth stated that the matter of transportation being as serious as it now was, some
  members had suggested the Committee should meet less frequently. The suggestion did not
  meet with general agreement, since more argued that matters of importance continually
  coming to the attention of the Committee should not wait.

#### <u>Topics discussed:</u>

- Brad Shepard reported on the activities of the safety requirements and the Accommodation Guide Subcommittees.
- Everett Thompson, SRD reported that Mr. Salley had called and advised him that there would be
  a meeting called around the 15th of November to try to finalize the Accommodation Guide. The
  Subcommittee of the FUCC will be invited to the meeting. Chairman Tinsley re-appointed the
  Accommodation Guide Subcommittee.
- Bob Traxler, Gulf Power Company reported that the Eastern Railroad Presidents Conference had adopted new rate charges to be imposed with respect to crossing permits and encroachments on railroad property. Some of these charges are quite high and they don't seem to be consistent.

#### 25 years ago:

#### **Topics discussed:**

- Treasurer's Report \$363.25, registration \$5. Coffee, tax, and gratuity (\$234.24) were the expenses.
- FDOT Update by Jerry Sasser. Mr. Sasser discussed the Utility Accommodations Guide (UAG). Agreement had been made with the FUCC UAG Subcommittee on how the Guide was to look. FDOT had selected separate colors for CATV and reclaimed water to be included in their CAD system. The colors selected were violet for CATV and brown for reclaimed water. He suggested UAOs to keep updated libraries of FDOT maps and publications because of the many changes and new issues of the indices, standards, etc. FDOT was increasing their use of directional boring and asked UAOs to send him lists of preferred, qualified contractors they have used. Metric conversion was discussed, including concerns of conversions with land descriptions, manuals, UAG, MUTCD, and FDOT work zones. Chair Sweet requested that the FUCC be notified at least 30 days prior to any publication changes to the UAG to allow for review, comment, and reply.
- Guest speaker John Shelton of Shelton Enterprises, Inc. He was the founder of "Miss Utility" (the 3<sup>rd</sup> One Call System in existence), a co-founder of the APWA-ULCC and operated UNCLE and

CALL CANDY in Florida. Mr. Shelton recognized Historian Duggar for his involvement in deploying One Call Systems in the 4 county area surrounding Tallahassee.

  - D7 163 people attending, Nick Zambillas took early retirement to work in private consulting with the Tri-Duct Corporation. Steven J. Tidwell, the namesake of the golf tournament won by MacSurvey's team for the past 3 of 4 D7 Liaison meetings would be the new DUE.
  - Turnpike preliminary design of SR417 between I4 and US 17/92 was underway.
- The Steering Subcommittee was discussed members were reminded that all interested parties
  were welcome and invited to attend the meetings and to bring matters of general concern up
  for discussion. Voting on all matters is limited to the Steering Subcommittee members, and all
  voting members should attend as well as all active subcommittee chairs as referenced in the
  Bylaws.

The CEI is not responsible for correcting the conflict only to the point of identifying an issue then working with either the roadway contractor or supporting consulting firm to help resolve the identified conflict during const. Tom & Shawn of the FDOT advised there will be a specific process labeled & distributed in 2019 throughout the districts to have consistency with the CEI process.
- Mast Arms: Reviewed a presentation from Greg Coker of FPL that showed the typical concerns/conflicts of working near energized lines & the process of utilizing a telehandler that has been successful in a few projects he has been involved with. The Telehandler enabled the site contractor/s to perform the work without needing the lines to be energized, that piece of equip is able to work under energized power lines (exempt from the under energized power lines OSHA rule) & not encroach the 10' clearances. He asked the group to continue to solicit the use of this low profile construction process and send him any success stories & pictures of projects that utilized the equipment. He also showed a shaft drilling piece of equip that was low profile that was able to dig the support shaft without needing the lines de-energized. The goal is to have enough physical examples of the use of low profile equipment for mast arm work & be able to present that info to the FDOT that this is a construction method that works & lessens the need for the utilities to be involved which speeds up the construction of the mast arms.
- Hurricane Restoration: Garrett Peterson of FPL shared restoration effort results from Hurricane Irma with comparisons to Hurricane Wilma from 2005. Also discussed the level of success was possible in a large part due to the storm hardening of our distribution facilities throughout our service territory. There was some minor discussion on our hardening standards concerning pole replacements/size.

- Street Light Concerns: Rob Morris of FPL with support of Alan Boaz from the Wantman Group discussed the concerns with the new FDOT lighting standards especially at intersections. The updated standards have been active for close to a year & there's not a good understanding of the specifics & how it will affect the utilities. What's known at this point is there's an increase of lighting required at intersections & along the roadway for a certain footage amount either way from the intersection. We realize this increase & upgrade of lighting will have an effect on the utilities facilities in some cases. To follow up We will have a presentation at the spring PIG meeting to discuss the specifics of the new standards & how they will affect the utilities. There was a question to the FDOT if they knew if the voltage for 480 lights would remain once changed to LED & they answered can remain as 480 volts.
- **UES/UWS Forms:** This was to ask the group if the new forms created any issues. No comments were given that stated any issues. Didn't go into any other discussion of either form.
- Round Table: No discussion came up at this point of the meeting, we had taken all the time allotted with our agenda items.

#### **Telecom Interest Group Meeting Minutes**

Attendees – 12

Fred opens meeting, asked for topics and introductions

Fred – Hillsborough County (UAG) says Utilities would pay for relocation/adjustments for water line placement. Hillsborough County permit language was revised to include the means of requiring other utilities to relocate at their own expense.

Tom asked how they did this? Ordinance, Law, etc.?

General discussion about utility locations, re-imbursement, etc. and similar examples of having to move MH systems and steps taken to prevent it.

No other utility reps that work in Hillsborough County were present.

Discussion included costs of relocating a MH system vs moving proposed water line.

Referred to old business to keep discussion going - PSEE, records retention by FDOT..

Fred asked if anyone used the new UAM? Bruce said yes, but it isn't an improvement.

Jan asked about CAF II \$\$ in FL. None for Frontier; None for CTL (David)

Talked about storm recovery, etc. Jan asked about D-1 projects coming up. No one has anything on it. Talked about overpasses being railway compliant. Talked about divergent diamond; Jan said it was successful.

Roundabouts also discussed. No boring under roundabout; no pole in roundabout.

Lake County roundabout per David.

Jan talked about wetland permitting. Exemptions size on size. No blanket exemptions for repairs from Corps of Engineers. Permits required for upsizing, etc.

Length of time to get Corps of Engineers permit is too long, 24 months. Trump Executive Order eliminates duplicity, encourage streamlining of permit process. All state and federal agencies looking at same paperwork.

Okeechobee (Hoover) dike crossing requirements are very restrictive, even for berms only 1' in elevation. No poles in dikes/levees. Bores under levees must be very deep underneath, requires geotechnical engineering. No fracking. Some types of soil have maximum 10 psi limitations to prevent fracking.

Back to Hillsborough County permit language. Fred asked Jan if she works in Hillsborough County. Frontier has 12-way conduit system in conflict with proposed 18" water line. Frontier lost legal challenge but has appealed the decision.

Some discussion about similar situation with CTL in Charlotte County.

Jan mentioned that if cables in the MH system carried FAA traffic, it could be used to delay or prevent having to move conduit system.
