Our greenbelts have been attended to through grants, some funds of Gold Ridge's, and Dom Smith who has worked harder than anyone to ensure the greenbelts did not get neglected. A very special thank you also goes to the Fire Council Chair, Sherry Hawk, who worked closely with the Gold Ridge Board, and the government, to get this work paid for. And it appears we have more grant monies in the pipeline. Go Gold Ridge, go!

I would be remiss if I did not mention the CC&Rs - and while no CC&Rs are perfect, for the first time Gold Ridge has bylaws that make sense, and if those pass, it will take a community vote for there ever to be a management agency trying to take over or manage Gold Ridge Forest.

This was put in the bylaws to ensure future Boards remember that it's we the people of Gold Ridge who steer our own futures - not outside agencies. Is there room for additions? Of course there is. That's the beauty of any piece of legislation. And if we don't get there yet, with the new rules that empowers homeowners to have more home autonomy and less regulations, we will get there in another round in the future. Your Board is listening!

This isn't the end, it's just the beginning for Gold Ridge. The nice thing is that if there is ever a need for a few small amendments to the CC&Rs, it won't cost much money because the hard work on the CC&Rs has been done. So don't give up Gold Ridge - keep fighting for what you believe in because all of you matter. And this is our community. Having served on the Board I know first-hand what Boards can do. And to give more power to homeowners over their homes rather than delegate those duties to a Board, all members need to do their part and vote! Thank you Marie Zandona-Harger for all of your dedication and support to Gold Ridge for so many years. When she sets out to do something, she puts her heart into it, and it shows.

To our Recreation Director, Rose Smith, she has been instrumental in the rebuild and reshaping of Gold Ridge's recreational facilities. I'm beyond grateful for her dedication and support as we quickly moved to deliver a state-of-the-art pool. To those that know her, we all know how much time and energy she puts into everything. So, if you see her around, thank her for a job well done.

In addition, we have hired pool operators (now reclassified as Facilities Operators), who oversee the recreation area and are certified to check the chemical balances of the pools. All groundskeepers are now called Facilities Operators, under the umbrella of Facilities Operations, and they all have unique qualifications such as plumbing, equipment management, and chemical balancing. This was vital for Gold Ridge in order to protect our biggest investment, our pool. Maintenance is key going forward, and every future Board must ensure our facilities are being maintained properly and that they are held accountable by all of us as members.

Your new Board is more than qualified to take over, and I'm pleased to see new faces step up to the plate to serve this wonderful community. Your new Board consists of Deputy Sheriff Jack Mermod, former IRS attorney Mark Weiner, Chris Soule of El Dorado Irrigation District, and Robyn Swift in construction, all of them bring their own set of skills and experiences. You will be in good hands.

As I finish this last letter as your President, I humbly say thank you for giving me the opportunity and privilege to serve as your President. It's been an honor to serve you and to listen to homeowners, while improving all facets of our Association. Onward and Upward Gold Ridge. Never stop improving, never stop believing. The future is all of ours if we turn those dreams into tangible realities.

On May 29, 2023, our GRFPOA community celebrated the opening of the new large saltwater pool with a barbeque and potluck. Getting to this happy day was not without its challenges, but the smiling faces of all the families enjoying that day was worth all the efforts needed to get it done! We can look forward to many years of continued swimming pleasure through proper maintenance and care.

We have continued to extend voting deadlines to July 10 for the CC&R and Bylaws revisions election. A simple majority of votes does NOT qualify as a valid election in this case.

The new proposed CC&R's and Bylaws are less restrictive on homeowners, and they give you more flexibility in making decisions with your home.

In order to pass the new CC&R's Gold Ridge Forest needs 315 YES votes to change the CC&R's. If the new proposed CC&R's and Bylaws do not pass, the current CC&R's and Bylaws will remain in effect.

If you have not voted, please mail your ballot today! If you need another ballot, please contact the office at <u>grfoffice1@gmail.com</u> to request a replacement.

This will be my final newsletter contribution as my term on the Board at GRFPOA comes to an end. I want to thank all our members for their continued support and encouragement as we all dealt with the challenges of the past two years.
