### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND IMDEMNITY AGREEMENT

The undersigned hereby agrees, understands and acknowledges the following:

I understand and take all responsibility to ride at my own facility as well as other facilities (for horseshows, schoolings, or clinics) or participate in group activities and agree to hold harmless Ron & Crystal Wylie, Sandia Creek Ranch staff, organizers & any affiliates, the undersigned for himself or herself (or his or her child or ward if the rider's is under 18) agrees on behalf of his or her (or the child or ward's) heirs, personal representatives, spouse, next of kin, successors and assigns, all of who shall be legally bound by this Release and Waiver of Liability ("Agreement"), as follows:

I am fully aware and acknowledge that horses are often dangerous and unpredictable animals, and that horseback riding, and particularly jumping, is a dangerous activity and involves inherent risks of accident, loss, serious bodily injury including broken bones, head, neck, spinal and internal injuries, trauma, pain, suffering, or death due to being kicked, stepped on, thrown from or falling from a horse; colliding with other rider's horses, buildings, fences or objects; numerous other causes, including, without limitation, other persons' negligent actions, inactions and/or misconduct; and lack of readily available medical care and treatment. I understand that no amount of care, caution, instruction or expertise can eliminate these risks. I wish to participate in these activities knowing that they are dangerous and agree to accept and assume all risks of personal injury, death and/or property damage that may occur.

I understand and acknowledge that I have been advised by Ron & Crystal Wylie and Sandia Creek Ranch that I must wear an American Society for Testing Materials (ASTM) and Safety Equipment Institute (SEI) certification approved/certified horse riding helmet while riding, mounting, dismounting and working or being around horses, and that the wearing of a helmet may reduce the severity of head injuries as a result of a fall from a horse or other occurrences. I also understand and acknowledge that it is in my best interest to wear an approved/certified protective vest designed to reduce trauma to the upper torso from impacts and falls. I take full responsibility for the condition of my own tack I choose to use and I accept all responsibility for any borrowed tack I choose to use. I acknowledge and understand that I have the opportunity to conduct a reasonable visible inspection of the Premises, including the riding course, its layout and obstacles.

To the fullest extent allowed by law, I voluntarily release, discharge, waive and relinquish Ron & Crystal Wylie and Sandia Creek Ranch, members, officers, agents, employees, sponsors, volunteers and insurers ("Releasees") from any and all rights, claims, demands, losses, causes of action and damages I now or in the future may have of any kind whether now existent or which become existent in the future, whether the same be now known/unknown, anticipated/unanticipated, resulting from personal injuries, death or property damage arising from or in any way related to my participation in the activities described in this Agreement. I expressly waive all rights.

IT IS MY INTENTION BY THIS AGREEMENT TO EXPRESSLY ASSUME THE RISK OF AND TO EXEMPT AND RELIEVE THE RELEASEES FROM ANY AND ALL LIABILITY FOR MY PERSONAL INJURY, PROPERTY DAMAGE OR DEATH FROM WHATEVER CAUSE OCCURING WHILE ENGAGING IN THE ACTIVITIES DESCRIBED IN THIS AGREEMENT OR RELATED THERETO.

To the fullest extent allowed by law, on behalf of myself and my heirs, personal representatives, spouse, next of kin, successors and assigns, AGREE TO INDEMNIFY, DEFEND AND HOLD HARMLESS the Releasees from any suits, claims, demands, damages, judgments, losses, liability, causes of action at law or in equity, costs or expenses of any nature whatsoever, including attorney fees and expert consultant fees, by whomever and whenever made, arising from or in any way related to my participation in the activities described in this Agreement regardless of fault and whether caused by the active, passive, sole or contributory negligence of the Releasees. I agree that under no circumstances will I or my heirs, personal representatives, spouse, next of kin, successors or assigns, sue or present any claim for personal injury, property damage or wrongful death against Releasees whether based on negligent acts or omissions, dangerous conditions or any other legal or equitable theories. This Agreement may be pled by the Releasees as a complete bar and defense against any claim, demand, action or causes of action asserted by me or on my behalf. I will be responsible for and bear my own costs and attorney's fees. I understand that I am waiving my right to a jury trial.

I have carefully read this Agreement and understand the contents. No oral representations, statements or inducements have been made to me, other than those contained in this Agreement. I understand that this is a waiver and release of liability and a legal binding contract between Ron & Crystal Wylie / Sandia Creek Ranch and myself and supersedes any other agreement or representation by or between the parties and is intended to provide my comprehensive release of liability and agreement to indemnify and not to sue. I agree that all provisions of this Agreement will be binding regardless of whether I have initialed the provisions.

## SCR Ranch Policies

Sandia Creek Ranch

---

Most of our Policies are standard at any reputable barn and reflect good sense and good horsemanship...a few rules are specific to our barn and its specific conditions...thanks for adhering to the Policies and maintaining the safety and good horsemanship we represent.

It is understood that horses are large animals with a mind of their own and can be dangerous. Any experience on or around horses and in this wilderness environment is a risk you are willing to assume and you will furthermore attempt to limit that risk to others by using correct considerate behavior around the other visitors also.

- NO SMOKING on the grounds...(Please be sure to remind your guests)
- Helmets are required when mounted
- Proper foot attire is required for riding in a saddle
- No bare feet around horses
- Signed Release **must** be on file (& kept current) for all riders and visitors (if you bring a guest, you must always watch them), teach them where to go if there is a loose horse & how to be safe!
- *When walking/riding the grounds please make yourself known when coming over a rise or down a hill by talking so that the horses can hear you and not wonder what is in the bushes and spook. Guests are not allowed to run free throughout the property...one should seek permission and leave word as to where they will be...Children never go alone!*
- **Do not** drink water from spigots with **purple** shut off valves, they are for irrigation only.
- Dogs are to remain in the car or on a hand held leash.
- **No jumping without SCR instruction** (see Ratings & Requirements for more details).
- Turn outs are in designated turn out rings.
- All breakages must be reported and replaced. Be responsible for all costs for repairs.
- Rings for riding lessons or training are reserved during lesson/training times.
- *Gates are to be left in a hooked closed position* (for safety and to prevent wind damage) and are ***not*** to be climbed on.
- Wash racks are to be left clean with drain working.
- Feeds that are spoiled must be dumped into trash can (where a horse cannot get into it) not washed down drains.
- Feed rooms must be always left latched closed when unattended.
- No riding double.
- Use of SCR equipment is specifically arranged for and signed out...
- Hay barns are for hay storage. They are not structured for holding weight only for holding up a tarp....Beware that visitors are careful not to try to swing on the structures and never allow anyone to handle the hay hooks....Feeders must be sure to replace hooks in the hanging position if they are not in hand.
- Horses must be tied to designated tie posts or crossties only (DO NOT tie to Pipe corrals, Benches, Fence boards, etc.)
- Visiting Horses (attending a lesson or clinic) must be current on all vaccinations, de-wormings & in good health. Regardless, No sniffing noses please!
- Keep horses away from Fletcher's & Tuck's stalls! "Tuck" & "Fletcher" are stallions, even though they are both really friendly fellows with people, other horses could be exciting to them, so please keep your horses away from them.
- Yearlings & Youngsters will bite, they are teething so don't put yourself in a vulnerable position.
- Do not feed "treats" without permission, we have several "special needs" horses that it could be toxic to them (i.e. HYPP horse = allergic to alfalfa, etc.)
