**Keep Calm and Lion On** Remember no matter how challenging situations become, you know what to do! As Lions, we focus on our members and our communities and Lion on!

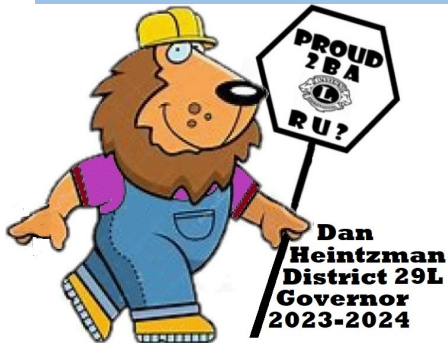
