 - a. On February 13, 2019 at about 3:08 AM a resident at 537 Touvelle Street heard a number of shots fired in the trailer court and called the Celina Police. Upon arrival officers found that a residential trailer had been shot five times. Officers made contact with the resident, who denied knowing what was going on and that he was asleep at the time. No suspect was located at that time.

- b. On February 14, 2019 St. Marys Police Department made a traffic stop. The officer was aware of the shooting call in Celina the day before. The St. Marys officer did make observations during the traffic stop which made him suspicious. He contacted Celina Police Department. Together the agencies developed probable cause for a search warrant which was executed on a St. Marys home

As a result, a suspect, 22-year-old Joseph Dylan Meinerding, was arrested and booked into the Mercer County Jail on Felonious Assault. The suspected handgun and ammunition were also recovered.
