 - a. Celina Police Department concluded a lengthy investigation and presented a case involving the overdose death of a Celina woman to the Grand Jury. Indictments were handed down on a Celina man for several felonies, including corrupting another with drugs, reckless homicide, possession of fentanyl, tampering with evidence, identity fraud, obstructing justice and theft.

This case, led by Detective Brian Taylor involved many hours of interviews as well as multiple search warrants for electronic and physical evidence. The 34-year-old man is being held in the Mercer County Jail pending court actions.
