- c. 2018 Street Resurfacing Project:
 - i. 2018 Street Resurfacing project is complete.

This project will be replacing the existing 6" waterline with a new 8" waterline from just East of Brandon Ave. to Main St. which will include new water services to the residents and businesses in this area. Traffic will be maintained during construction.
