6. 2020 Construction Update:
 - a. 2020 Street Resurfacing Project
This project is currently in the planning design stage. Access Engineering Solutions and the City of Celina expect to put this project out for bids sometime in late May or early June with construction beginning sometime after the first of July. This project was postponed due to Covid-19 pandemic. The City opened bids for this project on Thursday the 13th of August with only one bidder, The Shelly Company. Their bid was \$1,293,479.80 and the engineers estimate was \$1.3 million. **The substantial completion date for this project is June 15, 2021. This project has been awarded to The Shelly Company. A start date has not been determined, however it is looking like this project will not start until next spring.**

b. 2020 ODOT Resurfacing (North Main Street)

The Ohio Department of Transportation (ODOT) has contracted with The Shelly Co. to resurface N. Main St. from Fulton St. to the northern City Limits on Main St. This project has a June 30th completion date and a contract bid price of \$493,173.00. The pre-construction meeting was held by ODOT on March 13th. The Shelly Company began work on Wednesday 5/20/2020 milling the existing pavement. They began the paving operation on Tuesday 5/26/2020 and finished all of the paving on Tuesday 6/2/2020. The pavement marking was also placed this date. This project was completed 6/22/2020.

c. 2020 (ODOT) West Market Street Reconstruction

ODOT accepted bids for this project Thursday 1/23/2020. The Engineers Estimate for this project was \$1,718,000.00. The apparent low bidder was Milcon Concrete Inc. from Troy, Ohio with a bid of \$1,676,869.00. ODOT has awarded Milcon Concrete this project. This project has a completion date of 9/30/2020 and an interim open to traffic date of 8/31/2020. A pre-construction meeting was held by ODOT on March 26th. Milcon Concrete intends to start this project mid-April. This project begins west of Landmarks west property line and ends on the west side of the Walnut St. intersection. This project includes all new asphalt pavement (12" Thick), all new storm sewers on both sides of the street, new concrete combination curbs and gutters, new concrete sidewalks and new concrete driveways. At the end of this project the City Electric Dept. will be installing new street lighting.

Milcon Concrete began work Monday 4/20/2020. This project will be constructed in 4 phases:

- Phase 1: Install all of the storm drainage while maintaining traffic except for storm sewer crossings in the street.
- Phase 2: Close and reconstruct Market St. from the West end of the project to Mill St. and including the Mill St. intersection. The contractor will have 3 weeks to complete this phase and reopen this section of Market St.
- Phase 3: Close and reconstruct Market St. from Mill St. to Walnut St. The contractor will have 90 days to complete this phase and reopen this section of Market St.
- Phase 4: Place the surface course of asphalt for the entire length of the project.

On 4/22/2020 the contractor began the storm drainage on the west end of the project. The storm sewer work was completed 5/29/2020. On 6/1/2020 the contractor began phase 2 of this project by closing Market St from just east of Mill St. to just west of Landmark's property. This phase of construction was completed and open to traffic on 6/22/2020.

The Phase 3 closing of Market St. (Mill St. to Walnut St.) began 6/16/2020 and the street was closed to all traffic 6/22/2020. The excavation of the street and the placement of the aggregate base was completed 7/1/2020. The installation of new curbs began Thursday 7/2/2020 and was completed Monday 7/6/2020. The concrete placement for drives and walks was completed 7/16/2020. The intermediate course of asphalt was completed 7/31/2020 to complete Phase 3 of this project.

Monday 8/3/2020 the contractor began Phase 4 of this project by placing and completing the surface course of asphalt.

ODOT has informed the City that the surface course of asphalt may need to be removed and replaced due to it being out of tolerance for the specified specification. After further review ODOT has determined that the asphalt surface course can stay in place with a 10% reduction in price.

The City has made it known to ODOT that the finished asphalt surface course is not satisfactory and the City is working with ODOT to resolve some of the issues. **On Tuesday 9/22/2020 the contractor began corrective work for the pavement in the area between Sugar and Walnut streets (sta. 11+50 to 12+75). This area was milled full width in order to remove deficient pavement and then the following day they replaced this pavement. On Thursday the final pavement markings were placed to complete this project.**

Due to not knowing the disposition of the surface course of asphalt the final pavement markings are on hold which will complete the project.

The natural gas lines in the area of this project have to be lowered before this project can get started. Dominion Energy has awarded this project to Middleton Mechanical.

The natural gas line relocation is complete.

d. Police Department Cold Storage Building

The City took bids for this project on December 10, 2019. The Engineers Estimate for this building was \$400,000.00. There were 8 bids for this project with Miller Builder, LLC of Apple Creek, Ohio being the lowest with a bid of \$308,780.00. Miller Builder, LLC has been awarded the contract and this project has a completion date of September 1, 2020. The contractor did layout the building on 6/25/2020. On 7/28/2020 the contractor began work. The footings and foundation walls were completed 7/30/2020. The concrete floor for the building was completed 8/26/2020. The wood framed walls were completed 9/12/2020. The contractor is currently not working as they are still waiting on the fabrication and delivery of the wooden roof trusses.

 - a. On 9/20/2020 at 8:11 PM the Celina Police Department along with Celina Fire Department were dispatched to the intersection of State Route 29 and Grand Lake Road in reference to an injury accident involving a motorcycle.

Through the initial investigation it was found that a 67-year-old Coldwater man was traveling west bound on State Route 29 towards the intersection of Grand Lake Road on a 2003 Harley Davidson. At the same time a 31-year-old Celina man was attempting a left turn from State Route 29 to north bound Grand Lake Road in a 2008 GMC 1500, causing the motorcycle to strike the passenger side of the GMC.

The motorcyclist was not wearing a helmet and he sustained severe injuries. He was taken by ambulance to Coldwater emergency room and then flown by helicopter to a Ft. Wayne hospital where he remains.
