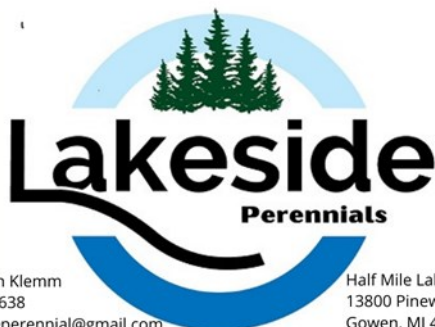

Restoring Harmony to the Lakeshore

While most of our Half Mile lakeshore property has been left to nature to manage since the beginning of time so to speak, we do have roughly 150 feet that has been modified over the years. Nothing too drastic, and much of what was done was deteriorating beyond recognition. With the removal of unsafe structures, and reinforcement of existing stones once used to hold the shoreline in place is how we began restoring harmony to the lakeshore.

What was once a mowed lawn with day lilies, iris and flower shrubs along the lakeshore has now been turned into an oasis for native plants, birds, bees, and wildlife to enjoy. If it looks a little unkept, it is not; but is really a start to creating a natural habitat. We started by burning the area off in the early spring two years ago, what this did was allow native plants/seeds that had been dormant to emerge. We now have New Jersey Tea (*Ceanothus americanus*) flourishing on the slope with its dainty white flowers in the early summer months, Spotted Bee Balm (*Monarda punctata*) a favored nectar source for the endangered Karner Blue Butterfly popping up everywhere, Pussytoes (*Antennaria neglecta*) gracing the slope with their flowers that resemble a cat's paw, Pipsissewa (*Chimaphila umbellata*) with its beautiful pink flowers and Wild Lupin (*Lupinus perennis*) another favorite of the Karner Blue Butterfly. At the lakeshore, Marsh Milkweed has returned with its beautiful pink flowers, Marsh Ferns along with Ostrich Ferns are now growing along with a variety of native grasses that I have not yet identified.

This year we removed non-native plants to allow natives to reclaim what was once theirs and added a host of pollinator plants that are native to Michigan. While native plants are slow to establish themselves the first few years once established, they will thrive with the right conditions. Our goal is to have an ever-flowering display along the lakeshore.

Erosion was a major concern in front of the house; railroad ties that had once been used to terrace the slope were deteriorating and allowing rain water to erode the soil, these have now been replaced with landscape blocks creating several landscape beds that terraces the slope down to the water. These beds are being used to propagate native plants for use in the yard and as nursery stock.

If you have been passing our place this summer/fall you will notice the large black covered area in front of the house, this process is called solarization which heats up the soil underneath with the intention of killing off weeds and grass, this area will be replanted with native plants in the spring.

As fall is upon us, the lakeshore will be allowed to die down naturally, thus providing food and shelter for insects and wildlife. The native plants that have come back are providing an abundance of seeds this year, a good indication that we are reaching our goal of restoring harmony to the lakeshore.

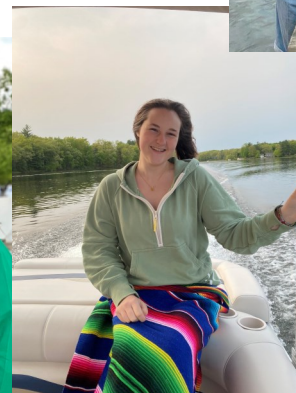

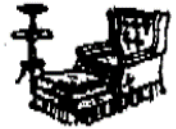

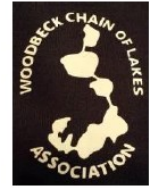

EGLE permitting restrictions, national holidays, and/or weather conditions may influence the timing of treatments throughout the 2023 season. PLM treats each lake according to a schedule or season plan, established with the cooperation of your lake association, lake board or residents on the lake. The treatment schedule is approximate. Please watch your shoreline for the posting of the 8.5x11 inch, yellow or green signs. The signs will indicate the date of the treatment, the products used, and any restrictions on the use of treated water for swimming, watering lawns, etc. The property owners in this area are planning to have the waters chemically treated to control lake weeds and/or algae. This notice is being circulated in accordance with Department of Environment, Great Lakes and Energy (EGLE) procedures. Below is a list of herbicides that **may** be applied to the lake and the associated use restrictions. On the day of treatment, signs will be posted along the shoreline within 100 feet of treatment areas that indicate what products were used and specific water use restrictions that apply:
