### How to Apply, Get Tax Exempt Status & More

### How do I apply for membership?

Apply in-person and complete a TRADE VIP application and present appropriate credentials. You will receive a membership card to present at the time of your purchases. Use of your TRADE VIP membership card is subject to Odd Fellows Antiques TRADE VIP Terms & Conditions (see below).

Please present two of the following application credentials:

Business or Resale License (resale certificate required for tax exempt status)

Business card with your design profession

Current business Accounts Receivable invoice

Membership in a major design organization (ex. ASID, AIA, NKBA)

Membership at Michigan Design Center

### How do I receive sales tax exempt status?

In order to process tax exempt transactions in the State of Michigan, Odd Fellows Antiques must have on file the completed State of Michigan Resale Certificate form. We are required to charge sales tax on all business purchases in instances where we have not received a completed and signed Resale Certificate.

### What is your return policy?

Due to the nature of our items, with everything being previously loved, there are no warranties on any of our antique and vintage items. All sales are final - we have a "no refunds, no returns" policy. Please measure and inspect carefully to be sure that you purchase items that are right for your project.

#### May I take items out on approval?

At this time, we do not allow items to be taken home for approval before purchase.

### Can I put an item "on hold"?

Yes, merchandise may be placed on hold for 24 hours upon request.

### Do you have a Layaway Policy?

The TRADE VIP program excludes items placed in layaway. Odd Fellows Antiques has a 30-day layaway policy. After a 20% down payment has been applied to the purchase price, the balance due on the item must be received in full and the item removed from the shop within 30 days of the purchase date.
