

MHPYC Prospective Member Application Process

Thank you for your interest in the Mariposa Hunters Point Yacht Club (MHPYC). This sheet is here to explain the process for membership. Our email address is mhpycmembership@gmail.com if you have any questions about the process.

All prospective members must be sponsored by a Member of the MHPYC. The Sponsor must be a member of the club for at least one year before they can sponsor a Prospective Member (PM). Your sponsor will complete the Application for Prospective Membership Introduction. The competed application and the PM sponsorship form is either emailed to membership or dropped off and left at the club for the committee's review. The membership committee will contact you and your sponsor about the application.

If the application is accepted, you and your sponsor will co-ordinate with membership and set up a date when he/she can come to introduce you to the Membership. This is done at one of our General Meetings. General Meetings are held every month except for January on the second Saturday of the month at 6:30 PM. Please **arrive at least 30 minutes early to check in**. You will have 4 General Meeting cycles from the date we accept your application to attend a General Meeting with your sponsor for Introduction to the Membership. **Please do NOT turn in this application if you cannot make the General meeting within 4 meetings WITH your sponsor (it is required your sponsor is present).** If you sponsor remits the application and you fail to attend with in 4 meetings you will have to wait 12 months to re-apply. Of course, if some unforeseen emergency happens you may have your sponsor contact the membership as soon as possible committee and we will happily apply to the board for an extension.

At the General Meeting the Board we will call up Sponsors to introduce their PM's. At that time, you will go before the board and the general membership. Your sponsor will tell the members who you are and how he/she knows you. You will then give the members information about yourself (line of work, where you are from, reasons for wanting to be a member of the club, etc.). The floor is then opened to members and t h e board to ask questions if they would like.

Please arrive at the meeting by 6pm and check in with the membership committee, at this time you will pay the \$150 Application Processing Fee. You will also receive your Prospective Membership Card. This allows you access to the club without your sponsor being present. On the back of the card there is a space for officers of the club to sign off on. You are required to have this card signed three times before y o u can be sworn in as a member. You may have your card signed off by attending any of our club sponsored events or by volunteering (cooking, work days, etc.).

When you have passed the probationary period of 3 months and have your 3 events signed from your PM card you may contact the membership committee (note: You have up to 6 months to have your PM card completely signed off with three events. If you do not have your card completed within 6 months your PM status is revoked and the \$150 application fee is forfeited. Again, if an unforeseen emergency happens please contact the membership committee to request and extension from the board.). The committee will then submit your application to the board for membership consideration. If your application is approved by the board, the membership committee will contact you and you will be sworn at the next General Meeting. The day you are sworn in you are required to pay prorated annual dues. The schedule of these dues is located on the Prospective Member Information Form. If your application is denied you will be refunded your application fee of \$150.

If you have questions or wish to follow up on your application, please feel free to contact the membership committee directly. Our contact information is in included in the Prospective Member Information section of this document.

General Meetings- are held the second Saturday of every month (Except for January, there is no general meeting that month) at 6:30 PM.

Dues/Pro-Rated Dues: Annual dues are \$250 per year per member. Annual dues are due on January 1. *If dues are not received by February 14*, your membership will be suspended. If you wish to be reinstated to the club at that *time you also must pay the reinstatement fee (currently \$75)* as well as your annual dues of \$250. A suspended member that has not been reinstated by April 1st shall be deemed to have resigned from the club and their membership will be permanently canceled. **If you are a new member you will pay prorated dues according the month you are sworn in as member.** The pro-rated dues are due the day you are sworn in before the meeting begins. The schedule for new member prorated dues is as follows:

PM Eligibility Events- Once you are introduced to membership you will be given a Prospective Membership Card. In order to be eligible for membership you must have the card signed off by attending or volunteering at the club. The card can be signed off by an officer of the club (please note that Bartenders are the officers of the day). The following is a list of opportunities to have your card signed off:

As a PM of the MHPYC you must follow the rules of the club and conduct yourself accordingly.

- 1) When you enter the club, you must sign the book. You will sign in as a Prospective Member.
- 2) You must wear a name tag when you are in the club. Under sponsor you will write Prospective Member.
- 3) You will not divulge the club's business to any outsider.
- 4) You must be respectful to all members and their guests.
- 5) Please be aware when children are in attendance at the club and act accordingly. This is a club which includes families not a private bar please be mindful of using offensive language.
- 6) No fighting, or threatening members or their guests.
- 7) Members often host private parties at our club, you can attend the club during a private party but do NOT help yourself to food or beverages purchased by the host unless you are invited by them to do so. (Please note you may not host a party until you are a full pledged member of the MHPYC)
- 8) As a Prospective Member of the club you are limited to bringing in guests who are members of your immediate family only.
