Structure, Governance and Management

Constitution

ACFRG is a Scottish Charitable Incorporated Organisation (a SCIO). The Charity has a two tier structure that comprises a Board of Trustees and Members. All of the Trustees are Members. The Charity's objectives, structure, governance and management arrangements are set out in its Constitution document which can be found on the website; http://acfrg.net.

Appointment of Trustees

The Board of Trustees meets as a matter of course on a quarterly basis. The Board of Trustees comprises the key office holders, a medical consultant and members who have relevant experience in the voluntary sector . New Trustees are initially appointed by the Board of Trustees. All Trustees are required to retire, and if they so wish, to stand for re-election on an annual basis at the Annual General Meeting. Any Member of the Charity may stand for election as a Trustee at the Annual General Meeting.

The constitution stipulates a maximum of eight Trustees and a minimum of three. The Trustees are entitled to coopt relevant specialists onto the Board of Trustees but no more than two Trustees will be co-opted at any point in time.

Objectives and Activities

Charitable purposes

A Community First Responder is a person trained, as a minimum, in basic life support and the use of a defibrillator, who attends a potentially life threatening emergency.

The purpose of Aberfeldy Community First Responders Group (ACFRG) Scottish Charity No SC047017 is to provide assistance to those experiencing a medical emergency and most importantly to start and maintain the CHAIN OF SURVIVAL in CARDIAC ARREST patients until a fully equipped ambulance arrives.

ACFRG are based in Highland Perthshire, geographically an area where emergency medical service response is likely to be delayed beyond the critical first 8-10 minutes.

Activities

At the start of 2022, ACFRG had 8 active Community First Responders (CFRs) and this had reduced to 7 by the end of the year. Three potential new recruits have expressed an interest to join the group and are awaiting SAS training courses. We have covered approximately 4,400 "GP out of hours" time and were called out on 30 occasions last year, including to a number of cardiac arrests. The number of call outs has been well below the levels seen prior to the Covid lockdowns, which is suprising given the well publicised strains on SAS. We have been advised that this has been due to technical problems with despatching at SAS.

First Responders attend monthly training updates to maintain appropriate levels of competence. In addition, individual skills assessments are carried out every 6 months, monitored by SAS staff.

Achievements and Performance

The Covid-19 pandemic had severely curtailed the ACFRG activities since March 2020. As the Covid restrictions have eased, we have recommenced our "in person" training with effect from January 2022. When ACFRG was launched in 2017, the number of CFRs rapidly increased and peaked at 20. During the Covid lock downs a number of CFR's were excluded on age grounds and others felt unable to continue. Whereas our CFRs originally worked in pairs, the lower current number has resulted in the CFRs having to attend emergency call outs alone. Nonetheless, ACFRG continues to provide a highly valued service within the community.

Financial Review

ACFRG had a relatively quiet year in terms of fundraising activities but £910 was successfully raised at our Quiz Night in November . We are very grateful to all of our donors, especially to the many individuals who live in the Aberfeldy area and who have shown huge generosity over the years. Due to the low levels of activity, the charity's expenditure was equally restricted.

The Charity experienced a net outflow of £1,511 for the year (2021 - deficit £1,437) after accounting for all costs. Since the accounts are prepared on a receipts and payments basis, the accumulated annual surpluses are held entirely in bank balances, which totalled £9,125 at 31 December 2022 (2021 - £10,636). Looking to the future, we will continue to raise funds at local events which will be sufficient to cover running costs. On top of this, we will raise funds so as to build up reserves for the replacement of medical and training equipment as neccessary.

Reserves Policy

The Trustees' policy is to maintain general reserves at a minimum of £1,000 as a contingency against any unexpected expenditure. In addition, designated reserves will be accumulated through fund raising initiatives for the purchase of medical and training equipment. This is particularly relevant to the replacement of our 10 defibrillators which have a 10 year life and which currently cost around £1,500 each. The general reserves at 31 December 2022 were £2,073 (2021 - £3,584). At 31 December 2022 the Trustees had designated a total of £7,052 as an equipment replacement reserve (2021 - £7,052). The Charity does not have access to any overdraft or loan facilities and the Trustees do not intend to enter into any such arrangements.

Plans for the future period

With just 7 active first responders we will cover as much of the "GP out of hours" time as we possibly can, but this will be limited. As soon as we are able to recruit and train new CFRs they will be brought into active service and our coverage will increase.

On behalf of the Trustees, I would like to express our sincere thanks to all those individuals and organisations that have donated funds to ACFRG, to the SAS for their assistance with training and, most importantly, to our volunteers who have demonstrated huge enthusiasm and committment over the 5 years since ACFRG was formed.

Independent Examiner's Report to the Trustees of Aberfeldy Community First Responders Group

I report on the accounts of the charity for the year ended 31st December 2022 which are set out on pages 2 to 7.

Respective responsibilities of trustees and examiner

The charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity's Trustees consider that the audit requirement of Regulation 10(1) (d) of the 2006 Accounts Regulations does not apply.
