The Principal Report from Mr. Crouse included:

- The elementary students had IAR testing last Tuesday-Thursday.
- The junior high students' IAR testing is this Tuesday-Thursday.
- The eighth graders participated in the Reality Store at Spoon River College. Students picked a job and learned about living expenses.
- On Friday, April 21st, we will be participating in Reading the Most from Coast to Coast.
- Teacher's Institute is Friday, April 28th.
- Junior high track to doing well.

The Principal/Superintendent Report from Mr. Willett included:

- Budget update: As a guideline, each month is worth 8.33% of the total budget. At nine months into our fiscal year, our guideline is 74.97%. As of March 31, our Ed Fund is 56.43%; Building Fund is 59.95%; and Transportation Fund is 58.96%. Our overall budget is at 55.90%. As a reference, 1% of our total budget is nearly \$63,500.
- The National Honor Society held their spring blood drive on Monday, April 17<sup>th</sup>. They were able to get 22 units of blood for their efforts. The NHS earned a grant for \$272 from ImpactLife for their efforts. They are thankful to all who donated.
- Once again, our school will participate in a bed build in conjunction with Sleep In Heavenly Peace. Our National Honor Society members and our students will build bed frames on Tuesday, April 25<sup>th</sup>, in our parking lot. The Astoria Lion's Club will also be here to assist in the build and provide supervision and hands-on help. We are looking forward to the build, as it is a rewarding community project.
- The district is looking to hire part-time bus drivers. The district will pay for all aspects of obtaining the bus CDL. If you are interested, contact the high school office at 329-2156.
- We will have our last teacher institute on Friday, April 28th. No school for students on that day.
- Our baseball, softball, track and fishing teams have been competing and showing improvement as the season has progressed.

The state provided the school with air purifiers.

The budget will need to be amended.

We are working on the Student Handbook for next year.

The board agreed to make a \$2,500 donation to the South Fulton Marching Band for uniforms.

An ad will be placed in the Argus to announce a school board opening. Any person interested will have to resident in one of the following townships: Browning, Hickory-Kerton, Pleasant, or Woodland.
