The Principal Report from Mr. Crouse included:

- House sorting was today.

- Parent/Teacher conferences are Thursday, October 19th.

- Junior high boys' basketball has started. We have 15-seventh graders and eighteighth graders. Their first game is Tuesday, October 31st.
- Junior high girls' basketball is wrapping up, with both 7th and 8th grade regionals being hosted at VIT. Seventh grade starts on Saturday, November 11th, and eighth grade on Saturday, November 18th.

The Principal/Superintendent Report from Mr. Willett included:

- I attended my yearly workshop on the levy process today. I will present our levy information at the November board meeting.
- We completed our yearly bus evacuation drill on October 17th. The students did a fantastic job listening to our drivers and completing the drill without incident.
- We are slated for a full compliance from the ROE this year. I have been working on the documentation needed to fulfill the requirements. This process will take a couple of months to complete, culminating in a visit from the ROE.
