- 7th and 8th grade girls' basketball has started. Both teams are 2-0.
- Junior high cross country is doing very well, having several students run personal best already this season.

The Principal/Superintendent Report from Mr. Willett included:

- The Astoria Chapter of the National Honor Society will be holding a blood drive on Monday, October 16th, in the high school gym from 8:30 a.m. to 1:00 p.m. The public is welcome to give blood.
- Homecoming week is next week. Our student council has several fun activities planned for
 the week, culminating in a lunch and game day on Friday morning. We will be going to
 VIT on Friday afternoon for the powder puff game. The football team will face Princeville
 on Friday night, and VIT will host the Homecoming Dance on Saturday from 7:00 to 10:00
 in the gym. Coronation of King and Queen will be at 6:30 in the VIT gym.
- Total enrollment in the district is 271, up from 270 last year. We have 80 in the high school, 57 in the junior high, and 134 in the elementary.
- High school students have taken their first round of MAP testing in math, reading, and language. The data we receive from these assessments will help our teachers understand the strengths and weaknesses of our students, and they will be able to address their needs. This assessment process will be given again in early December and early May to show progress of the students throughout the school year.
- Our final round of ESSER III federal funds have been allotted. We are in the process of determining the best way to spend the funds from a district perspective.
- All our athletic teams have had a good start to their respective seasons. All are competing hard and experiencing success early in their season. VIT is the site for the Fulton County Volleyball Tournament this year. It will start Saturday, September 23rd. Continued luck and health to all our athletes.

We received our report from our HLS annual inspection.
