

COMMISSIONERS PROCEEDINGS

January 9, 2023

Carla J. Waugh, Jewell County Clerk, administered the oath of office to Ed Duskie, County Commissioner, District 1, with Marcia Duskie present.

The Jewell County Commissioners met January 9, 2023, at 8:30 a.m. Commissioners Brent Beck, Keith Roe, and Ed Duskie, were present. Carla J. Waugh, County Clerk was present for the meeting.

Ed Duskie moved, and Keith Roe seconded to appoint Steve Greene to the Jewell County Hospital Board of Trustees, filling the vacancy of Lila Frost. Motion passed unanimously.

Keith Roe moved, and Ed Duskie seconded to appoint Brent Beck as Chairman of the Board of County Commissioners for 2023. Motion passed unanimously.

Brent Beck moved, and Ed Duskie seconded to appoint Keith Roe as Vice Chairman of the Board of County Commissioners for 2023. Motion passed unanimously.

Keith Roe moved, and Ed Duskie seconded that the Jewell County Record be designated as the official County Newspaper. Motion passed unanimously.

Ed Duskie moved, and Brent Beck seconded that all banks in Jewell County be designated as official depositories. Motion passed unanimously.

Keith Roe moved, and Brent Beck seconded to appoint Ed Duskie as Jewell County's Representative for the Juvenile Justice Authority/Community Corrections Advisory Board. Motion passed unanimously.

Keith Roe moved, and Ed Duskie seconded to appoint Brent Beck as Jewell County's Representative for the North Central Kansas Regional Juvenile Detention Facility. Motion passed unanimously.

Ed Duskie moved, and Brent Beck seconded to reappoint Keith Roe as Jewell County's Representative for the North Central Regional Planning Commission Board. Motion passed unanimously.

The minutes of January 3, 2023, County Commissioners meeting was approved.

Per K.S.A. 19-204 the Commissioners reviewed commission districts based on current population. It was determined to retain the current commission districts as currently assigned.

Joel Elkins, General Superintendent, discussed personnel and road and bridge maintenance.
