Spring arrived early this year on Cedar Lake with the official ice out on March 14. This tied for the earliest ice out—March 14, 1988—since we began keeping records in 1955. Here are a few ice-out fun facts:

- In 2017 the ice went out on March 8, but froze over on March 13 and stayed until March 20.
- Latest ice out was May 4 in 2018.
- Ice out last year was April 25.

There is a lot of CLCC activity and planning in the fall and winter to enable everything to happen during spring and summer:

- The **Fish and Wildlife Committee** got the four loon platforms in place the day after the ice went out. A special thanks to Dean Nicholson and Steve DeGroot for making this happen!
- The **Water Quality Committee** is always busy! Contracts are signed for the extra access inspections to help reduce the spread of aquatic invasive species. The self-serve water craft cleaning stations (called CD3s) will be in place at the CTY RD 6 and Schroeder accesses. All aquatic invasive species plans (grant applications, mappings, and if needed treatments) are in order with professional lake management vendors. Thanks to Kathy Jonsrud for 12 years of leading the Water Quality Committee as she retires from this role. Dave Glass is the new chair.
- We have an emergency plan for **fighting the aquatic invasive starry stonewort**, which looks to be the next big headache for lakes. Please look at page 3 for more information on this newest foe.
- The **Events Committee** is hard at work planning activities to connect our lake community:
  - July 4<sup>th</sup> Boat Parade, 2pm, sandbar: decorate your watercraft and/or docks!
  - Picnic and Music on the Water, Saturday July 13<sup>th</sup>. You don't want to miss it! See the details on page 2.

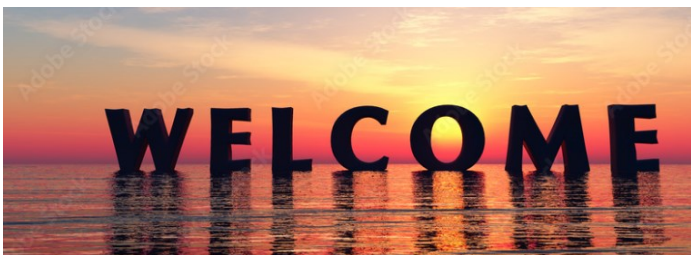


# WELCOME

## Invasive Starry Stonewort **High Alert** None discovered yet on Cedar, but be on the look out!



Starry stonewort is a particularly troublesome and aggressive aquatic invasive species. It can quickly form very dense mats, choking out native vegetation, impacting aquatic habitat, and severely limiting recreation. There are **four lakes close to Cedar with the infestation: Clearwater, Lake Sylvia, Pleasant, and Lake Koronis**. Control strategies are promising, but **early detection is the key**.

### What can we do?

- Familiarize yourself with the list of lakes to the right which are infested with starry stonewort—some of them very close to Cedar—and note the high percentage of infested lakes in Beltrami County. **If you must take your watercraft to a lake with starry stonewort, it is imperative to do a hot water, pressurized decontamination before going to another lake. THOROUGHLY inspect bunk trailers as it can be spread by fragments.** See more information about the Wright County Courtesy Decontamination—right here in Annandale—on page 10.

- Be sure fishing equipment and anchor ropes are thoroughly cleaned after visiting a lake.
- Learn how to recognize starry stonewort. It can be tricky to identify, as there are many natives (chara and star grass) that look like starry stonewort. One unique characteristic of starry stonewort is the six point “star” or bulbil. Here’s a great four minute identification video: <https://youtu.be/te9iF5OTdtg>.
- Watch your lake shore carefully for changes in vegetation. Report any suspicious vegetation to Dave Glass ([glassdavid@gmail.com](mailto:glassdavid@gmail.com))

# Bill introduced to recycle boat shrink wrap in Minnesota

Shrink wrap is used across the country to protect boats from the elements. Unfortunately, the opportunities to recycle that plastic are currently very limited. And we are talking about a lot of plastic. A 25-foot boat uses approximately 25 pounds of plastic and that's roughly equivalent to over 2,000 plastic shopping bags.

Think about the 800,000 registered watercraft in Minnesota and how many of them are shrink wrapped every year. The amount of boat shrink wrap Minnesota uses in just one year is staggering.

A bill introduced in the Minnesota Legislature this year—HF 3220/SF3269—proposes the following process for boat-wrap recycling:

- Create a product stewardship program to responsibly recycle and reuse boat shrink wrap.
- Require producers, through membership in a stewardship organization, to implement and finance a statewide product stewardship program. The program will reduce the volume of boat wrap disposed of in landfills by promoting and providing for the collection and recycling of boat wrap.
- Set goals and a mechanism for tracking progress towards recycling the majority of boat shrink-wrap plastic used in Minnesota.
- Use an existing mechanical technology that uses chemical free, toxic free methods to turn used boat plastic into resin. This resin is then turned back into boat plastic.

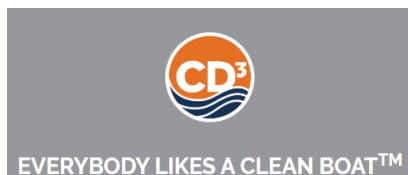

## Aquatic Invasive Species We are all in this together



Aquatic invasive species (AIS) have significant effect on all activities on the lake—not just boating and swimming!

Zebra mussels are an invasive species and can have an impact on the important food chain for sport fishing.

Lake Mille Lacs has been infected with zebra mussels since 2005. You may have heard of the DNR reducing the walleye limits on Mille Lacs to one fish per day this past winter, and additional limits this spring.

Along with climate factors and loss of natural shoreline, which impact fisheries, the University of Minnesota Aquatic Invasive Species Research center explains that the zebra mussel infestation on Mille Lacs appears to have a serious negative effect on the walleye population.

Their first paper, published in 2019, focused on Mille Lacs and concluded zebra mussels (and improved septic systems) lead to increased water clarity and reduced suitable walleye habitat. Walleye prefer water with low clarity and cool temperatures.

The second paper, published in 2020, concluded that young walleyes grow 14% slower in lakes infested with zebra mussels (and 12% slower in lakes infested by spiny water fleas, another invasive species).

So, we are all in this together to prevent the spread of AIS!  
**Clean. Drain. Dry. AND be sure to remember to clean, drain, dry your fishing gear and anchor ropes.**

## What's the Buzz for May?

- **1st week** | We often see the return of the charming hummingbirds and the dazzling Baltimore Orioles this week. Get the feeders out and keep them full as they are hungry when they arrive. Purple martins are back on Cedar Lake, checking out all the great housing provided by Cedar Lake landlords.
- **2nd week** | Lilacs are in bloom and the bees are busy! Barn swallows are getting their nests constructed and ready for their new families. Both the male and female barn swallow build the nest, and share egg incubation responsibilities.
- **3rd week** | Monarch butterflies are welcomed back from their winter in Mexico. They are on the hunt for milkweed where they will lay their eggs.
- **4th week** | The loons are usually sitting tight on their nests, incubating their eggs. As the summer boating season starts, please give the loons plenty of room—200 ft or more—as they tend to their families.

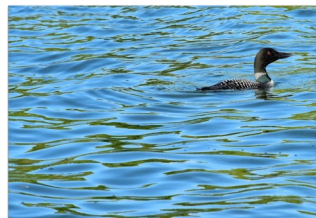
## Loons on Cedar | 4 Nesting Platforms

Nothing says spring on Cedar Lake like the call of the loon. The early ice out this year gave the Fish and Wildlife Committee ample time to get our 4 loon nesting platforms in place.

The loon's urge to return to Cedar lake is triggered by the amount of sunlight. This year, the first loon spotted on Cedar was April 2nd.

Loons are about 2 feet long and weigh 8 to 9 pounds. Males and females have identical plumage. Their wild, haunting calls are a symbol of Minnesota wilderness.

And loons love Cedar Lake, with its deep, cool waters and abundant food source. Fish are their principal food source, but they also eat frogs, leeches, and other aquatic creatures. Loons dive to eat; the average dive time is 40 seconds, but they can stay under water for up to 5 minutes and dive to depths in excess of 100 ft.

Some stories will tell us that loons mate for life. Wildlife studies show that may be the case, but only if the couple is successful raising their chicks.

So marvel and enjoy this incredible gift on Cedar, but please give the loons and their new families plenty of room—200 ft. The new chicks won't be diving till at least July, and parents will not dive if a chick is tucked on their back.

# CLCC WATER QUALITY COMMITTEE

## Aquatic Invasive Species (AIS) Fear Us | \$6,000 of Grants Secured

The Water Quality Committee has met several times over the winter to make sure all plans are in place for our aquatic invasive species (AIS) management. Here's the bumper sticker:

- **Clap and cheer!** For 2024, CLCC has received a DNR AIS treatment grant of \$3,000. And another \$3,000 AIS treatment grant from Wright Soil and Water! **Hats off to Glenn Baird for this win!**
- Contracted for an extra \$29,000 of access monitoring through Wright Soil and Water Conservation District (WSWCD). This is in addition to the standard amount of access monitoring Wright County Soil and Water District provides to Cedar.
- Contracted for mapping/delineation by lake management professionals of curly leaf pondweed (CLP) and eurasian water milfoil (EWM). Treatment will be completed as necessary. We have had limited amounts of CLP to treat for the past 3 years and no EWM

treated for 4 years.

- CLP mapping was completed on April 10th and great news—we do not need any treatment. Our professional mapper says, *“Despite throwing the rake many times, I only found two sites with single CLP plants. Accordingly, I am recommending no treatment.”*
- New this year is a professional all-lake search for any AIS. The search will be late summer.
- Diver/snorkel assisted search for stary stonewort at high risk areas (accesses and sand bar) in September.
- Stary stonewort is our newest foe! Though Cedar doesn't have the infestation, we are prepared with a detailed check list for a rapid response with vendors, DNR, and Wright County. Early detection is the key to control. Please take a look at more information on page 3.

## 2023 Water Quality Numbers Show High Quality, Stable Lake

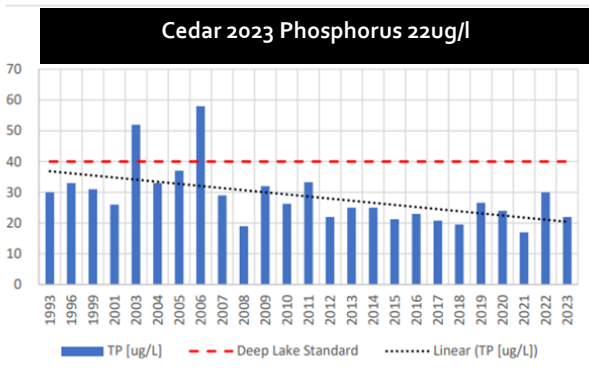
Once again, 2023 was another year of extremes in Wright County. We started the year with very high water—so high the 300ft no-wake ordinance was activated. The year ended with a normal lake level.

Cedar Lake had wonderfully clear water in 2023 but did experience—as did many high-quality lakes—filamentous algae due to environmental events.

Monitoring of Cedar's water quality has been performed for decades by the Clearwater River Watershed District. Samples are regularly taken from our lake during the summer months and analysis is done by a laboratory.

Here is a summary of our 2023 values:

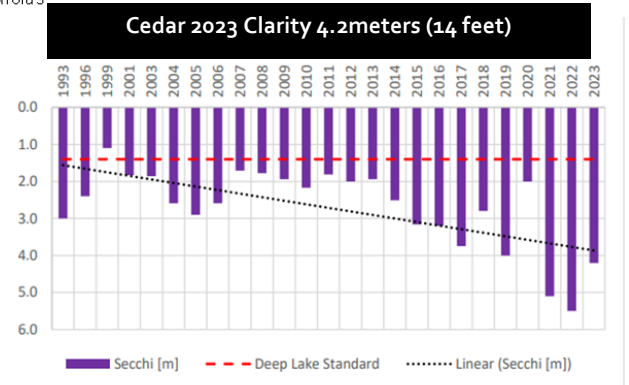
- The gold standard for monitoring lake water quality is the phosphorus level. A good lake is considered to have a level less than 40ug/l. **The average 2023 phosphorus level in Cedar was 22ug/l.**
- **The average secchi depth (clarity) reading was 4.2 meters (14 feet).** The dry end of summer and the presence of zebra mussels more than likely contributed to this clarity, along with our long term phosphorus reduction project with the Clearwater River Watershed District.
- **The chlorophyll average was 4ug/l**, one of the lowest values since monitoring started, representative of limited algae blooms.



### Phosphorus Level

#### Good Lake Less than 40

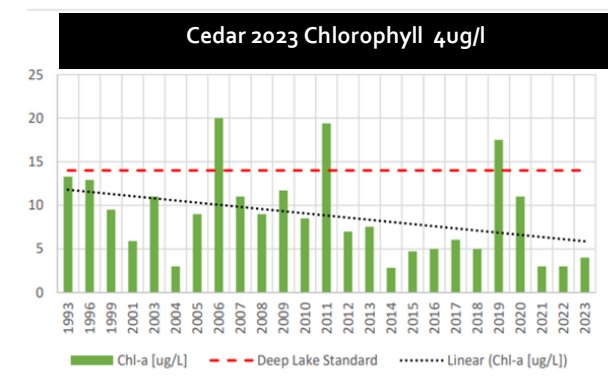
The lower the phosphorus level, the cleaner our lake is. The primary phosphorus source for our lake is the south inlet. Clearwater River Watershed projects (fish barrier, buffer management, and retention ponds) reduce the amount of phosphorus into our lake.



### Secchi (Clarity) Depth

#### Good Lake Greater than 1.5 meters

A measurement that we all can identify with is the clarity of the water. A secchi disk is a disk with alternating black and white areas that is lowered into the water until it can no longer be seen from the surface.



### Chlorophyll-a

#### Good Lake Less than 14

Chlorophyll-a usually goes hand in hand with the phosphorus level—the lower the better. In general, the chlorophyll-a level rises with the presence of algae blooms.

# Corinna Township Vacation Rental Ordinance

*Includes yearly registration, occupancy limits & septic, noise, and parking requirements

Corinna Township, has a "Private/Vacation Home Rental" ordinance. This regulates the rental of homes by the night or week. All properties on Cedar Lake are in Corinna Township and impacted by this requirement.

The Township acknowledges the benefits of vacation rentals, however recognizes that short-term rentals can have a negative impact on neighbors.

Corinna Township is the only area in Wright County that has a vacation rental ordinance.

## Corinna Vacation Rental Ordinance Highlights

- Private/Vacation Home Rentals in Corinna Township are required to register annually. Annual registration form can be found at <https://tinyurl.com/yckzn4nd>.
- Maximum occupancy of 3 guests per bedroom or 12 guests, which ever is less; otherwise, Interim Use Permit required.
- If the property has a septic holding tank, an Interim Use Permit is required (regardless of occupancy).
- Use of detached or temporary sleeping accommodations (e.g. RVs, tents, campers, etc.) to increase overnight guest capacity is prohibited.
- Standards for noise level, on-site parking, and preservation of road rights-of-way must be followed.
- Requirements for local contact/property manager.
- Contact information, emergency phone numbers, maximum occupancy/parking, and other information to be posted in rental.

## Clearwater River Watershed District (CRWD)

*Cedar Water Quality Project Carp Control and Planning for Cedar AIS Project Increase

### Cedar, Albion, Henshaw, Swartout (CASH Project) Enhanced Carp Control Enters 2nd Year

The Clearwater River Watershed District (CRWD) will begin the second of a two-year project that will benefit Cedar and the three lakes upstream that flow into Cedar (Swartout, Albion and Henshaw).

The first task last summer was to determine the populations of carp in each lake of the Cedar chain with electrofishing, then radio trackers were installed on some fish. This spring the radio trackers will be used to better understand where the carp are spawning and how they move through the season. It will also provide data about the effectiveness of our existing carp barriers.

#### What Did We Learn Last Year?

- Cedar had very sparse carp populations likely because of our current fish barriers and other water quality measures. Albion and Henshaw also have low carp populations, probably due to 2023 winter kill.
- Swartout's carp population is relatively high (estimated at nearly 3900 carp). Its carp are relatively young (2-5 years) and averaged 26 inches in length. The amount of carp in Swartout is reducing vegetative cover and diversity—both important for water quality.
- The recommendation from professional vendor, Carp Solutions, is further carp management, including removal of some carp on Swartout Lake.

#### What's Next?

- Determine what drives successful carp reproduction. This is done using radio tracking systems to monitor carp movement patterns between Swartout and potential carp nursery lakes like Albion and Henshaw during spawning season.
- Use radio trackers to monitor nearby wetlands that may be acting as carp nurseries.
- Remove carp from Swartout when monitoring determines best removal methods and the amount of fish to be removed.
- Continue to survey carp biomass and abundance every 2-3 years.

**If Cedar has few carp, why do we care about Swartout's problems with carp?** Swartout's water quality is important to residents because carp's rooting behavior releases phosphorus from the lake bottom into the water. Phosphorus causes algae growth. Swartout is upstream of Cedar. When heavy rains overwhelm Cedar's filtering systems, phosphorus-loaded water washes into Cedar from upstream lakes.

This project is part of the original CASH program begun by CRWD in 2007. Funding for this project comes from the CASH program's ongoing maintenance fund.

### Cedar Aquatic Invasive Species (AIS) Project Expecting Increase for 2025

Cedar Lake also has an Aquatic Invasive Species (AIS) project with CRWD. This project pays for AIS treatment and control, and in recent years, is the primary source of funds for the access monitoring on Cedar.

The amount collected for this project has changed over the years. At the start of project maintenance, the annual amount collected from 2015 to 2019 was \$30,000. In 2020, Cedar Lake requested a decrease to \$22,000 due to limited AIS treatment needs.

The fund can be used for access monitoring costs, and the CLCC has committed, since 2018, to fund about 1,600 extra hours of access monitoring. This extra provides coverage for most weekends on Cedar.

Since 2021, access monitoring costs have risen by 20%. The cost of 1,600 hours of monitoring in 2024 is \$29,000.

After careful consideration, and with the urgent threat of starry stonewort in nearby lakes (see page 3), the CLCC BOD wishes to keep the access monitoring at the current level. To continue funding this current level, the Board plans to request the CRWD Board of Managers to increase the annual assessment for 2025. The amount of the increase for most Cedar Lake properties is expected to be about \$50/year.

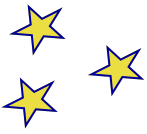

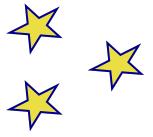

# True Friends Camp Courage on Cedar Lake

## Plans for new recreation center

True Friends Camp Courage has been a Minnesota and regional asset for almost 70 years, providing experiences that have enriched and changed the lives of thousands of people with disabilities.

Situated on the east shore of Cedar Lake, the facility is a wonderful asset and neighbor, and graciously opens up their Lakeside Dining Hall each year for the CLCC Picnic.

After more than 50 years, the pool and gym need to be rebuilt.

In May of 2023, True Friends was awarded \$10 million from the Minnesota State Legislature. In addition to the public funding, True Friends has raised an additional \$6.75 million, with \$250,000 to go to reach their \$17 million goal. This will allow for a slightly larger gym and pool and to help cover the increasing costs due to inflation.

Because of the overwhelming generosity of donors, the final design phases have begun. Construction is scheduled to begin in early 2025 with the project being completed in the first half of 2026.

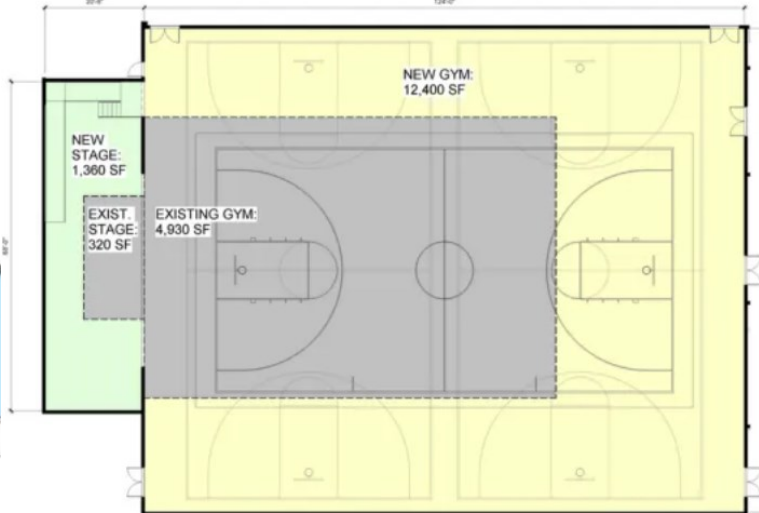
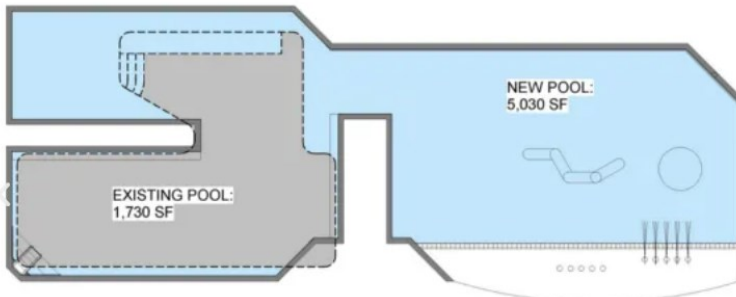

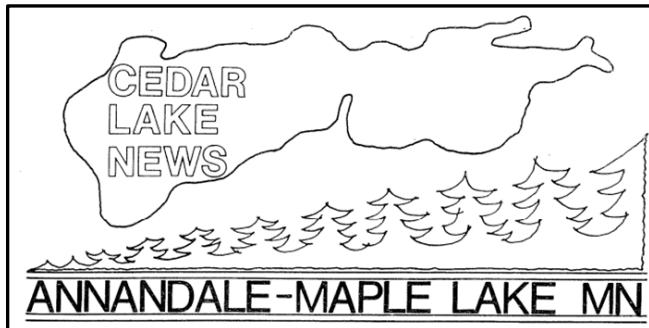

## Cedar Lake Favorite Recipes Chris Nelson—CLCC Director

## Stay in Touch with CLCC in Your Favorite Way

This is one of our favorite things to do! Perfect one pot meal for at the lake!

This serves about 8 people. Put a roll of paper towels at each table.

### Dave's Low Country Boil

#### Ingredients

- 1 tablespoon seafood seasoning (such as Old Bay)
- 5 pounds new potatoes
- 3 (16oz) packages cooked kielbasa sausage, cut into 1 inch pieces
- 8 ears fresh corn, husks and silks removed, cut in 1/2
- 5 pounds whole crab, broken into pieces
- 4 pounds fresh shrimp, peeled and deveined

#### Directions

1. Heat a large pot of water over an outdoor cooker, or medium-high heat indoors. Add Old Bay Seasoning to taste and bring to a boil. Add potatoes, and sausage, and cook for about 10 minutes. Add the corn and crab; cook for another 5 minutes, then add the shrimp when everything is almost done, and cook for another 3 minutes.
2. Drain off the water and pour the contents onto a picnic table covered with a plastic table cloth.
3. Melt a stick of butter and put over everything.
4. Cut up a loaf of french bread to put around the food.
5. Give everyone a big serving spoon, grab a paper plate and a beer. ENJOY!


