

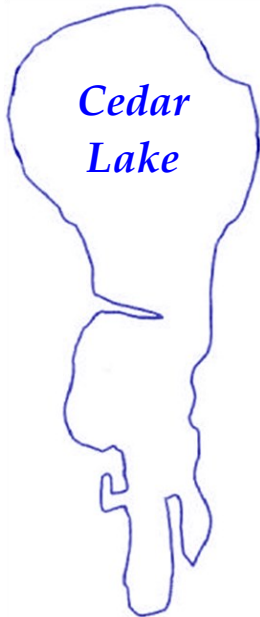

Do you recall that just two years ago on March 19, the ice went out on Cedar Lake? Last year's ice out date was May 1st and this year's ice out date may even be later. **WOW!** I certainly hope your winter went well and you're looking forward to fun and enjoyment on our beautiful lake.

The Water Quality Committee, Chaired by **Kathy Jonsrud**, has been very busy in coordinating our AIS treatment strategy for 2014. **Orv Jonsrud** applied for grant money for our AIS treatments and was once again successful. **Bobby Ebert** has been coordinating enhanced AIS watercraft inspection hours and signage. The committee has also been attending numerous meetings on the progress of our PO6 enhancement projects that were approved last year. I want to give a big thank you to Kathy, Orv and Bobby for their dedication to the CLCC. Please review the Water Quality Articles on pages 4-5 and 14 for more details.

Paul Schutte, Chair of our Fish & Wildlife Committee has also been busy meeting with Joe Stewig who is the new DNR Area Fisheries Supervisor. He reports that the DNR will be conducting a Lake Fish Survey this summer. It should also be noted that Henshaw, Albion and Swartout lakes all had a winter kill this past winter. This is great news for our lake.

We are in the second year of fundraising for our **2014 Walleye Stocking Campaign**. We have reached the \$2,000 mark but our goal is to reach \$5,000 by the end of September for stocking approximately 5000 fingerlings in October. **Please consider donating to the Walleye Fund and help reach our goal.**

Please check out the calendar of events for 2014 on page 15. I would like to highlight that the CLCC will be sponsoring a **Native Plant Sale on June 7th and on July 19th we will be sponsoring a Native Shoreline Restoration Tour** of various properties on our lake. See page 4 for all the details. A big thank you to **Cheryl Wold** who is chairing these two events. You can read the notices about these events on the next page. Please consider attending these two events and getting involved with starting up your own native garden along your shoreline.

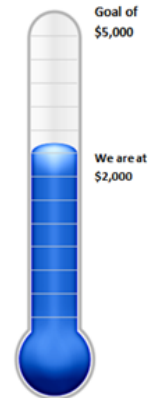
2014 CLCC Walleye Stocking Fund

In 2012 we raised enough money to stock 5,000 fingerlings in Cedar Lake. last fall the DNR stocked 7,604 walleye fingerlings. This fall our goal is again to stock 5,000 fingerlings. Currently we have approximately \$2,000 in our walleye stocking fund. We need \$5,000 to make this happen in 2014. The money raised for this comes from the fundraising at our annual picnic in August and through your generous donations.

Musing of a Cedar Laker Fisher

"This winter while doing a little ice fishing the water clarity appeared to be one of the better ones I have seen through the ice in years. I had a 25' visibility! Not jumping to any conclusions, I may have a hunch that one of the reasons might just be the removal of the carp we have had in the last few years in the Carp barriers/traps upstream. At the Segner carp barrier in 2012 alone, 12,000 pounds of carp were removed. Carp are notorious for stirring up the bottom (phosphorous) and destroying native plant growth. The last few years I personally have not seen a carp in Cedar Lake. And now it looks like Mother Nature might just produce a freeze out on those shallow lakes to the south of us that flow into Cedar, Henshaw, Albion and Swartout." Paul Schutte

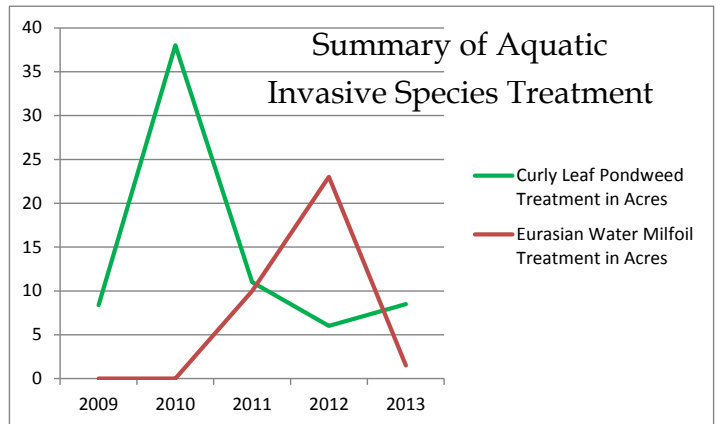

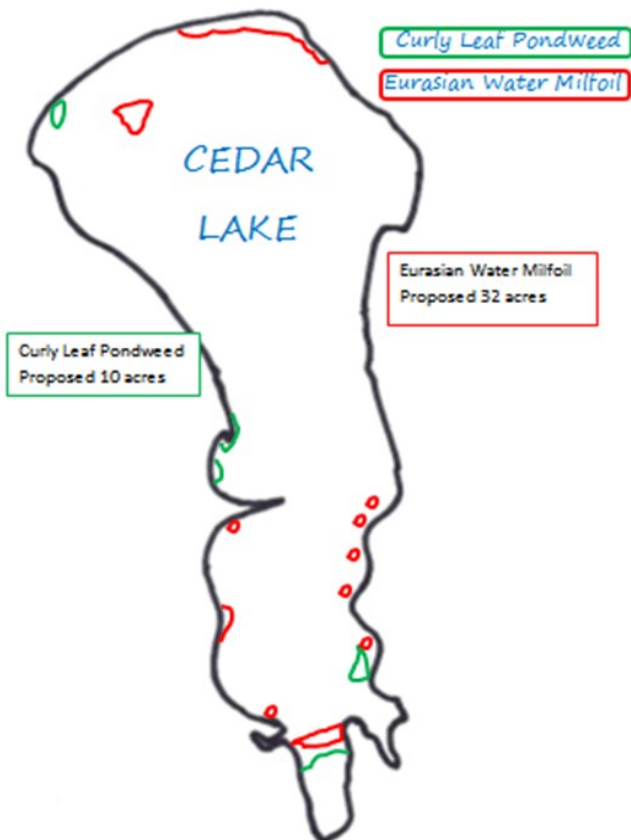
2014 Aquatic Invasive Species Control

We all are anxious for ice-out after the wicked cold winter. The Water Quality Committee has worked hard over the winter making sure all the details are taken care of for our 2014 Aquatic Invasive Species (AIS) control. Projects are in place to control Curly Leaf Pondweed (CLP) and Eurasian Water Milfoil (EWM). Many are familiar with our AIS control, but for those new on the lake, here is an overview of our 2014 AIS control strategy:

- The DNR makes the final determination about the acreage we can treat.
- We have received our 2014 DNR treatment permits. The permits were approved with few DNR restrictions.
- This is the earliest we have received our treatment permits and is allowing us to prepare and plan.
- We have contracted with Professional Lake and Land Management (PLM) to complete the 2014 treatment.
- We are in regular conversations with PLM to maximize the effectiveness of our treatment.
- The CLP treatment is paid for by an assessment from the Clearwater River Watershed District (CRWD) through the PO6 project. EWM is paid by a similar assessment mechanism under a separate CRWD AIS Control project.
- We expect to treat more CLP and EWM this year. See more information below.
- In 2013 we completed a DNR required full vegetation mapping. This was a very detailed point-intercept identification of all the vegetation in our lake.
- CLCC provides AIS project management and oversight on a volunteer basis.



Aquatic Invasive Species Treatment for This Summer



We do expect there will be more Curly Leaf Pondweed (CLP) and Eurasian Water Milfoil (EWM) to treat this year:

CLP	10 acres	Estimated Cost	\$1,060*
EWM	32 acres	Estimated Cost	\$10,900

Though this is more than we treated last year, we are still well within the costs of the CRWD project budget and we have received DNR grants (see article top of page 5).

The map to the left shows the approximate treatment areas.

The detailed vegetation mapping conducted in 2013 provided important information. The mapping was a two step process: a mapping in June and another in August. Because of excellent resident engagement and vigilance, we identified additional EWM in the late summer. Our mapping vendor conducted an extra EWM plotting in early November of 2013. The extra November mapping was extremely helpful, and gave us the important information we needed for the 2014 DNR permit. A special thanks to Mike Hankee and Orv Jonsrud as they were in the boat that chilly November day to help our vendor with the mapping.

DNR Grants – Winners Again

We once again received grants from the DNR for our Aquatic Invasive Species (AIS) control. This is great news and a special thanks to Orv Jonsrud for completing the grant application and being a true ambassador for our lake with the DNR. Our grants for AIS treatment in 2014 are up to:

\$1,210 for CLP control

\$3,140 for EWM control

The final amount of the grants will be determined by acreage we end up treating.

2013 Vegetation Mapping is Valuable

“Although the invasive non-native curly leaf pondweed and Eurasian water milfoil are present in the lake, Cedar Lake has a healthy aquatic vegetation community dominated by a number of native species, as 17 species of native vegetation were observed in the lake in 2013.”

Wenck and Associates Final Report, January 2014

Every three years, we conduct a total vegetation mapping on our lake. This is not only a required activity by the DNR, but an important tool in our “eyes forward” approach to controlling aquatic invasive species. The mapping confirms where the invasive species are and also helps us to understand the impact to the important native species. The vegetation mapping is extensive and precise using GPS technology which is shared with the DNR and our AIS treatment vendor (PLM Lake and Land Management).

Bobby Ebert serves on the Board of Directors and the Water Quality Committee. Bobby has worked hard over the winter to really up the ante on our AIS signage and Inspection Strategy.

Here is a summary of what is planned for 2014:

- ◇ Additional AIS signage at landings on Cedar. Postings/additional signage at Wurm’s landing, CR 6, and Schroeder.
- ◇ In collaboration with Schroeder Park, manned AIS inspection and education at the Schroeder Park landing for select weekends. This is our second year of providing these inspections. Bobby has worked with Marc Mattice, Wright County Parks Administrator, to hire this year’s intern. We plan to have inspections start fishing opener through the season.
- ◇ Standard DNR AIS Inspections at the CTY RD 6 landing scheduled for 60 hours.
- ◇ Through a program sponsored by Wright County Soil and Water, CLCC plans to purchase an additional 100 hours of manned inspection at the CTY RD 6 landing. Please watch for more details later in the summer.

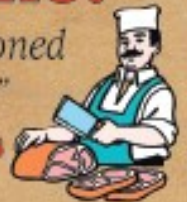

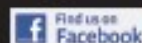

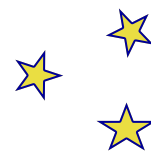

Please respect these areas and their staff, so an accurate and complete survey can be accomplished.



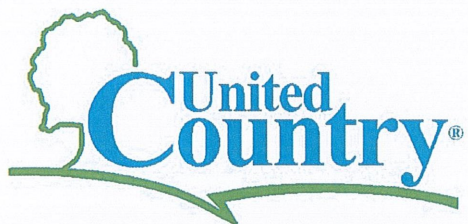

DNR Allows Signature Waiver for AIS Treatment

Cedar Lake has been granted a waiver to collect property owner's signatures for treatment of aquatic invasive species for the 2014 treatment. Please see the form to the right for more information.

Enhancements to Project PO6 Move Forward

In September of 2013, the Clearwater River Watershed District (CRWD) Board of Managers approved two major enhancements to our existing PO6 project. Project PO6 was started in 2006 to reduce phosphorus and carp population in Cedar Lake (check out www.crwd.org for more details about PO6).

- ◇ The two new projects will temporarily "slow down" a portion of the runoff during rain events and reduce the amount of phosphorus coming into Cedar.
- ◇ The projects are located just south of Cedar (near Hwy 55) and the other is east of Swartout Lake.
- ◇ Construction south of Cedar is expected to begin the summer of 2014. The project east of Swartout will start in later 2014.
- ◇ CRWD received a large Legacy Fund grant of \$277,900 for the project. This was a huge positive for the feasibility of the project. The total cost of the projects may not exceed \$554,000.
- ◇ The assessment to a Cedar Lake resident was \$500. There is an option to pay the assessment over multiple years.
- ◇ CLCC engaged deeply to evaluate and support the projects.
- ◇ CLCC contributed \$10,000 from the Water Quality Fund towards the projects.

Dear Cedar Lake Property Owners:

The Cedar Lake Conservation Club (CLCC) has contracted to treat Curly Leaf Pondweed and Eurasian Water Milfoil, both Aquatic Invasive Species, in Cedar Lake in 2014. The Minnesota Department of Natural Resources has granted to the CLCC a waiver of the requirements that the Association obtain signatures of approval by owners of lake-shore property. Instead, the CLCC will notify property owners of the treatment through the:

- CLCC newsletter which is mailed to all residents of Cedar Lake
- CLCC website www.cedarlakecc.org
- CLCC annual member meeting
- Annandale Advocate (local weekly newspaper).

With regard for treatment for 2014:

- The proposed timeline for treatment is April – August
- The target species for the treatment is Curly Leaf Pondweed (CLP) and Eurasian Water Milfoil (EWM)
- The method of control or product being used is Aquatic Herbicide appropriate to control CLP and EWM
