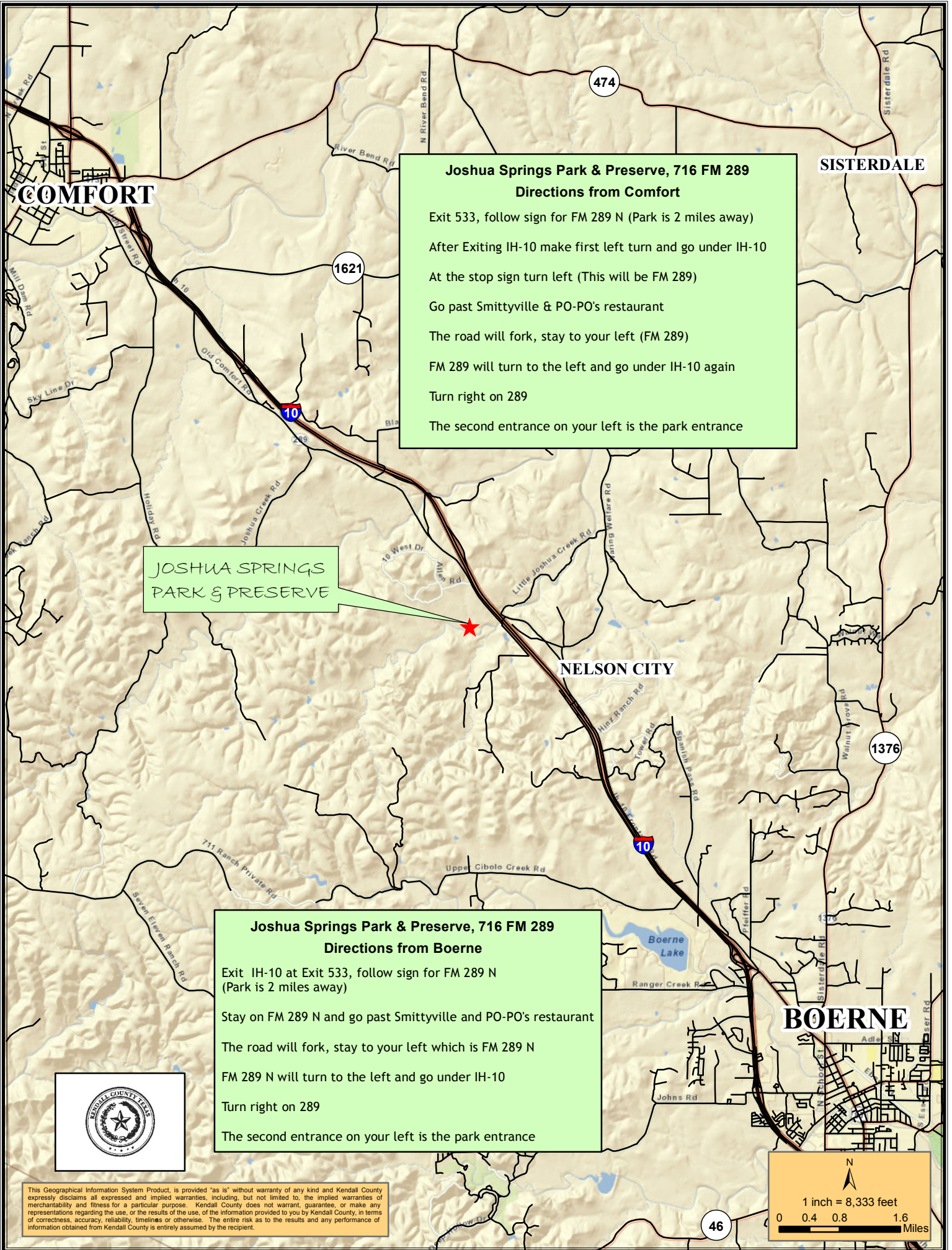

The road will fork, stay to your left which is FM 289 N

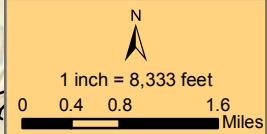

Welcome to San Antonio Home School's Cross Country Meet - at an authentic cross country setting in Joshua Springs Park and Preserve, 716 FM 289. Exit #533 off of IH-10, near Nelson City, TX. North of Boerne, south of Comfort.

**ROLLING Schedule:** next race will start once course is clear and timers are ready; listen for calls

**Course:** accurate, hand-wheel measured 3200m grass-dirt course with a few international style obstacles, *e.g.*, hay bales. Well marked (red flags left, yellow flags right, blue flags indicate every 100 meters) and marshaled with split signs (800m, 1600m, 2400m). Coach and fan friendly, significant shaded sections throughout course.

**Fees:** per gender per team = Varsity \$100 (max of 10 runners per team per gender), JV \$80 (JV entries unlimited), MS \$80 (MS entries unlimited) and \$17 per individual. May enter more than one team per division per school. Max fee of \$490 per school.

**Awards:** to team champion; individual medals to top ten.

**Concessions:** on-site, includes water, drinks and food items.
